UNB graduate Nancy Mathis, who successfully commercialized the technology she developed as a PhD student – and nurtured the growth of her company at UNB's entrepreneurial development centre – was just awarded the Ernest C. Manning Foundation's Principal Award for Innovation.

The workbook is comprised of stories and corresponding exercises with a focus on Canadian history, geography and government. An interactive lifestyles section, where students can learn about nutrition, exercise, computer technology and employment search skills, is also presented. Teaching tips and ideas for learning in the community provide teaching support to the instructor or tutor. *My Front Yard* has been designed to work in tandem with its partner math workbook, *Math For All Ages*. Both workbooks address similar topics, with the material introduced from both a math and reading perspective.

Math For All Ages is a math workbook designed for adult learners who are studying basic math concepts (counting, addition and subtraction). Teaching tips and ideas for learning in the community are included. *Math For All Ages* has been designed to work in tandem with its partner reading and writing workbook, *My Front Yard*.

Kitchener's War: British Strategy from 1914-1916

George Cassar's study focuses on Kitchener's role in recognizing and framing the larger issues of the war facing his countrymen and the Allies. From the beginning he appreciated the complexities and demands of the global conflict, understanding that it would last at least three years and require the deployment of a mass army. His recruiting campaign, highlighted by the famous poster “Your Country Needs You,” brought in nearly three million volunteers, a feat that no

other belligerent nation came close to matching. Kitchener's strategy was twofold. First, to defeat Germany and preserve Britain's independence, Kitchener understood that the key to victory was to treat the western and eastern fronts as one. Thus he worked closely with, and supplied armaments to, the Russian army, while pursuing careful attrition in France. His second aim was to enhance the security of Britain and its empire in a postwar world, not just against enemies but also against allies. George Cassar is a professor of military and modern European history at Eastern Michigan University. This is his ninth book.

Centered on the Word: Literature, Scripture, and the Tudor-Stuart Middle Way

The essays in this volume relate in different ways to a central proposition: that the word-centeredness of the Tudor-Stuart Church of England had both powerful and subtle effects on the literature produced during and immediately after the reigns of Elizabeth and the early Stuarts. The literary works treated here appeared from the 1590s, in the last Elizabethan decade, to 1652, shortly after the death of Charles I. The essays represent a range of long-recognized major authors: Spenser, Shakespeare, Donne, Herbert, and Milton; but also the more recently canonized Aemilia Lanyer, along with Robert Southwell, a little-known William Baspoole, and a fresh, relatively new discovery in the anonymous female author of Eliza's Babes. Every essay is interdisciplinary: most take the historical setting into account, while others relate literature to philosophy, theology, architecture, and ecclesiastical controversy. The contributors to this collection include many seasoned scholars, as well as some promising new voices. Yet their work shares a common thread: the strengthening and deepening of the dialogue between literary and historical scholarship. One of the contributors is Lorena Henry, who received her PhD from UNB in 1997. What Happened to the Blueprint for Atlantic Advance?

The untold story of the struggles to “pull ourselves up by our bootstraps” by the fathers of the Atlantic Provinces Economic Council: Dr. C.H. Blakeny, A.D. Ganong, R.W. Ganong and L.W. Simms and Blueprint for Atlantic Advance. As APEC celebrates its 50th anniversary in 2004, the challenge of regional economic disparities has not been resolved. The story includes the get-up-and-go initiatives by APEC and the ad-hoc and piecemeal federal and provincial spending without a national development policy. The book includes details of failed industries and boondoggles financed from the public purse by the separate provinces in the name of job creation. It is also the history of the APEC research office on the UNB campus with the leadership of Professor William Y. Smith, head of the department of economics and political science, president of APEC 1960-61 and chairman of the Atlantic Development Council 1970-72. Finally the author recommends a comprehensive and co-ordinated approach to the underlying problems of the region to avoid shrinking economic opportunities and the continuing exodus of our youth and capital.

The British capture of Fort Beauséjour was the final act in a long struggle between Britain and France for control of Acadia. In *The Siege of Fort Beauséjour, 1755*, Chris M. Hand outlines the events leading up to the siege and gives a running account of the siege itself. In June 1755, a combined force of New England volunteers and British regulars captured it after a brief siege. When Beauséjour fell, so too did Acadia, and the great expulsions fol-

lowed soon after. Chris M. Hand is a major with the Royal Canadian Regiment. *The Siege of Fort Beauséjour, 1755* is based on his MA thesis in history at UNB. The book is Volume 3 in the New Brunswick Military Heritage Series.

Lean Days

Steve McOrmond was born in Nova Scotia and grew up on Prince Edward Island. He has served as an editor with *The Fiddlehead* and *Qwerty*, and his poems have appeared in literary journals across Canada. An earlier version of this collection was awarded the Alfred G. Bailey Prize from the Writers' Federation of New Brunswick. He lives in Toronto.

A Century of Service: The Knights of Columbus in New Brunswick 1904-2004

A Century of Service traces how the Knights of Columbus came to New Brunswick by looking first at the early days of the order in New Haven, Conn., when, in 1882, Father Michael J. McGivney, guided by the hand of God, formed an order that would serve Catholic men like no other. The specific focus of this history records 100 years of the Knights of Columbus in New Brunswick, from the beginnings of Saint John Council No. 937

in 1904 to the present. This is an examination of Knights' activity in both world wars, the Depression, the Child Home Finding Association, scholarships, Adachild, their strong stand against abortion, Catholic Action and the great expansion from 18 councils in 1969 to more than 115 councils two decades later. It shows how the leaders accepted the challenges to build a strong State Council. *A Century of Service* includes the Columbian Squires, the Fourth Degree, the order's insurance program, and an overview of voices from Knights which echo work by enterprising Councils, by specific groups and by dedicated individuals. The text is illustrated by selected photographs of Knights contributing to this “century of service.” *A Century of Service* captures the spirit, the wisdom, the loyalty and the vision that inspired men to support a Catholic organization and create an influential voice among the Catholic people in N.B.

A tribute to Fred Cogswell — poet, publisher, mentor

Fred Cogswell was one of the most sensitive, generous, and caring individuals in my life. He was always prepared to help others.

I first encountered Fred Cogswell when I was a student librarian at St. Thomas University in Chatham in the last half of the 1950s. *The Fiddlehead* arrived in the mail one day, and I went through it cover to cover, noting that the editor was Fred Cogswell. I continued to read it as each new issue arrived.

My first face to face with Fred came at UNB summer school. It was probably 1963. In those days, the summer program included softball as an evening recreation. The different residences played each other in a sort of on-campus league which included a faculty team.

The night my residence faced the faculty, I came to bat hoping to at least hit the ball. In came a big easy one. I swung and it sailed over everyone's head.

Later I asked who the pitcher who smoked a pipe was. "Oh, that was Fred Cogswell," came the reply. It was my first face to face with the man who would mean so much to me as a teacher and writer for over 40 years. Perhaps he saw in me that evening so long ago another farm boy and pitched a soft one.

In 1965 when I was teaching at Oromocto High School, I decided to take an evening course in Canadian literature at UNB, chiefly because the professor was Fred Cogswell. Actually I did two courses — one fiction, one poetry. What amazed me about Fred was his wonderful ability to lecture for two to three hours without notes.

About half way through the poetry course, I had nerve enough to approach Fred to ask if he would mind reading some of my poems. He was quite prepared to. The next class I brought in probably 25-30 poems and left them with him. The following class, he handed me back my envelope.

When I got home, I opened it to discover Fred not only provided an overall comment, but he wrote an individual comment on every poem. It was my start as a published poet. Sometime after I sent some poems to *Salt*, a literary magazine edited by Robert Currie in Saskatchewan. Two were accepted; I was more than excited. But it was Fred who turned me in the right direction.

I was to learn later that Fred Cogswell did what he did for me for dozens, maybe hundreds, of young writers across Canada. When I started a series of annual Canadian literature days at Oromocto High School in the 1970s, I could always count on Fred to be a participant to share so much with my students.

After the "days" ceased, Fred was always available to come to my class for a read and discussion with the class. And he never looked for any money.

When the Writers' Federation of New Brunswick was founded, I was the interim chair of the committee and Fred was a member. We travelled to several places in New Brunswick. One memorable trip we travelled together. I think it was to Sackville. What a mind he had on so many things from hockey to the most intricate features of literature.

Fred's poems, however, were what truly impressed me. I read them whenever I had a chance. I even photocopied his first book, *The Stunted Strong*, and put it between a crudely designed cardboard cover. I still have that 'book.' Yes, it broke copyright, but, since the book was out of print, I know Fred did not mind.

I always gave a Fred Cogswell title preference in my review column in *The Atlantic Advocate*. It was a tribute to a special writer/friend. His output was immense, especially in his later years. At the Alden Nowlan Festival two years ago, he told me he was two or three books ahead of his publisher.

Another feature was the Fiddlehead Poetry Books, a publishing house commenced by Fred at UNB and, for the most

part, run by him for many years. At one count he had published over 200 titles. This venture was the forerunner to the highly successful Goose Lane Editions today.

When I edited an anthology of New Brunswick literature for New Brunswick's Bicentennial in 1984, it was natural that Fred Cogswell would be included. I selected five poems, one of which provided the book's title, *Stubborn Strength*, from his sonnet, *New Brunswick*, which was one of the poems in *The Stunted Strong*. Each division of *Stubborn Strength* opens with a quotation from Fred's *New Brunswick*.

In April, I submitted a query to Fred relating to a book I hoped he would publish under his Cogswell Books imprint, a venture he commenced last year at 86 years old. Quickly he replied

with a positive note that he was interested.

Two other letters followed as I worked at developing a manuscript I hoped he would publish. I felt I had reached my zenith. I was actually working with my literary mentor on a book. What more could I ask for?

It was one of the projects he was working on when he went to the hospital on June 4. His daughter Kathleen told me by e-mail, "this is something Fred wants to do."

Fred Cogswell never quit. He was always prepared to promote and sponsor Canadian literature in its many forms as professor, editor, publisher, translator, mentor. His memory will be cherished by those who knew him.

I have always been in awe of Fred Cogswell. I still am.

Scholarships, prizes, bursaries at UNB

Scholarships, prizes and bursaries are an increasingly vital component of the assistance UNB offers its students. In this space from time to time, *Alumni News* will highlight new or existing awards available to qualified students.

Feicht Scholarship

This scholarship is awarded to a Saint John campus student entering the second year of the bachelor of science in engineering (chemical) program or the bachelor of science (chemistry, biology- psychology) program and is a graduate of an N.B. high school. Selection will be based on scholastic achievement and financial need. This cannot be held in conjunction with another scholarship. Only students with GPAs between 3.0 and 3.6 will be considered. This scholarship is funded by Dr. Anton Feicht & the N.B. University Opportunities Fund.

Tore Grude Scholarship

This award, equal in value to first-year tuition, perpetuates the memory of Tore Martin Grude, a Law student in 1978-79. It is open to first-year students from the Atlantic region who do not hold a Beaverbrook Scholarship. Grude scholars are students of academic ability who have participated widely in community and extra-curricular activities in ways demonstrating sensitivity to the needs of society and those less fortunate, concerns important to Tore Grude. Financial need is also a consideration.

Rose May and Reta Mae McGee Memorial Scholarship

This scholarship is open to Fredericton campus students enrolled in the bachelor of arts program. Preference will be given to a student taking one or more subjects in the humanities and languages. Selection is based on scholastic attainment and financial need. The scholarship is funded by Robert Harley McGee.

Jeff Matchett Memorial Scholarship

A scholarship awarded to a student beginning an undergraduate degree program at UNB who is a Northumberland County high school graduate. Preference will be given to a student graduating from North and South Esk Regional High School. Selection will be based upon scholastic attainment and financial need. The scholarship is funded by Roussel Toyota.

Dirk van der Meijden Memorial Scholarship

A scholarship awarded to a female

Fredericton campus student who is entering the third or fourth year of study in the bachelor of science in engineering (electrical) program. Selection will be based on academic achievement and financial need. This scholarship is funded by Mrs. Denise van der Meijden.

Bakhshi Jawahar Vohra Scholarship

A scholarship awarded to a Fredericton campus student who has completed more than 38 credit hours and less than 111 credit hours in the bachelor of science in engineering (electrical or computer) program. The scholarship will be awarded to a student who has a scholarship GPA of 3.7 or higher (Dean's List) and has been involved with and contributed the most to activities of their local community. Preference will be given to the student who has shown a willingness to serve the needs of others while pursuing their course of academic study. This scholarship is funded by friends and family of B.J. Vohra.

Jennifer Prosser Wade Scholarship

A scholarship awarded to a Fredericton campus student who has completed at least the requirements for the first year of the bachelor of philosophy in interdisciplinary leadership degree program offered by UNB's Renaissance College and who is a graduate of an N.B. high school. Selection will be based on academic achievement and financial need. The scholarship is funded by Dr. Jennifer A. Wade & the N.B. University Opportunities Fund.

Hilton International Scholarship

This scholarship is awarded annually to a student who has completed a two-year diploma at an articulated Community College and is entering the bachelor of applied management – hospitality and tourism degree program at UNB Saint John. Selection will be based on scholastic achievement as well as interest and involvement in the accommodations sector. This scholarship is funded by the Hilton International Saint John.

Five honoured at spring graduations

UNB granted honorary degrees to a past president and four distinguished alumni during its spring graduation ceremonies on the Fredericton and Saint John campuses. Honoured were, from left; **Gerald Pond** (BA'66) of Rothesay, N.B., a senior executive with over 37 years of in-depth experience in the fields of telecommunications and information technology, doctor of letters; **Elizabeth Parr-Johnston** of Chester Basin, N.S., the first woman to serve as UNB's president and vice-chancellor, 1996-2002, doctor of letters; **Patricia L. Cumming**

(BBA'71, LLB'73) of Douglas, N.B., associate chief judge of the Provincial Court of New Brunswick, doctor of laws honoris causa; **E. Joanne Shattock** (BA'63) of Leicester, England, one of the world's most distinguished Victorian bibliographers, doctor of letters; and **Lloyd R. Sutherland** (BA'69) of Calgary, Alta., an internationally renowned scientist in gastroenterology, doctor of science. Dr. Pond received his honorary degree during Convocation in Saint John, while the others received their degrees during the 175th Encaenia on the Fredericton campus. Approximately 1,600 students graduated in Fredericton, and another 400 in Saint John.

UNB approves balanced budget for seventh straight year

UNB's Board of Governors has approved a \$144.4-million operating budget for the institution's 2004-05 fiscal year. The budget represents an increase of \$13 million or 9.91 per cent over 2003-04.

"For the seventh year in a row, UNB has a balanced budget," said President John McLaughlin. "The provincial government has a limited capacity to fund universities, and we respect that. We are taking responsibility to ensure the sustainability of UNB. We're investing in our people — our faculty, staff and students — we're enhancing the quality of our learning environment; and we're making innovative investments to adapt and remain competitive."

Tuition fees

UNB's tuition fees for full-time undergraduate students will increase for 2004-05 by \$260, from \$4,510 to \$4,770, or 5.75 per cent.

"This is the same percentage increase as UNB's tuition fees are currently among the lowest in the region, ranking 12th out of the 16 Maritime universities and \$387 below the Maritime average of \$4,897 for 2003-04.

Tuition fee increases for graduate stu-

dents and full-time continuing students in the faculty of law will also be 5.75 per cent — the same percentage increase as last year. Tuition for new students entering UNB's law school will increase from \$5,647 to \$6,972, reflecting a \$1,000 supplemental fee that will be used to enhance the activities of the faculty of law and maintain its competitive position as a quality law school.

The supplementary fee for international students, which is added to basic tuition, will remain constant at \$3,890 for graduate students. For undergraduates it will increase by nine per cent — the same percentage increase as last year — from \$4,240 to \$4,622.

Residence fees

For the 1,439 students living in residence on the Fredericton campus, fees for room and board will increase on average by 5.75 per cent for 2004-05. A student living in a double room, for example, with the 19-meal-a-week plan, will pay \$5,938 for the year, an increase of \$323 over 2003-04. Rates vary according to the type of room and number of meals per week. Ninety-six per cent of UNB Fredericton residence students have high-speed internet and

cable connections in their rooms. The increase in residence fees is the result of an increase in operating expenses and the introduction of alternate dining, which offers students more choice and meals freshly prepared to their specifications.

Room fees for students living in the two residences on the Saint John campus will increase five per cent for 2004-05. This increase will offset expected increases in operating costs. In the 70-bed Sir James Dunn Residence, the rate for a large single room, which most residents have, will be \$4,015. The fee for the new all-suite 168-bed residence, which provides a greater set of amenities than Sir James Dunn Residence, will be \$4,150. The meal plan fees for all students remain unchanged.

Capital budget

The overall capital budget for 2004-05 is \$8 million, with all funding sources secured. "The most significant aspect of the capital budget is a continued commitment to infrastructure renewal and major maintenance," said Dr. McLaughlin. "This year, 2004-05, is the second year in a four-year \$20-million capital renewal program."

Guide dog case resolved to satisfaction of all

An incident that landed UNB in a world-wide media glare in July ended happily in early August when Yvan Tessier, with the help of his guide dog Pavot, successfully completed the university's English Language Programme (ELP).

Mr. Tessier, a visually-impaired student from Quebec, arrived on campus with Pavot, a black Labrador retriever, believing he was enrolled in a five-week ELP session beginning July 4.

However, the ELP was not prepared for Mr. Tessier's unexpected arrival for the first day of class. While ELP staff members had been in communication with Mr. Tessier since March, they were notified in May by the Quebec government, which was providing a bursary for Mr. Tessier's language training, that he would not be attending UNB.

He was not registered and had not paid for the session. As well, Pavot can only be issued commands in French, which, according to the standards of the course, would not have been permitted.

It was the latter circumstance that caught the attention of the media, and by Tuesday, July 6, the story was front-page news in Canada's national papers. By the next day, the story had been picked up by media around the world, ranging from CNN to the *Times of India*.

That was also the day that intensive mediation efforts between Mr. Tessier and university officials led to his being admitted to the program — with permission to issue commands to Pavot in French.

Mr. Tessier was happy with the outcome.

"I am thrilled to be joining the UNB program and look forward to my challenge," Mr. Tessier said at the time. "I look forward to joining my classmates."

UNB President John McLaughlin said in the wake of the decision that all factors in the case were considered carefully, but in the end it was a question of balance.

"The university weighed every aspect of the situation prior to making a decision to admit Mr. Tessier to this session," Dr. McLaughlin said. "We took into account Mr. Tessier's specific needs, balanced against the rules and regulations that have guided over 50 years of extremely effective immersion training provided by our English Language Programme.

"We respect the strong and sincere passion our faculty and staff have for their work, the high standards they maintain and their desire to do the right thing. We also respect that our students are individuals with particular rights and needs. In this instance, those came into conflict with university regulations.

"Undoubtedly, every organization has found itself in such a position at some time. The circumstances tested us all as we agonized over the situation and even now, within the university and outside, opinion is still divided about the decision.

"We are pleased that Mr. Tessier chose UNB's English Language Programme and we were able to reach an accommodation for him to attend the course of his choice. As it does with all students, UNB is making every effort to ensure that Mr. Tessier leaves with all the benefits of a quality program that

will serve him well in the future."

The decision to admit Mr. Tessier to the ELP also found favor with newspaper editorialists, perhaps best expressed by New Brunswick's provincial newspaper, *The New Brunswick Telegraph Journal*.

In a July 9 editorial, the newspaper opined that "It must be said that as an integral and historic cornerstone of our education system, the University of New Brunswick has excelled in teaching skills to students of different races, creeds, colours and physical abilities so they become the open-minded thinkers and problem solvers our society relies so heavily upon.

"It is seemingly these same skills that deserted university officials when initially dealing with Mr. Tessier's case. Officials sought to protect the integrity of the course for the other 255 students enrolled, and were genuinely concerned that Mr. Tessier's learning experience could not be maximized under existing conditions. What that equated to was a desire to do the right thing, but it came out all wrong.

"Now, it's time to forgive and forget. This institution of higher learning has done the right thing by bending its rules to get Mr. Tessier into this program. The applicant is thrilled to be part of it all — he is looking forward to the challenge of improving his English-language skills.

"With this valuable lesson learned, it's time to move on."

After finishing the course Aug. 5, Mr. Tessier told a university official he had had an "excellent" experience at UNB.

UNB hosts D-Day veterans on 60th anniversary

UNB Fredericton honoured New Brunswick D-Day veterans at a commemorative luncheon on the 60th anniversary of that fateful day. President **John McLaughlin** and UNBF's Military and Strategic Studies Program representatives hosted veterans on Sunday, June 6, at the Wu Conference Centre. With assistance from the Provincial Command of the Royal Canadian Legion and local newspapers, nearly all surviving New Brunswick D-Day veterans were identified and invited to the luncheon. The guest list included soldiers who landed on D-Day, sailors manning the invasion fleet and air crewmen who provided overhead support. Canada made the third largest contribution on D-Day, providing 20 per cent of the assault force that stormed the Normandy beaches, and liberated Europe from Nazi oppression less than a year later.

UNB holds Bangladesh family reception

On June 12 at the Dhaka Sheraton in Bangladesh, UNB held a reception for current students, alumni and their families. Also in attendance were recently

UNB awarded \$3M for chairs in nursing, forestry

UNB's reputation as a leader in forestry and health-care research has been enhanced with the announcement of \$3 million in federal support for two new Canada Research Chairs in these key areas.

The chairs, UNB's 13th and 14th, will be located on the Fredericton campus.

Barbara Paterson joined the faculty of nursing as the Canada Research Chair in Chronic Illness on July 1, 2004, while Om Rajora will take up the Canada Research Chair in Forest Genomics, Genetics and Biotechnology in the faculty of forestry and environmental management in January 2005.

As Tier I chairs, each will receive \$1.4 million from the Canada Research Chairs program over the next seven years. In addition, the Canada Foundation for Innovation will provide an additional \$200,000 in infrastructure funding, \$125,000 to Dr. Rajora and \$74,911 to Dr. Paterson.

Dr. Paterson comes to UNB from the University of British Columbia. She will be developing health-care strategies for Canadians with chronic illness who have limited access to health services. Dr. Paterson is looking for new ways to foster effective prevention and care of chronic illness among marginalized and medically unsupervised populations in Canada and beyond.

Dr. Rajora is an internationally renowned expert in the genomics, genetics and biotechnology of trees. At UNB, he will explore the genetic basis of trees' productivity, health, and ability to adapt to climate change. He will also focus on the conservation and sustainable management of forest genetic resources. Ultimately, Dr. Rajora's research will enable the Canadian forest industry to remain competitive on the global stage.

New faculty members receive \$500,000

Four newly recruited faculty members at UNB have received a boon from the Canada Foundation for Innovation (CFI) — more than half-a-million dollars to support their research projects.

A total of \$572,054 was awarded at UNB as follows. Kecheng Li of the department of chemical engineering received \$267,779 for the Advanced Characterization of Pulp Fibres and Paper Surface Laboratory. Bale Viswanadha Reddy, mechanical engineering, was awarded \$131,055 for his work on environmentally sustainable energy conversion through circulating and pressurized circulating fluidized bed combustors. Biologist Janice Lawrence received \$111,806 for the Algal Virology Research Laboratory and biologist Heather Hunt received \$61,414 toward hydrodynamic infrastructure for marine ecology research.

Drs. Li, Reddy and Lawrence are located at UNB Fredericton, while Dr. Hunt is located at UNB Saint John.

also will be included in the winter edition of *Alumni News*, though we will be encouraging as many of you as possible to use our online system.

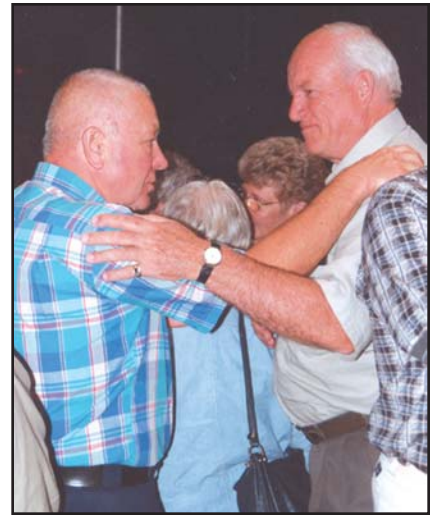

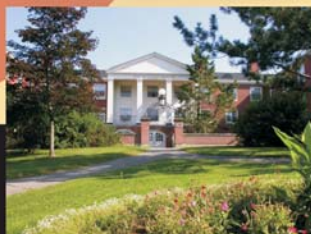

A 'sneak peek' at Forging Our Futures



UNB is putting the final touches on plans for its most ambitious development campaign in its more than 200-year history. The official launch of Forging Our Futures is still some time away – no official date has been set. However, work on the campaign has been ongoing for the last year. Now, for the first time, some of the campaign priorities are being made public in the Alumni News.

Forging Our Futures will make strategic investments in students, faculty, facilities and programs. The campaign will help UNB take its place in the 21st century as a national university that is fundamentally important to the economic, social and cultural well-being of the province, the region and the country. Forging Our Futures has three components – People, Places and Programs. Each includes a number of worthy projects, large and small, on both campuses.

From building new facilities to creating new scholarships to supporting our libraries, each individual project is part of a larger tapestry that together will transform the university.

Investing In Our People

Forging Our Futures will invest in both students and faculty. One key priority is undergraduate and graduate scholarships. Support for scholarships will help to attract the very best students from New Brunswick, Canada and other parts of the world. All faculties will benefit from new entrance scholarships, continuing scholarships and part-time study scholarships. UNB puts great emphasis on support for graduate students, who generate countless economic, social and educational spin-offs for the university and the world around them. Graduate programs build critical mass. They not only attract top researchers and students to UNB, they also help to retain leading faculty, who collaborate with graduate students on their academic work and research. Key investments will be made in faculty as part of the campaign. Investing in faculty recognizes and retains top professors and researchers, offers critical programs to our students and enhances UNB's national standing by attracting first-class scholars from around the world.

The campaign will focus on an important part of UNB's internationalization strategy – the Study Abroad programs on both campuses. Each year, UNB offers a selection of courses, exchange programs and internships in other countries. Open to students on both the Fredericton and Saint John campuses, these Study Abroad programs are held in various parts of the world, including Greece, Italy, Mexico, China and the West Indies.

Investing In Our Places

To ensure our students are successful we need to enhance our supportive learning environment. Both of the capital projects in our campaign – Saint John's University Commons and Fredericton's Health and Wellness Centre – are more than buildings, they will be catalysts for



elevating the quality of student life and creating an important sense of community on our two campuses.

The University Commons will be the keystone of UNB Saint John's new campus plan and the locus of its most important shared activities – uniting campus, community and academic life. In this centre of scholarly activity, students, faculty and staff will study, research and share ideas in a much-expanded library, replacing the outmoded 1969 facility that our increasing enrolment has outgrown. An information/help desk, instructional facilities, specialized equipment, collaborative workrooms, public workstations, study and research space, and mobile computing will transform access to knowledge and information of all kinds. The University Commons will enclose an accessible, flexible and open space that is the logical extension of the classroom and the laboratory.

But this signature building will be much more than the library that is at its heart. It will include gallery and performance areas, other flexible multi-use space, and informal meeting places so important to intellectual creativity. It will seamlessly integrate many kinds of media and ideas, from scientific to artistic, while providing opportunities for dialogue and reflection.

Construction of the new Wellness Centre on the UNB Fredericton campus will be crucial to the advancement of UNB's wellness agenda. Because wellness is a broad concept that incorporates all aspects of human well-being, including the physical, psychological, social and spiritual, a centralized, integrated centre will unify and better serve the health and wellness needs of the UNB Fredericton campus, and the community.

The creation of a comprehensive wellness facility would bring together, for the first time, an assemblage of services that will address the wellness needs of students, faculty and staff, and enhance UNB's role as a partner in the economic and cultural development of the Fredericton region and beyond. The new Wellness Centre will also have the potential to become a "living laboratory" for our teaching and research programs in the health-related disciplines. This new facility will be highly interactive and collaborative, nurturing, increasing, and promoting well-being at UNB Fredericton in one convenient location.

Investing In Our Programs

The UNB libraries are critical for the creation, preservation, and management of knowledge. Through the provision of collections and services, the library offers a foundation for teaching, research and scholarship. With more than 10,000 electronic journals and over 100 electronic reference sources, our electronic collections are the most comprehensive regionally and comparable to those of much larger universities in Canada.

While we have had great success bringing UNB libraries

into the electronic age, the rising costs of serials and monographs as well as currency exchange over the last two decades have eroded our ability to keep pace with the purchase of books. In the 1970s, UNB libraries were acquiring about 25,000 new books each year. Today, we add only about 8,000. An improved and sustained library is one of the aims of **Forging Our Futures**. Our goal is to reach an annual acquisition rate of 14,000 to 16,000.

Through a revolutionary reorganization of our undergraduate curriculum, and building on our success in interdisciplinary research and graduate studies, the campaign will support plans to develop an integrated first year in science and engineering. The ground-breaking initiative will instil in our students greater appreciation of other disciplines, along with stronger cross-linkages and problem-solving skills. It will also encourage creativity and innovation.

The campaign will build on the university's academic strengths by enhancing existing expertise and capacity of its various centres and institutes, such as financial studies, international business and entrepreneurship and clinical psychology.

Providing much needed operational flexibility, the UNB Opportunities Fund will be a major project for the campaign. The fund will enable the president to make strategic investments that encourage excellence and foster innovation.

ASSOCIATION ACTIVITIES

A word about privacy and use of your alumni information . . .

At the Office of the UNB Associated Alumni, we care about your privacy and take the matter very seriously. We recognize that our alumni are concerned about the information we maintain and how that information is used. As the basis for our own policy, we follow Canada's Personal Information Protection and Electronic Documents Act (PIPEDA).



Alumni information is collected and utilized only for genuine alumni or university related functions, programs and services. All individuals, affinity partners or third-parties using alumni information are required to sign a confidentiality agreement stating that they assume responsibility for using the information solely for the purpose specified.

Following are the most frequently-asked questions from alumni about the use of their information.

Q: I sometimes receive information or solicitations from companies claiming to be working with UNB and/or the Associated Alumni. Are you selling the mailing list of UNB alumni to raise funds?

A: Neither UNB nor the Associated Alumni sells, trades or gives away mailing lists of its alumni. The Associated Alumni affinity partners such as Meloche Monnex and Manulife sign contracts, approved by the Alumni Council, stating that alumni information will not be used for any purpose other than marketing their service and that no alumni information will be used by the company in any way other than that specified in the contract. All information sent out by these companies is approved by the Office of the Associated Alumni.

Q: Why do I get mail and/or telephone calls from these companies?

A: Direct mail and telemarketing help provide support for our affinity programs. By participating in affinity programs, you not only benefit yourself, you help support the activities of the Associated Alumni. Revenue realized from these programs is used to support alumni and student initiatives such as scholarships and bursaries. From time to time we will be contacting you to update you on the services offered to UNB alumni.

Q: I am an alumnus/a. How can I contact a long-lost friend who is also an alumnus/a?

A: If you have lost contact with a former classmate, we can help. While we are unable to release any personal information such as addresses, phone numbers, or e-mail addresses, we can provide the desired person with your contact information and have them make contact with you if that is their choice.

Q: Can I get a list of alumni from my area?

A: UNB Alumni Office staff will provide lists of local alumni to chapter contacts only to assist with the recruitment for chapter leadership and the promotion of chapter events. The information provided to chapter leaders can only be used for official UNB and Associated Alumni use. Use of the information for any commercial, political or solicitation purposes is expressly prohibited. Permanently reproducing and storing the information in a retrieval system by any means, electronic or mechanical is prohibited. Photocopying or use of the addresses or other information provided for any mailing other than notification of an official chapter function is strictly prohibited.

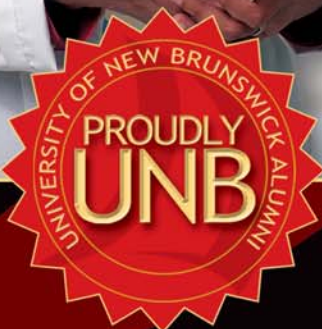

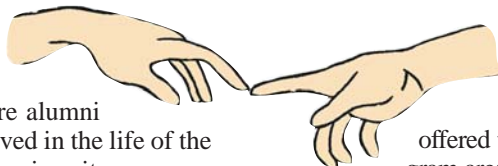

New Outreach Program will help you get involved

The Associated Alumni has developed a new program to get more alumni energized and involved in the life of the association and the university.



The **Alumni Outreach Program** has been developed to provide a greater selection of opportunities for UNB alumni to become active with their alma mater across the country and around the world. The new program offers opportunities for alumni to stay connected and show their support on a group or an individual level. These opportunities will serve to keep alumni informed about the UNB, and offer activities and events for graduates and former students.

The need to develop a broader program was identified in the association's revised strategic plan, Energized and Involved II.

"Goal number one in our strategic plan stresses the need to develop pride and loyalty in our alumni and get more of our alumni involved in the events, activities, and projects of the organization," said Association President Carey Ryan. "But we also recognize that we need to provide various opportunities if we want to see a higher level of engagement. In some cases, those opportunities just were not available due to geographical or population constraints. This program is a huge accomplishment for the organization to help us address those issues."

According to Associated Alumni Executive Director Mark Hazlett, the program is unique when compared to other alumni programs offered across the country.

"UNB is a very diverse institution – we need to ensure that our programs provide something for everyone," said Mr. Hazlett. "The new program provides six very distinct and engaging ways in which a former student can choose to stay connected. Alumni can also choose to be involved in more than one area – the program has built in the ability to allow opportunity areas to

cross over." The six Opportunity Areas that are offered through the program are:

1. Community Contact:

Act as an information source for a fellow alumnus/a who may be moving into a new area;

2. Career Network: Offer information on what led to their current career choice;

3. Game Watch: Organize events and activities around UNB varsity competitions and support UNB teams when they are on the road or playing at home;

4. Recruitment Volunteer: Help a young person make UNB their choice for higher education;

5. Local Director: Organize events and activities that support alumni getting together and reconnecting;

6. Alumni Groups: Gather together a group of individuals to organize events and activities that support alumni in getting together and reconnecting.

The Alumni Office has worked hard to ensure that the program is accessible to all alumni. Central to the development of the program has been the creation of an "Outreach Volunteer Handbook." It is available either online from the alumni website or in hard copy. The resource contains a detailed description of each opportunity area and the necessary information needed to sign up. The manual also contains a wealth of information on such topics as group development, event planning, and volunteer recruitment. Information about the program has been posted on the alumni website and provides everything that can be found in the manual plus a few extras.

The program was officially launched at an Alumni Council meeting in September. In 1971 the University of New Brunswick Alumni Council established the Alumni Award of Honour to recognize the important role played by alumni in promoting the university and helping it to achieve and maintain its position of prominence among Canadian universities.

This year the Associated Alumni will give its most prestigious award to two dedicated graduates — **Frederick McElman** (BBA'72, LLB'78) and **W. Blair Orser** (BSc'47), both of Fredericton.

Mr. McElman has been practising law in Fredericton since 1979, and is a partner with Stewart McKelvey Stirling Scales. Throughout his career, he has maintained close ties with the Associated Alumni and the university. He served several terms on Alumni Council, and was its president from 1991-93. He also sat on the UNB Board of Governors. From 1996-99, Mr. McElman was chair of PLAN International, a world-wide development organization of which Foster Parents Plan of Canada is a member. In 2002, he was appointed a Member of the Order of Canada and was presented with Her Majesty's Golden Jubilee Medal.

Dr. Orser is a retired doctor who practised medicine in various N.B. centres, but spent most of his career in the Bathurst, N.B., area. He began serving on the Alumni Council in 1981, and served as its president from 1986 to 1987. He also chaired UNB's Futures Fund and served on the university's Board of Governors and Fredericton Senate. Dr. Orser has been a member of numerous local, provincial and national medical societies and associations. The Saint John Ambulance Brigade has honored Dr. Orser's extraordinary contributions to its work by naming him a Knight of the Order of St. John. He is a recipient of the Queen's Silver Jubilee Anniversary Medal.

Associated Alumni awards UNB rings to 14 students

Fourteen graduating students left both campuses this spring with UNB rings, all because they took advantage of a free service from the Associated Alumni.

The students, one each from the 11 Fredericton faculties and one each from the three Saint John faculties, were winners in a draw the association held to encourage graduating students to claim their alumni E-mail Forwarding for Life (EFL) accounts before they set out into the world.

Out of the approximately 2,000 students who graduated from both campuses this spring, more than 600 claimed their EFL accounts by the draw deadline.

Association Executive Director Mark Hazlett said EFL is a valuable service.

"EFL is an easy-to-use means for our alumni, and those who one day will be alumni, to stay connected with both the friends they've made at UNB, and with the institution itself," he said. "Since the association established the service about three years ago, its use has grown exponentially."

To date, about 14,500 alumni and current students have claimed EFL accounts.

The UNB Alumni EFL is a free service designed to help UNB alumni keep in touch with each other, and the institution. EFL is not a full e-mail service. Rather, it is a service that will forward to your 'real' e-mail address any messages sent through your UNB Alumni EFL account. As long as the user keeps their UNB alumni EFL account updated with their 'real' address, any mail directed to them through their EFL address will get to them.

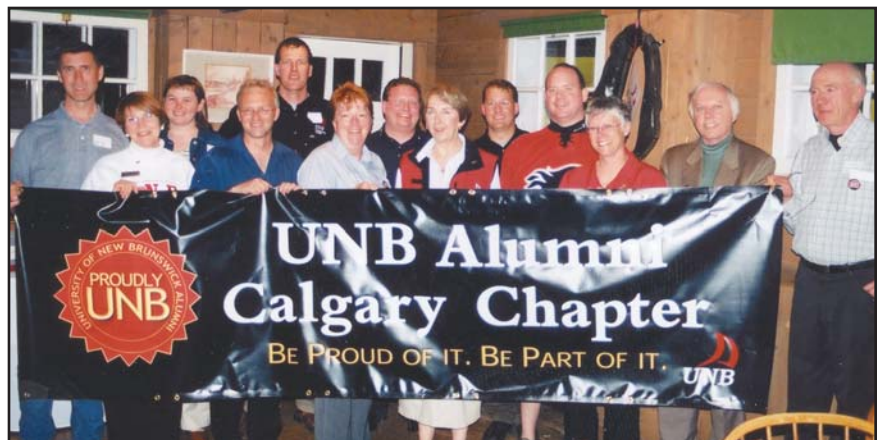
