




### Association's new president asks us for a favour


As the deadline approached for this, my first contribution to the *UNB Alumni News* as association president, I

### Where the Water Meets the Land: The Story of the Halifax Harbour

By John Boileau (BA'66) Saltscapes ISBN: 978-0-97-38830-2-2

The waterfront is the historical core of commercial and naval Halifax. In the past, the waterfront was very animated, with a broad range and intensity of goings-on - a compliment to the thriving commercial and government activities farther up the hill. From the mid-20th century, as ships became larger and handling facilities more sophisticated, major shipping moved southward and northward to container terminals, while the navy moved northward. Over the same period, Halifax declined as a fishing port because of improved transportation connections to more remote coastal areas and pollution in the harbor, which resulted in declining fish stocks. These factors left the old waterfront to deteriorate, both commercially and physically, until only a handful of users were left scattered over its length. The waterfront should be a place to work, eat, live, shop, walk, play and relax. By the 1970s, it was none of these. In 1976, the Waterfront Development Corp. was created, with responsibilities for the redevelopment of the Halifax, Dartmouth and – later – Bedford waterfronts to restore the flavor and vigor of an earlier time. Where the Water Meets the Land is the story of Halifax harbour and its waterfront from prehistory to the modern day, detailing the rise and decline of this historic area, and its rejuvenation during the last 30 years under the guidance of the Waterfront Development Corp.

### Johanna Krause Twice Persecuted: Surviving Nazi Germany and Communist East Germany

Persecuted as a Jew, both under the Nazis and in post-war East Germany, Johanna Krause (1907-2001) courageously fought her way through life with searing humour and indomitable strength of character. Johanna Krause Twice Persecuted is her story. Born in Dresden into bitter poverty, Krause received little education and worked mostly in shops and factories. In 1933, when she came to the defence of a Jewish man being beaten by the brownshirts, Krause was jailed for "insulting the Führer." After a secret wedding in 1935, she was arrested again with her husband, Max Krause, for breaking the law that forbade marriage between a Jew and an "Aryan." In the years following, Johanna endured many atrocities. After the war, the Krauses took part enthusiastically in building the new socialist republic of East Germany - until 1958, when Johanna recognized a party official as a man who had tried to rape and kill her during the war. Thinking the communist party would punish the official, Joanna found out whose side the party was on and was subjected to anti-Semitic attacks. Both she and her husband were jailed and their business and belongings confiscated. After her release she lived as a persona non grata in East Germany, having been evicted from the communist party. It was only in the 1990s, after the reunification of Germany, that Johanna saw some justice. Originally published as Zweimal Verfolgt and translated by Carolyn Gammon, Johanna Krause Twice Persecuted will be of interest to scholars of autobiography, Second World War history, and the Holocaust.

### The Sweet Fuels

By Erin Knight (MA'06) Goose Lane Editions ISBN-13: 978-0-86492-491-9 ISBN-10: 0-86492-491-7

With a supple, meditative approach, Erin Knight explores the complexity of beauty in this first collection. The Sweet Fuels also reflects on the notion of orientation - whether in terms of magnetic north or street signs, the entrails of an animal or the vowels in a name - as a task of translation. Of the more than four dozen poems in the book, some are written in English, others are rendered from Spanish. Still others perform a high wire act written in English, converted to Spanish, and then back into English. The practice of translation allows for a direction that does not try to reorder or simplify the world, but rather emphasizes the promise of continuous engagement with our points of reference.

### **Beginning Old English**

By Carole Hough and John Corbett (MA'82) Palgrave Macmillan ISBN 13: 978-1-4039-9350-2

This is an accessible beginners' guide to the language of Old English literature. It takes the reader on a gentle journey into the earliest history of English, suggesting practical ways of recognizing Old English words, building up a reading vocabulary and unpicking the grammar. It deals with issues in translation, from William Morris to Seamus Heaney, and concludes with substantial extracts from four major Old English texts, the epic 'Beowulf,' the heart-breaking 'Cynewulf and Cyneheard,' the stirring 'Battle of Maldon' and the intensely spiritual 'Dream of the Rood.'

### War Brides: The Stories of the Women Who Left Everything Behind to Follow the Men They Loved

By Melynda Jarratt (BA'87, MA'95) Vanwell Publishing Ltd. ISBN: 1-933354-18-6

After 20 years of research and writing,

Melynda Jarratt has compiled the compelling stories of some of the more than 48,000 women who married Canadian soldiers during the Second World War. Drawing on archival material, one-on-one interviews and personal letters and writings, *War Brides* sheds new insights on an intriguing period in Canadian history.

### Faith & Falafel: My Spiritual Journey in Israel

In February 2005, 15 Halifax-based students embarked on a journey to Israel to learn more about "the land where Jesus walked." Throughout the trip, the students marvelled at centuries-old ruins and breathtaking landscapes and witnessed the Bible coming to life. When two of the group's members were struck down with illness, however, the trip became much more than a vacation. It became a faith-enhancing experience that left a permanent impression on everyone who went through it and taught a valuable lesson about the power of prayer. ### She's Gone

By Kwame Dawes (PhD'92) Akashic Books ISBN: 1-933354-18-6

In Kwame Dawes' first novel, Kofi, a Jamaican reggae musician, and Keisha, a social researcher from South Carolina, meet at a club where Kofi's band is playing on the tail end of a U.S. tour. Kofi and Keisha come together that night, seeking relief from the uneasy circumstances of their life - Keisha still trying to make up her mind about an ex-lover who keeps coming back into her life, and Kofi realizing that he is teetering on depression and the tyranny of his older lover in Jamaica. Something happens in their first meeting and Kofi convinces Keisha to take a chance and follow him to Jamaica. She's Gone explores the complex dynamics of two virtual strangers trying to negotiate the complicated terrain of cultural difference, class difference, and issues of gender. She's Gone delves into the psychology of desire and need as it contends with issues of culture and class. Dawes is a poet, but he never lets his poetry detract from the sheer pleasure of storytelling.

### **Reconstructing Human-Landscape Interactions**

Reconstructing Human-Landscape Interactions demonstrates the high quality of work presented at the first Developing International Geoarchaeology conference (DIG 2005), held

in Saint John, N.B., and exemplifies the overriding theme of this discipline. People have always used the landscape in many ways: as a place to live, as a place to grow crops, as a source of natural resources. Those actions leave their traces. The characteristics of the landscape constrain which activities are possible, just as social and cultural habits condition people's connection with the environment. Geoarchaeology is about finding the traces of these interactions, and using them to reconstruct how people in the past behaved in their environmental context. The material covered in the proceedings ranges from broad themes of climate change and landscape use, to more specific subjects such as river avulsion and the use of tidal ponds. The papers move us from the land to the coastal margin and back onto land to examine particular techniques. The final paper leads us beyond archaeology and points out that geoarchaeological data must contribute to the debate about the sustainability of present-day land-use practices: a fitting challenge to take us into the future.

### Sex Workers in the Maritimes Talk Back

Sex workers are often the "objects" of study for academics and policy makers. Theories about their lives and the policies that affect their work are usually developed without input from the sex workers themselves, as they are rarely seen as capable of analyzing the social and political world in which they work. In this book, however, sex workers set the tone. Leslie Ann Jeffrey, an associate professor of history and politics at UNBSJ, and Gayle MacDonald, a professor of sociology at St. Thomas University, interview sex workers in three Maritime cities and those who work around them: police, healthcare providers, community workers/advocates, members of neighborhood associations, and politicians. The sex workers discuss such issues as violence and safety, health and risk, politics and policy, media influence, and public perception of the trade, portraying the best and the worst facets of their working lives and expressing sentiments refreshingly at odds with commonly held opinions. Given recent Parliamentary recommendations to decriminalize prostitution, Sex Workers in the Maritimes Talk Back represents a timely shift to public discussions about sex work.

### Ketchum Silver Medal Winners meet in Fredericton

A meeting of the Ketchum Silver Medal Winners' Club was held at Old Government House in Fredericton on May 23, 2007. The Ketchum Silver Medal is awarded to the student who has the highest standing in the senior year of the civil engineering program at UNB. The medal was established in 1897 in memory of Henry G.C. Ketchum, a well-known railway engineer who conceived of the idea and developed the plans for the Chignecto Ship Railway to transport ships from the Bay of Fundy to the Northumberland Strait. About two-thirds of the project was completed before funding was cut off in 1897. Henry Ketchum was awarded the first UNB diploma in engineering in 1862. He died in Amherst, N.S., in 1896. Prof. Michael Ircha, professor of civil engineering at UNB, presented a talk on "The Chignecto Ship Railway" that included many of the contributions of Henry Ketchum to the creative and innovative technical aspects of the project. ### CHOOSING EXCELLENCE:

### Post-Secondary Education in New Brunswick

Adapted from an editorial published in *The Daily Gleaner*, January 2007

hat if New Brunswick had a post-secondary education system of colleges and universities that was a model for the rest of the country? A seamless, integrated, accessible network of opportunities for all qualified students from this province that set a new North American standard? A system so effective and so appealing that students and faculty from across Canada and around the world would be irresistibly drawn here to study, to teach and to conduct research? How could we achieve this?

That is the question faced by the Commission on Post-Secondary Education in New Brunswick over the past nine months. We anxiously await their report, due out this month. As president of the University of New Brunswick, I applaud the government for following through on its commitment to undertake a comprehensive review of post-secondary education in the province. This represents an early and critically important component of Premier Shawn Graham's agenda for self-sufficiency.

The review is long overdue, the last sweeping evaluation of our institutions having been conducted in 1962 by the Royal Commission on Higher Education chaired by John Deutsch. Though the system has served the population well over the past 45 years, the world and its educational needs have changed so dramatically in this time that the assumptions on which our current approach is based must be examined. It behooves this Commission to be thorough, thoughtful and bold in its recommendations.

The province's universities and community colleges are fundamentally important to the advancement and prosperity of our society. Numerous studies from a variety of North American jurisdictions demonstrate that those with post-secondary education earn more over their lifetimes, are more productive and adaptable, are more likely to become involved with their communities and support charities, take better care of their health and make fewer demands on the health care system, and generally lead more satisfying lives. In addition, two out of every three jobs in Canada now require post-secondary education.

We entered the review process from a position of relative strength. The past five years have been a time of steady and substantial accomplishment for UNB. The quality of our faculty and students is among the

best in the country.

Since 2002, annual research revenues at UNB have more than doubled to \$50 million. Ambitious land management plans were developed for our campuses in Fredericton and Saint John, and two new residences and a laboratory-classroom building for the world-class Canadian Rivers Institute were constructed. In Fredericton, commercial development began on our 3,800-acre woodlot, the proceeds from which will fund further campus improvements. The University reached out to the citizens of the province through the

### Commission

Next New Brunswick initiative, addressing the immediate and longer-term future of New Brunswick, creating new networks and identifying 21 Young Leaders for the 21st Century. And more than \$107 million was raised through the Forging Our Futures Campaign, the largest-ever in Atlantic Canada.

Despite these achievements, we are facing substantial challenges, as a province and as a higher education system. Among these are enrolment declines, which we knew from our own projections were imminent and which are now exacerbated by intensified national competition for students; the impending shortage of qualified faculty; the increasingly difficult fiscal situation in the province and the region, caused by demographic trends and an alarming out migration to the west; and significant infrastructure challenges. Furthermore, students are graduating with unprecedented levels of debt. This poses a threat both to their financial well-being at the start of their careers and to our institutions' accessibility at a time when it has never been more important to have a post-secondary education.

It was easy and obvious for those of us who have made representations to the Commission to ask for more funding from government. And we did. But the solution requires more than money. The solution lies in ourselves.

While we can learn from studies in other jurisdictions, such as Bob Rae's Ontario: A Leader in Education, our solution must be made in New Brunswick and for New Brunswick. It must involve much greater collaboration among and between our universities and colleges. We must find ways to share infrastructure, facilitate student mobility, integrate academic requirements, minimize duplication of programs, foster differentiation, maximize lifelong and "life-wide" learning and take full advantage of the truly remarkable brain trust that we have in our post-secondary sector.

Above all, we must maintain and seek to improve the quality of our higher education system. Our students deserve a first-rate education equal to that offered anywhere in Canada. What could be more harmful to New Brunswick's prosperity, indeed to the future of this country, than to have our students and our citizens in any way disadvantaged by attending college or university in this province?

British artist William A. Foster has said it well: "Quality is never an accident; it is always the result of high intention, sincere effort, intelligent direction and skillful execution; it represents the wise choice of many alternatives."

Choosing excellence and pursuing quality will take imagination and courage on the part of the Commission, the government and our post-secondary institutions. Our future and our children's future depend on this.

### About the Commission on Post-Secondary Education in New Brunswick

The Commission: Announced in January 2007 by the New Brunswick government, the commission is conducting the most comprehensive review of higher education in New Brunswick in 45 years. The commission has focused on identifying challenges to higher education in New Brunswick, consulting with stakeholders and the public, and will propose recommendations for the future direction of the province's post-secondary education and training sector.

The Commissioners: The commission is co-chaired by Rick Miner and Jacques L'Écuyer. Dr. Miner is the president of Seneca College of Applied Arts and Technology in Ontario, and is the former vice-president, UNB Saint John. Dr. L'Écuyer has years of experience in the post-secondary education field as president of the Commission d'évaluation de l'enseignement collegial for the Government of Quebec, vice-resident of the Université du Quebec, and president of the Council of Universities for the Quebec government.

The Commission Advisory Committee: The advisory committee has assisted the commission as it proceeded with recommendations and preparation of the final report. They come from a broad range of backgrounds, and all have different and interesting perspectives on the post-secondary system in the province. The members are:

# More than 1,600 graduate, four honoured at Encaenia

# Students give UNBF high marks

f the opinions of students count for anything — and they do — UNB Fredericton seems to be doing all right.

In a recently-released survey of university students across the country, UNB Fredericton outperformed other Canadian universities in three of five key benchmarks.

The National Survey of Student Engagement (NSSE) indicates that UNB Fredericton stands out from other Canadian universities in the areas of student-faculty interaction, active and collaborative learning, and supportive campus environment.

"These results reflect the kind of environment and student experience that we strive to foster at UNB," said Angelo Belcastro, vice-president Fredericton (academic). "It is impressive that a comprehensive university of our size has achieved results in areas more often associated with much smaller institutions."

Of the more than 1,300 first- and fourth-year students at UNB Fredericton who participated in the survey, 86 per cent rated their overall experience as good or excellent. The Canadian average was 80 per cent.

The survey, conducted in 2006, compared student participation in programs and services of 523 universities and colleges in Canada and the United States. More than 30 Canadian institutions participated.

# Budget 'one of the toughest' UNB has faced in a decade

The UNB Board of Governors has approved a \$160.4-million operating budget for the institution's 2007-08 fiscal year. The budget represents an increase of approximately \$4 million, or 2.57 per cent, over 2006-07.

"This is one of the toughest budgets we've faced in nearly a decade," said President John McLaughlin. "New demographic and fiscal realities are directly affecting us.

"We're working with a model that's more than 40 years old. Going forward, we're striving for a new, sustainable institutional and financial framework for UNB and for post-secondary education in New Brunswick in general."

For 2007-08, UNB will derive 57.44 per cent of its operating revenue from the provincial operating grant. Tuition will comprise 35.10 per cent and 7.46 per cent will come from other sources.

UNB's basic tuition for full-time undergraduate students will increase for 2007-08 by 4.5 per cent or \$236, from \$5,246 to \$5,482.

"This is the lowest fee increase in the last seven years, but we know that any tuition increase makes accessibility to a university education more difficult," said Dr. McLaughlin. "To help offset this, we're making a new investment of more than \$1.3 million in student scholarships, library funding, graduate

student support, and student services."

Tuition for graduate students will increase by 4.5 per cent for 2007-08.

To maintain its high quality, nationally accredited engineering programs, UNB will increase the engineering tuition program fee by \$200. This will bring undergraduate engineering tuition to \$6,282 for 2007-08, which is comparable with other engineering schools in the country.

The supplementary fee for international students, which is added to basic tuition, will remain constant at \$3,888 for graduate students for the sixth year in a row. For undergraduates, it will increase by 4.5 per cent, from \$5,374 to \$5,616.

Room fees and meal plan fees for students living in the two residences at UNB Saint John will remain the same for 2007-08. Students living in traditional on-campus residences at UNB Fredericton, will see an overall increase of 4.5 per cent from increases in meal plan costs.

The Board of Governors also approved a \$20.4-million capital budget, which includes more than \$8 million in infrastructure renewal projects on both campuses, funding for accessibility projects, and classroom and laboratory upgrades — including additional facilities for nursing programs.

# Take a seat in a new facility

In the spring issue of *Alumni News*, we profiled the new Richard J. CURRIE CENTER, a building that will become UNB Fredericton's new front door — and its face to the community. This multi-faceted facility will be located on the south side of Buchanan Field overlooking Fredericton and the St. John River. It will include new facilities for fitness, recreation and athletics, as well as research and outreach program space for the healthy living agenda.


During the past several months, university officials have been meeting with alumni and friends to secure the balance of funds required to construct the centre. As a result, UNB has moved much closer to having a state-of-the-art health and wellness centre on the Fredericton campus. General support for the project has been garnered, along with specific funds for the Alberta Alumni Recreation Centre, the Conference Room, the Human Performance Laboratory, the Sports Medicine Centre and the Seminar Room. Support also has been secured for two locker rooms and more than 100 seats through our Name-A-Seat program. However, additional support is needed.

This fall and winter, the focus will be on the Name-A-Seat Campaign. The CURRIE CENTER will include a performance court to be used for varsity athletics and graduation and other ceremonies, and surrounding this will be a 1,500-seat stadium. By selling and naming all these seats, the university will raise a much-needed \$1.5 million toward construction. All members of the UNB family are being looked to for support — alumni, board members, friends, former athletes, faculty and staff, and the Fredericton community.

By naming a seat in The Richard J. CURRIE CENTER, supporters will be putting their names on a part of UNB's history and providing the university with important support to help establish an athletics, recreation and wellness research facility that will enhance UNB's position as a national university. A \$1,000 donation (payable over five years at \$200 annually) will allow supporters to place up to two names on a seat, either for themselves, or in memory of a loved one or friend. Construction of The CURRIE CENTER is expected to begin in 2008.



Amby Legere retired from UNB in 1978 after 32 years' service. He passed away in February 1997.

he mixed-use development of seven per cent of the UNB woodlot in Fredericton is well underway.

The woodlot comprises approximately 3,815 acres in total, of which 3,540 acres are within the city of Fredericton. The latest work is a continuation of previous projects on the approximately 270-acre parcel of the woodlot slated for mixed-use development. Those previous projects include the Knowledge Park, which has been developed in stages since 1999, and the Home Depot complex, opened in 2006.

This year, over the spring and summer, construction crews worked within the mixed-use development area just off the Vanier Highway between Regent Street and Kimble Road, extending the existing Knowledge Park Drive off Regent Street to the Kimble-Road/Allison Boulevard interchange.

The concept plan for the mixed-use development area includes 45 acres of retail development that is currently underway or has been completed (Home Depot), a 45-acre site for the Southside Sports and Leisure Complex, and the remaining land to be filled with a mix of development types, potentially including residential, commercial or other appropriate development.

The Southside Sports and Leisure Complex will include both Olympic-sized and NHL-sized ice surfaces, and construction is expected to begin in 2008. The City of Fredericton has negotiated a 99-year lease with UNB for the 45-acre property on which the complex will be located.

The woodlot project is not proceeding, however,

without some controversy.

Both individuals and Fredericton-area groups concerned about conservation have voiced their opposition to the project.

They argue, among other things, that there is no plan in place for the woodlot's development, and that the land shouldn't be given away to the development of big box retail stores. One group is pressing for a moratorium on the existing work "until such time as the mixed-use development plan and related public consultation are complete."

For its part, the university has established sustainable design guidelines to help shape the concept plan and which will have an influence on the type of development that will occur.

In 2004, the university approved a Land Management Strategy (www.unb.ca/lms) covering all its land endowment, which dates back to 1800 when the institution was granted substantial tracts by King George III. The lands were intended for the university's support, and today, through acquisitions and donations, UNB's endowment comprises nearly 8,300 acres in 12 locations throughout N.B. (See page 17 for details on these and other FAQs about UNB's land endowment.)

Among the key tenets of the strategy are provisions that state UNB is committed to gradual, thoughtful and responsible land development and conservation carried out under strict principles of appropriate design and long-term sustainability. UNB recognizes and respects the public's active interest in its land holdings and will strive to ensure a healthy balance among conservation, recreation,

support our mission," he said.

"First and foremost we will seek to conserve and preserve UNB's ecologically, educationally and environmentally valuable land holdings."

But UNB also will seek to develop — over the next century — lands that are not identified as conservation lands, Dr. McLaughlin said.

"If UNB is to continue to serve this province and this region as a leading, national university, it is imperative that we develop revenue streams beyond tuition income and government grants," he said. "Having said that, it is important to note that we are committed to gradual, thoughtful and responsible land development."

As a result, management of the UNB woodlot in Fredericton is a major component of the Land Management Strategy.

The Woodlot Implementation Plan (www.unb.ca/lms/woodlot) was developed following extensive consultation, and with the input of environmental consultants and experts on habitat and rare species.

The plan has designated 50 per cent of the approximately 3,815 acres of the UNB Woodlot as green space, an area that will be protected from development in perpetuity (see map). It will be available for teaching, research and recreation, while ensuring that ecological sensitive areas are protected. To put it in context, the protected area is four times the size of Fredericton's Odell Park.

While the remaining 50 per cent of the woodlot has been designated Endowment Development Lands, only a very small portion of that — approx-



education and development.

When the strategy was approved by the university's Board of Governors, UNB President John McLaughlin said it was both visionary and responsible.

"Land is one of UNB's key assets, both as an important resource for teaching and research, and as an endowment that can generate revenue and

imately 270 acres — will be developed under the current concept plan, which will continue until 2015. Any further development, if a market exists, will take place over the next 100 years.

This isn't the first time portions of the woodlot have been developed. In the past — and more importantly in the absence of an established landuse plan — parts of the woodlot have been sold or leased to provide revenue for the university or to support community objectives. These include lands leased by the Province of New Brunswick for a variety of purposes, including the Research and Productivity Council of New Brunswick and the Department of Transportation, the Knowledge Park, and other land has been sold for commercial uses along Regent Street, including the Regent Mall.

Today's development — and any future development — will take place under specific guidelines.

The Woodlot Implementation Plan has as its five "guiding principles" the following components:

- Conservation of a Key University Resource: The UNB woodlot contains sensitive ecological areas that should be preserved in perpetuity, and areas that should be used for sustainable mixed-use development on a leasehold basis.
- Balancing University and Community Interests: Uses of the UNB woodlot should serve to: enhance community vitality and well-being; generate long-term revenues in support of the university's mission; leverage additional forest land holdings for research, education and endowment purposes; increase UNB's profile as an environmental steward and community leader; and demonstrate UNB's commitment to excellence in development and management.
- Furthering Education and Research Opportunities: The UNB woodlot should continue to showcase UNB by integrating educational and research activities and its broad based partnerships. A spectrum of educational activities includes public, applied, theoretical and recreational learning.
- An Enhanced Open Space Network: UNB

should promote and facilitate the use of areas of the UNB woodlot as a natural green space for public use within a controlled and managed environment. Planning shall seek to integrate with the larger trail network (bike/walk/non-motorized) already established within Fredericton through collaboration with the city, and the redesign/extension of existing infrastructure.

• Sustainability: The woodlot presents an opportunity to implement sustainable development practices as it relates to protection of natural components and land-use planning including: careful identification of appropriate mixed land uses; waste management; storm water management; balance between local and regional needs; transit-supportive development; and high quality design.

There is no doubt there will always be those opposed to any development whatsoever on UNB's lands.

Yet at the same time, UNB's current and future use of its holdings seem in line with the wording of King George's original 1800 Charter granting the land:

That charter established that the use of, and rent from these lands is to support the fledgling institution, and that revenues received from a grant of land must be applied to an academy or College to be erected and supported at Fredericton.

The "academy or College" — UNB — has now been long established, and its support at Fredericton and elsewhere will continue, thanks to King George III.

### Some FAQs about UNB's management of its land holdings

### Frequently Asked Questions About UNB's Land Management Strategy

### What is the UNB Land Management Strategy?

The UNB Land Management Strategy is a policy and administrative framework for the management of the university's land holdings. The strategy provides a comprehensive review of the university's land endowment and presents a series of recommendations and strategies to enable the university to realize the full potential of these assets.

### How did UNB obtain its land endowment?

More than 200 years ago, UNB was granted substantial tracts of land by King George III. These lands were intended for the university's support.

### What is UNB's land endowment?

UNB's 8,295-acre land endowment comprises 12 locations throughout the province. Most of the property is near Fredericton and Saint John. In descending order of area, the four largest properties are:

- · UNB Woodlot (3,815 acres in total, 3,540 acres in the city of Fredericton)
- · Noonan Woodlot (3,781 acres)
- · Saint John Campus (222.8 acres)
- · Fredericton Campus (142 acres)

### Why was the Land Management Strategy developed?

UNB, and its Board of Governors, recognized the tremendous importance of being a responsible steward of its lands.

### How was the strategy developed?

Following a public tendering process, Brook McIlroy Planning & Urban Design, was hired to prepare the strategy — with assistance from Jacques Whitford Environmental Limited, ADI Ltd., and Hemson Consulting — for the properties committee of the UNB Board of Governors.

An extensive process of consultation and review was undertaken throughout the development of the strategy, including interim presentations to the board, to members of the university community and to a substantial number of community stakeholders. The development of the strategy took about three and a half years.

### What are the key tenets of the Land Management Strategy?

First and foremost, UNB seeks to conserve and preserve its ecologically, educationally and environmentally valuable land holdings.

To develop much needed revenue streams beyond government grants and tuition income, UNB will seek to develop — over the next century or longer — those lands that are not identified as conservation lands.

UNB is committed to gradual, thoughtful and responsible land development carried out under strict principles of appropriate design and long-term sustainability.

UNB recognizes and respects the public's active interest in its land holdings and will strive to ensure a healthy balance among conservation, recreation, education and development.

### How is the Land Management Strategy being used?

Under the Land Management Strategy, a number of specific plans have been identified and initiated for UNB properties, including:

- · UNB Fredericton Campus Plan
- · UNB Saint John Campus Plan
- · UNB Woodlot Implementation Plan

### Frequently Asked Questions About UNB's Woodlot Implementation Plan

### What is the Woodlot Implementation Plan?

It is a plan to optimize the UNB Woodlot in Fredericton as a key resource for the purposes of conservation, teaching, research, recreation and revenue generation to support the mission of UNB.

### Why is it important to have a plan for the Woodlot?

At roughly 3,815 acres, the UNB Woodlot is roughly equivalent in size to the urbanized area of Fredericton south — that is, the area bounded by the Hanwell Road, the St. John River, the Wilsey Road and the Vanier Highway/Prospect Street on the south. Because of its size, the UNB Woodlot has had a dramatic impact on the regional urban growth in Fredericton. There has also been a great deal of pressure to develop sections of this vast property. The plan will ensure that all decisions about the property follow the key tenets of the Land Management Strategy and adhere to a series of guiding principles.

### What are the Guiding Principles for the Woodlot Implementation Plan?

The five guiding principles for the plan are: conservation of a key university resource; balancing university and community interests: furthering education and research opportunities; an enhanced open space network; and sustainability. (See www.unb.ca/lms/woodlot for further details.)

### Who was consulted during the development of the Woodlot Implementation Plan?

Many stakeholder groups and individuals from within and beyond UNB were consulted to obtain information and input on valued features of the woodlot, including recreational, research, teaching and environmental features. Examples include faculty members in kinesiology, forestry and biology; naturalists; recreational groups; provincial government representatives; Ducks Unlimited; and the City of Fredericton. Information provided by these groups and individuals was used to establish areas within the woodlot that should be set aside for conservation and protection, and to establish which areas would be more suitable for development.

### What portion of the UNB Woodlot has been designated Endowment Conservation Lands?

Approximately 50 per cent of the entire woodlot is designated as Endowment Conservation Lands. These lands will be conserved in perpetuity ensuring that the ecologically sensitive areas of the woodlot are protected.

The Endowment Conservation Lands are contiguous conservation areas available for

teaching, research and recreation; as well as green spaces and corridors in the Endowment Development Lands.

This is a considerable legacy that UNB is establishing in recognition of the importance of the woodlot in supporting activities and features that are valued by the university and the public.

### What portion of the UNB Woodlot has been designated Endowment Development Lands?

Approximately 50 per cent of the woodlot is designated as Endowment Development Lands.

### What is the timeline for development?

The majority of the Endowment Development Lands will remain as is for a very long time: 50 to 100 years. A small portion of the woodlot, approximately seven per cent, has been identified for a mixed use development over the next eight years (2007-2015). Other portions of the Endowment Development Lands may, if the market exists, develop over the next century — if the appropriate proposals are brought forward and if municipal services, such as water, sewer and roads, are extended to allow development.

### What is the concept plan for development?

The concept plan applies to the area between Regent Street and Kimble Road. The plan is for a mix of land development types with a 45-acre retail area under construction, a 45-acre Sports and Leisure Complex and the remaing approximate ~180 acres for a mix of land use types. UNB has worked closely with consultants and in-house faculty to develop design principles to guide responsible and esthetically pleasing development.

### How will the income from the concept plan development be used?

The income will be used to finance:
· initiatives related to the growth and development of the Fredericton campus, guided by the UNB Fredericton Campus Plan,

- · campus renewal and maintenance,
- · management of UNB's land endowment.

### Will development restrict use of the UNB Woodlot for recreation, education, or research purposes?

With the exception of the concept plan development area, use of the remainder of the woodlot will remain as is for the foreseeable future.

The Woodlot Implementation Plan protects, over the long term, the valued features and activities that the woodlot supports. In fact the plan will put in place a structure that should improve the support that the woodlot provides to the university and to the public over the long term. To that end, the university is currently developing an advisory group that will assist with the stewardship of the endowment conservation lands.

### What about public access? Will people still be able to walk dogs or ski in the woodlot?

These uses will continue, and be improved with specific recreational plans.

During the graduation ceremonies, concert pianist Ludmila Knezkova-Hussey received an honorary doctor of letters degree and former provincial cabinet minister and Senator Brenda Robertson received an honorary doctor of law degree.

Dr. Knezkova-Hussey, who makes her home in Bathurst, N,B., is a concert pianist, composer, choral conductor, chamber performer, and educator who has performed as a soloist in more than 50 countries. She has appeared as a guest artist with several orchestras including the Moscow Symphony, the Swedish National, the Russian State Symphony, and the Orquesta Nacional de Espana.

Dr. Robertson of Moncton, N.B., was N.B.'s first female MLA, and first female cabinet minister, serving in portfolios that included youth, social services and health. She was appointed to the Senate of Canada in 1984. During her 20-year term, her participation in the chairing of key committees highlighted her understanding and foresight across a range of areas including healthcare, fisheries, and the economy.

Retired computer science Prof. Lawrence Garey and retired psychology Prof. Paul Gendreau were recognized as *professors emeriti*.

# Learning Commons supports students' needs

The Learning Commons at UNBSJ is a new facility designed to provide students with support for all of their information, technology, and writing needs. When they first come to campus, few students know that many resources critical for academic success are readily available — more than 100 bibliographic databases, more than 21,000 electronic journals, dozens of specialized software applications on state-of-the-art computers, to name just a few, plus expert help in incorporating all of these tools into papers and presentations.

The mission of the Learning Commons is to provide students with in-person, professional support in a facility that enhances learning at UNBSJ. The Learning Commons occupies some of the best space at the university — the main floor of the Ward Chipman Library, overlooking the beautiful Kennebecasis River.

Even the furniture in the Learning Commons is designed to make learning easier and better. Big spaces at every workstation encourage students to 'spread out' while working on assignments and presentations, and allow small groups to form and disperse as needed. Laptop computers, scanners, printers, and photocopiers are also available.

The Learning Commons is the first manifestation of the new University Commons, a new building that will house the library, technology services, many student services, the bookstore, and public and private meeting and presentation spaces. As a proving ground for new technologies, and learning and teaching methodologies that will be standard features of the University Commons, the Learning Commons is also equipped with a new presentation suite featuring a data projector and screen, a Smartboard™, and a large LCD display system for viewing videos or other presentations created with Learning Commons software.

### Medical education program set for UNBSJ

The Province of New Brunswick, Dalhousie University and UNB will partner to create two working committees and proceed in negotiating a five-year agreement to train 30 New Brunswick undergraduate medical education students at UNB's Saint John campus.

The announcement was made in June by Post-Secondary Education, Training and Labour Minister Ed Doherty and Health Minister Michael Murphy.

"Government has approved the policy and the road map to the creation of an English-language medical education program in Saint John, and we will finalize the agreement by the fall of 2008, so that the first students will begin their studies in September 2009," Mr. Doherty said.

"This will be an excellent complement to the French medical program offered in Moncton through the Université de Sherbrooke. Giving New Brunswickers the opportunity to study medicine and train in their home province fits well with our strategy to retain our best and brightest minds."

Murphy said there will be 27 physicians hired over the next five years to provide medical instruction for students.

"These new physicians will spend about one-third of their time teaching and the remaining time providing medical services to New Brunswickers," Murphy said. "This represents an investment of up to \$4.5 million annually."

Sharing their experiences

Several former international students who are now UNBSJ alumni working in Saint John returned to campus in May to speak to a group of current international students. The alumni shared their experiences on how they launched their careers in Canada. From left are Yan (Ida) Nie (BBA'06), Rui (Hope) Liang (BBA'03), Mary Wang (BBA'04), Monica Zhu (BBA'06), Zafar Quresh (BBA'05), Sacha Patino (BBA'02), and Beverly Zirobwa (BBA'04). Also participating were Brandon Zhan (BBA'06) and Yan Guo (BBA'05).

The agreement to be finalized will enable Dalhousie University to deliver its four-year undergraduate medical program at the UNB Saint John campus beginning in September 2009. Dalhousie will supply and deliver the curriculum, while UNB Saint John will house the program and provide student support services, as well as computer technology and library services.

Funding for the development of the decentralized program once the agreement is finalized will be allocated in future years. As well, the province will increase the number of seats available to New Brunswick students at Dalhousie from 20 to 30.

Doherty also announced the creation of two committees to streamline the negotiation process.

"I have appointed a management committee made up of the deputy ministers of both departments, as well as the presidents of Dalhousie University and UNB," Doherty said. "The management committee will direct the development of the program through a negotiating committee made up of representatives of the Dalhousie University Faculty of Medicine, UNB and our two departments."

"Dalhousie has a long and successful partnership with New Brunswick in delivering medical education, and the proposed program announced today represents a natural evolution in this partnership, and an important component in New Brunswick's health human resources planning," said Dr. Harold Cook, dean of the Dalhousie Medical School.

"We are very proud to be part of this important new partnership," said UNB President John McLaughlin. "This announcement provides a major new opportunity for medical education and significantly strengthens the health sciences teaching and research agenda at UNB Saint John. It is yet another building block in developing a strong post-secondary education system for all New Brunswickers."

Murphy said providing these training opportunities for residents sends a strong signal to medical students that "we want them to choose to spend their career here in New Brunswick."

"If residency programs are available in our province, there is much better possibility that our physicians will stay here," Murphy said.

"The delocalized medical education program will have significant impact on the recruitment, retention, research and development, and provide significant economic benefits to New Brunswick," Doherty said. "Where there are medical education professionals, there is increased research; and that will bring more research funding to New Brunswick. This initiative also fosters the potential for more co-operation between medical education and existing programs in Saint John, including nursing and other professionals."







### A personal reflection on the nursing program at UNB

Retired nursing Prof. Val Gilbey (BN'63, BEd'70) wrote the following reflection on her experiences as a student and teacher at UNB.

Demo/Competition

Graduates from our Class of 1963 were historic players in the inclusion of nursing as an academic degree at UNB; ours was the first nursing class to be admitted to the university.

My first memory of being on campus was attending the President's Tea at the Student Centre. I was a country girl wearing my mother's high-heeled shoes and a dress I had made myself! That was the beginning of my life in nursing, an initiation that launched my professional career. Until 1999, when I retired as a nursing professor, I drew consistently from my educational preparation. The UNB nursing program was very challenging; it required comprehension and mastery of arts and science courses, and nursing courses, which, at that time, included full-time clinical work in Moncton or Saint John each May and June.

Factors that mattered for our class and that still seem to matter include the following: how committed and supportive our nursing professors were/are; how most university professors in other faculties welcomed us; how cohesive the 14 members of our class became; how beautiful and inspiring the campus was/is in all seasons; how much I enjoyed the library and how helpful the librarians were; how important it was/is to be recognized at graduation by receiving our degrees along with all other faculties; and how important the final or concluding transition was/is to clinical practice.

From those learning experiences, I've been prepared over my career to engage in the right work, at the right place and at the right time. My education opened a whole vista of experiences for me and whetted my appetite for continued learning. Lifelong learning truly began for us at UNB nursing. On behalf of our class, I'm pleased to celebrate these first 50 years of professional education in nursing.

# Alumni staff member receives national award

member of the UNB Associated Alumni staff has won a national award from the Canadian Council for the Advancement of Education (CCAE).

Alumni Outreach Co-ordinator Shaw-Pratt named a CCAE Rising Star at the council's national conference in P.E.I. in June. The award is presented annually to individuals with three and to five years' experience in the institutional advancement field, and who demonstrate

achievements and accomplishments in the institutional advancement field, early success as an advancement leader, and professional and volunteer contributions that indicate a strong commitment to advancement in Canada.

A Fredericton native, Shawna graduated from UNB with a BBA in 2002. She showed a keen interest in the advancement field in her fourth year, when she served as a faculty recruitment assistant for business administration.

After graduation, Shawna accepted a position in UNB's Student Recruitment and Integrated Marketing office as a high school liaison officer. From there, she became the alumni student recruitment co-ordinator — a position designed to engage UNB alumni in the university's recruitment effort. Over a two-year period, she increased alumni involvement in the university's recruitment efforts, especially through strong support for the "Pass it On" program — an alumni student referral program — and oversaw the alumni diploma framing program. During these two years, the framing program revenues increased from \$18,000 to \$30,000 per year.

Since 2005, Shawna has been the alumni outreach co-ordinator. Shawna redefined the Associated Alumni's chapters and clubs program, which now has 84 alumni volunteers registered in one of six outreach program categories. She organizes 45 to 60 events annually, assists new graduates with community transition, and plays a major role in the continuous improvement of the association's online registration and payment program.

As a result of Shawna's leadership and creativity, over the past three years 1,500 UNB alumni have become active in the life and work of the association and the university. Shawna is an important member of UNB's alumni and advancement teams, providing key ideas and input relating to strategic direction, operational policy and guidelines, and institutional alumni support. Her professional approach to advancement work and her engaging personality have earned Shawna immense respect from colleagues inside and outside UNB.






