

All three of these new facilities have the combined effect of changing the campus in many ways; more students, more professors, more options and greater opportunities for Saint John-area students.

Revolutionary Social Change in Colombia: The Origin and Direction of the FARC-EP

Compared to other Latin American countries, minor sociopolitical analysis has been given to contemporary Colombia. This lack of investigation is perplexing due to Colombia's geographical and socioeconomic importance worldwide. The Andean country has one of the largest reserves of fossil fuels in the world, it is home to the longest running civil war in the hemisphere, and is the poster-child of the international drug trade. Amidst such conditions, Colombia also holds a unique and interesting history of resistance against dominant political-economic interests. At the helm of this decades-long struggle has been the Revolutionary Armed Forces of Colombia-People's Army (Fuerzas Armadas Revolucionarias Colombianas-Ejército del Pueblo, FARC-EP). Attempting to fill a much-needed void, Revolutionary Social Change in Colombia evaluates the unique theoretical and pragmatic composition of the insurgency and its relation to radical social change within Colombia. James J. Brittain addresses the question of who the FARC-EP are, what they are doing in Colombia, and if this insurgency can assist in the creation of a social and political revolution of, by, and for those marginalized in Colombia.

One Hundred Years of Military Mapping in Canada

The Mapping and Charting Establishment has had other names in its history, but this small, highly skilled and essential organization is as old as the army itself. It is easy to see in the photos and personal stories how these military mappers pushed, led, and supported in the accurate mapping of a land 18 times the size of France. In the First World War, they pioneered the accurate location of artillery targets, and in the Second World War found out how to use air photos for accurate and rapid mapping. In the Cold War, they worked to map the world, and today the story tells of modern combat operations supporting military actions in the Balkans and in Afghanistan. In 1903, these intrepid mappers slapped mosquitoes and black flies in the swamps of Petawawa while painstakingly drawing a map on a plane table. Now they sit in front of computers in the dust and danger of Afghanistan combining good maps with timely information about the enemy. From the preface to the last chapter, you will be convinced that these men and women are damned good at what they do!

Women of India, Their Status Since the Vedic Times.

A systematic presentation of the status of women of India throughout the long history of about 6,000 years has been presented, starting from the Vedic times to the postindependence period. A detailed description of the status of women during the Vedic times, which is rarely available in any of the existing literature, and in the following periods is very significant to the study of this subject. The author has discussed how the political and religious conditions over the periods have affected the conditions of women. The age-old evils, which had become firmly entrenched in the Indian society, such as the tradition of Sati, illiteracy, child marriages, and deplorable treatment of widows and so on, still persist and some new ones have joined the list. To the credit of the Indian government, legislative measures have been taken to protect and improve the status of women after independence and just prior to it. Those have been outlined. A snapshot of the present conditions is given along with concluding remarks and recommendations for improvement.

What God Has Promised You: Ancient Wisdom for Modern Times

Each chapter identifies a promise, and guides the reader with questions for reflection, the theological context of the promise, and a meditation on the promise. The book is filled with modern day life examples that will resonate with everyday situations and circumstances for many readers.





Researchers awarded nearly \$1M to improve health care in N.B.

Two researchers at UNB Fredericton have received research grants of close to \$1 million to carry out projects that will improve health services for New Brunswickers.

The funding was awarded through the Canadian Institutes of Health Research (CIHR) Partnerships for Health System Improvement (PHSI) program and the N.B. Health Research Foundation, a funding partner in the PHSI program.

Judith Wuest received \$484,950 over three years to examine the feasibility of a primary health-care intervention for women who have left abusive partners. Nicole Letourneau received \$499,829 over three years to study telephone-based support programs for new mothers suffering from postpartum depression (PPD). Both are researchers and professors in the faculty of nursing.

"These grants are a testament to the critical work that Nicole and Judy are doing in the areas of women's health, mental health, and family and community services, and in influencing public policy and social change," said Greg Kealey, UNB's provost and vice-president (research).

Dr. Wuest's project will evaluate a nurseled health intervention delivered in collaboration with existing domestic violence outreach services. She has partnered with the N.B. Women's Issues Branch, the N.B. Department of Health, and Liberty Lane Inc., which collectively are providing inkind contributions of close to \$50,000. The partners will provide direction for the research and become the first users of the new knowledge.

Dr. Letourneau's project addresses postpartum depression, which affects nearly one in seven new mothers. Her team includes researchers at the University of Alberta, UNB, the University of Toronto and the IWK Childrens' Hospital, and decision-makers with the Public Health Agency of Canada and three divisions of the N.B. Department of Health.

Atlantic Innovation Fund, ACOA step up

\$5.8M for research

Three UNB researchers received a total of \$5.8 million from Round VII of the Atlantic Innovation Fund (AIF) delivered through the Atlantic Canada Opportunities Agency (ACOA).

For UNB researcher Kenneth Kent, this means the creation of a new centre that will work to make computer systems faster.

The demands for faster processing speeds are important today in commercial/research computing, but they have reached their practical limit. Currently, IBM, Oracle and Microsoft are racing to develop new multicore solutions to achieve high-performance results.

With the AIF investment, Dr. Kent and his team will create a set of software tools and techniques to run IBM's J9 Java Virtual Machine more efficiently on massive multicore systems.

Dr. Kent said this project brings short-term and long-term opportunities to UNB.

"By teaming with IBM to enhance Java Virtual Machine technologies we are providing a hands-on industrial/research learning environment and building a critical mass for the establishment of an IBM Centre of Advanced Study," said Dr. Kent. "This centre will act as a vehicle for future projects between the faculty of computer science and IBM beyond the life of the AIF-funded project."

Through the creation of a Centre of Enhanced Study, in partnership with IBM, UNB will attract research and development staff to Fredericton. The

centre will have approximately 20 staff and provide research opportunities to more than 20 graduate students, which will position UNB to be a world leader in research and development in Java Virtual Machine technology.

This project, with total estimated costs of \$5.1 million, will receive approximately \$3 million from the AIF over a four-year period.

The Round VII of AIF also funded two other UNB projects.

Chris McGibbon, professor of kinesiology, received \$1.9 million towards the development of a toolkit to perform the assessment of muscle impairment.

Yonghao Ni, professor of chemical engineering and chemistry, and Huining Xiao, professor of chemical engineering, received \$976,000 to develop new technology for the production of value-added products from hemicelluloses in pulp mill waste streams.

In addition, Andy Justason from the Centre for Nuclear Energy Research, owned by UNB and the Research & Productivity Council, was awarded \$1.2 million to develop two new corrosion monitoring instruments to be used for predictive maintenance in nuclear plants and other heavy industrial facilities.

Greg Kealey, vice-president research and provost at UNB, said funding support such as the AIF is what allows UNB to be the leading research institution in the province.

TFirst: Integrated Recruitment & Retention in Fredericton is implementing a new approach to its undergraduate domestic recruitment efforts.

"We recognize that a healthy incoming enrolment is vital to UNB," said Susan Mesheau, executive director of U First. "Although we've experienced a six-per-cent and an eight-per-cent increase in full-time and parttime new, incoming undergraduate students in fall 2008 and fall 2009 respectively, we're seeing an incredible amount of competition from other post-secondary education institutions in our target markets. That, combined with a declining 18-24-year-old demographic in New Brunswick, means we need to work smarter."

U First has implemented a recruitment structure that is more often found in the private sector — that of an outside and an inside team. The outside team recruiters are assigned to specific geographic prospect territories (see box at right). The inside team is focusing on two new opportunity areas — online recruitment through new media and on re-admit recruitment to reattract those students who have attended UNB previously but have been out of school for at least a year.

Geographic territories are divided into four areas: Western N.B., Eastern N.B./P.E.I., N.S./NL and Ontario/Western Canada. A recruiter is assigned to each territory — the Atlantic Canadian recruiters are based in Fredericton and the Ontario/Western Canada recruiter is located in Toronto. A fall 2010 enrolment target has been set for each area and the recruiter is accountable to the target.

"Our recruiters are professionals and are very energized with the new approach," Mesheau said. "They know that the expectations are high and that just makes them more determined. The outside team is already on the road focusing on relationship building with all key stakeholders groups in their territory, including high school administrators and guidance counsellors, high school students, parents, transfer students and alumni."



When faced with the choice in the Dirty Thirties between sending his fourth child to university and renewing insurance on the family store, Florence Swan's father chose to pay her tuition.

Such was the importance of education to the Swan family. Unfortunately, the store burned down, but Florence went on to dedicate her life to teaching and learning. (The store was rebuilt.)

The late Dr. Swan's commitment to education will continue for generations to come through the Florence Swan Memorial Scholarship.

Created with her bequest of \$160,000, the scholarship will benefit students from New Brunswick, with financial need, who are enrolled in UNB's bachelor of education program.

"We had no idea she'd been so fiscally astute," said Swan's niece. Elizabeth Ferguson. "But we weren't at all surprised by what she did

with her bequest. She was very much attached to the and the New Brunswick Teachers' College. She joined university and any time I visited her, she wanted to go through campus."

Dr. Swan was a retired associate professor in home economics in the faculty of education. Born in Oxford, N.S., she held degrees from Mount Allison University, Columbia University, and Penn State. She also held a certificate in dietetics, and studied nutrition at the University of Toronto.

"Sir Howard Douglas Scholars see opportunity where others see obstacles," said UNB President Eddy Campbell. "They want to build a world where dignity and character come first. They are a shining example of what we can achieve at UNB.'

Nominated by their faculties, the scholars must have completed two years of their bachelor's degree program, achieved academic excellence and actively participated in co-curricular or extracurricular activities. Recipients are inducted into the Sir Howard Douglas Society of Scholars.

At a dinner in their honour, the 2010 scholars were addressed by alumnus Gururaj (Desh) Deshpande, who graduated from UNB in 1975 with a master's degree in electrical engineering and received an honorary doctor of science from

UNB in 2001. He is chairman of A123 Systems, Sycamore Networks, Tejas Networks, Sandstone Capital and HiveFire.

Born in Scotland, Sir Howard Douglas served as lieutenant-governor of New Brunswick from 1823 to 1831. Sir Howard was a founder and the first chancellor of King's College Fredericton, predecessor to UNB.

UNB and its milestones . . .

WE HAVE A Long History OF PARTYING

ecause of its many incarnations - the Provincial Academy of Arts and Sciences (1785-1800), College of New Brunswick (1800-1828), King's College (1829-1859) and the University of New Brunswick – UNB has more than its share of anniversaries. In fact, UNB has celebrated no fewer than two

bicentenaries and two sesquecentenaries (150th anniversaries), sometimes with bewildering timing. For example, UNB's centennial celebrations took place in 1900, marking the 100th anniversary of the charter for the College of New Brunswick. A sesquicentenary of this occasion was held (logically) in 1950, but yet another took place in 1979, when we observed the 150th anniversary of King's College and the opening of the Old Arts Building (aka Sir Howard Douglas Hall). Then just six years later, in 1985, came the bicentennial celebrations of the 1785 petition to establish the Academy of Arts and Sciences.

Maybe this is how UNB acquired its reputation as a place that loves a party.

It all began at the turn of the last century

Not surprisingly, perhaps, it was the students who got the festivities going. In 1899, the Class of 1900 petitioned the university senate to hold a "fitting celebration" marking 100 years since the granting of a provincial charter for the College of New Brunswick. "The advantages resulting from bringing the College before the people favorably and rallying the graduates around their Alma Mater cannot be overestimated," they wrote. "At this important period in her history much might be accomplished of a permanent benefit to the College by arousing the friends of the institution to added exertions on her behalf and more liberal donations." By June of that year, a joint senate-alumni committee

had been struck to plan the celebrations.

And what celebrations they were. Centred around Encaenia at the end of May 1900, the events filled five days. All were free and open to the public as well as students, alumni, faculty and staff. They included the graduation ceremonies for the 11 men and one woman who completed their degrees that year; a students' day at City Hall in downtown Fredericton; sporting competitions; a variety show; an on-campus garden party; the laying of the cornerstone for the science and engineering building (also promoted by the students, who raised \$1,455 for the edifice which is now part of Head Hall); and an alumni ball attended by 400 people. The Old Arts Building, the only major building on campus, was festooned with bunting and banners.

The crowning glory of the centenary was a ceremony at the Legislature attended with much pomp and circumstance by delegates from various learned societies, 31 Canadian universities, and several prestigious international institutions, including Harvard, Oxford and Cambridge. The university presented a total of 42 honorary degrees, many to these distinguished representatives. Despite the report in the *University Monthly* (predecessor to the

Brunswickan) that, "The program was carried out without a hitch or a break," one honorary degree recipient, founder of New Brunswick's free school system, Theodore Rand, was stricken with a heart attack and died on the spot.

The sesquicentennial celebrations in May 1950 also spanned five days. Preceded by a lecture series, which featured several major speakers, including Nobel Prize winning chemist Linus Pauling, the 150th anniversary was a whirl of various alumni reunion activities, banquets and dancing, the iron ring ceremony for engineering graduates, and two Encaenia ceremonies at which "only" 31 honorary degrees were presented. A special convocation was also held in Saint John, then the home of the UNB Law School, at which three members of the legal profession were honored, including Supreme Court justice and native New Brunswicker Ivan Rand. A history of UNB, The Memorial Volume, a collection of essays edited by historian Alfred G. Bailey, was published and sold for \$1.50.

Celebrating King's College

Just 29 years later, the University held another

After a lengthy search that left a patchwork of excavation around its foundation, the original cornerstone of the building was unearthed and opened, revealing a glass bottle, three British coins from the 1820s, and a brass plaque inscribed in Latin, which read, in part,

With support and honour from all pious and good citizens, The First Attempt at here establishing a Seedbed of Learning upon the most liberal and soundly based principles should be treated... And likewise the building here constructed by the authority of true Loyalty and with the protection of the Father of our Country, sustained by the wisdom of its founders, the integrity and knowledge of its leaders, may it become a Seat of Liberty and Letters, and for many centuries endure.

The main celebration took place in front of 200 people on New Year's Eve 1978 with a viewing of the corner-

stone contents and a "Historical and Musical Extravaganza" written by history professor Bill Acheson, directed by Spanish professor Alvin Shaw and starring President Emeritus Colin B. Mackay, Vice-President Tom Condon and English professor Bob Gibbs. The Brunswick String Quartet provided the accompaniment. Lt.-Gov. Hedard Robichaud presided over the evening.

The Old Arts Building, or Sir Howard Douglas Hall, is an architectural gem and

the oldest university building still in use in Canada. It was therefore only fitting that on Jan. 1, 2004, the university community marked the 175th anniversary of the centerpiece of UNB Fredericton by reenacting the opening of the building. Local actor Peter Pacey appeared as the "ghost" of honour, Sir Howard Douglas, presenting the landmark speech that the lieutenant-governor had delivered almost two centuries before.

Two centuries, twice observed

Several years in the planning, the most extensive celebration ever conducted at UNB was the yearlong bicentenary of 1985-86, which commemorated the Loyalists' petition to Lt.-Gov. Thomas Carleton on Dec. 13, 1785, requesting the establishment of a Provincial Academy of Arts and Sciences. UNB, as well as Fredericton High School, traces its origins from this early desire for educational opportunities for the youth of the province.

Recognizing UNB's fiscal challenges, the Bicentennial Committee planned a year of costeffective, grass roots activities that appropriately

honoured this significant anniversary. The year's activities included three major events - Fall Convocation in Fredericton at which 10 honorary degrees were presented; Gaudeamus Igitur, a dramatic musical re-enactment of the presentation of the petition in Saint John by English professor Mark Blagrave; and Encaenia celebrations in Fredericton in May 1986. There were joint celebrations with the University of Georgia, which was also founded in 1785; an exhibition of works by artists associated with UNB; a Bicentennial Ball; an oral history project; special lectures; and a wall calendar featuring the tapestries of alumnus Ivan Crowell. The letters of James Robb, who taught at King's College and UNB from 1837 to 1861, were published, along with several departmental histories, giving insight into the development of UNB. And the Beaverbrook Canadian Foundation established the Bicentennial Scholarships for continuing education.

In February 2000, UNB marked another bicentennial, this one of the charter for the College of New Brunswick. University orator and history professor

Stephen Patterson saluted the rich history of the institution in a lecture entitled, "From College to University: The Origins and Chartering of the College of New Brunswick." The actual 1800 charter granted by the province was on display.

Saint John's proud heritage

Not to be outdone by its older sister campus, UNB Saint John, established in 1964, has marked both its 25th and its 40th anniversaries. The sil-

ver anniversary party took place on Oct. 12, 1989, with the official opening of the Alumni Gate, donated by graduates; the dedication of the G. Forbes Elliot Athletics Centre, named in honour of the campus's first vice-president; several open houses and art exhibitions; and the planting of 25 trees given as a birthday present by the Fredericton campus.

In 2004, the 40th anniversary spanned a weekend of activities including a golf tournament, banquet, dinner theatre reliving the history of the campus and a Back to Campus Day.

Another cause for celebration

And so we come to the 225th, a *Celebration of Spirit*, commemorating once again the petition of 1785. Our long and interesting history has provided many occasions to reflect with pride on all we have accomplished here. But there is one anniversary that has never been observed: the 1859 passage of the act creating the University of New Brunswick. Its 150th passed without notice in 2009. Anyone for another bicentenary in 2059?

UNB to establish degree in First Nations governance/management

UNB has received \$550,000 from the province to further develop programs and services directed to potential and current Aboriginal students.

The funding is part of a more than \$1-million Government of New Brunswick initiative to recruit and retain Aboriginal students to the province's post-secondary institutions. Donald Arseneault, minister of post-secondary education, training and labour, made the official announcement earlier this year.

UNB has used this financial support to appoint Gwen Bear, UNB's first Aboriginal elder-in-residence, to work with the university's Mi'kmaq Maliseet Institute (MMI). It has also hired an Aboriginal recruiting officer.

The funding is also going towards the development of specialized curricula that will include a First Nations perspective.

MMI researchers and First Nations education experts are currently working together to review and design curricula that are culturally appropriate in pedagogy and content. This initiative could help shape First Nations education in New Brunswick.

UNB and the MMI are also in the process of establishing a bachelor's degree in First Nations governance and management as an extension of the existing certificate program. It will be the first undergraduate degree of its kind in Canada.

"These are things we can provide as we continue to define ourselves as 'the University for New Brunswick'," said UNB President Eddy Campbell in making the announcement.

"This support will allow the institute to build on its entrepreneurial initiatives and continue to provide New Brunswick's First Nations students with programs and services that will prepare them to be strong leaders in their communities and their country."

Peter Coates named interim director of development and donor relations

Peter Coates has been appointed UNB's director of development and donor relations (DDR). Serving in an interim capacity, Coates began his duties on Feb. 1, 2010, for a six-month period.

Coates has a long history with the DDR team, originally joining the office in 1995.

Coates graduated from UNB with a bachelor of business administration in 1983. He received a UNB Distinguished Service Award in 2002 for his contributions to building partnerships with donors that translate into opportunities for UNB and its students.

Julie Dickson (BA'79)

Watching over Canada's financial institutions

Canada's top prudential financial watchdog holds a bachelor of arts in economics from UNB.

Julie Dickson (BA'79) is the federal superintendent of financial institutions. It's her job to regulate and supervise Canada's banks, insurance companies and private pension plans.

There's no such thing as a 'typical day' for Dickson, who splits her time primarily between Office of the Superintendent of Financial Institutions (OSFI) offices in Ottawa and Toronto and regularly travels the world to represent OSFI at international meetings.

"Financial services is a global industry, and there's a lot of effort spent to try to ensure that the rules are the same around the world," she explains.

Dickson oversees OSFI, which shapes the supervisory and regulatory frameworks of financial institution policy for Canada.

"The breadth of responsibilities is quite challenging," she says. "We like a challenge. You're also seeing first-hand what financial institutions' plans are, and how they are dealing with the challenges they face. Seeing it across the whole sector can be very exciting."

Lifelong interest

Ms. Dickson's interest in financial institutions began earlier than one would think — she first fell in love with banks at the age of 10.

"I remember walking into a bank branch and thinking it was a very fascinating place," she says.

While attending UNB Fredericton, Dickson spent her summers working at

a bank. She attended graduate school in Ontario before she started her career with the Department of Finance in Ottawa in the capital markets group.

"Next to my office was the group that dealt with the Bank Act. I immediately thought 'that's where I'd like to be.' It's where I went after a year."

After 15 years with the Department of Finance, Dickson moved to an Ottawa consulting firm and then to the Privy Council Office, serving the prime minister, before taking a position at OSFI.

Having worked with OSFI for much of her time with the Department of Finance, joining its office as a special adviser was an easy move. Within a short period of time, she had become assistant superintendent of the regulation sector, and then was appointed deputy superintendent a few years later. Dickson was appointed superintendent of financial institutions in July 2007.


Tight-knit community

UNB is a big part of Dickson's family.

"We have six kids in the family and they all went to UNB," she says.

Dickson remembers her own time at UNB for the people and the size — its small classes and close community made it easy to make friends and be engaged.

"I lived in Lady Dunn Hall, and that was a lot of fun. You meet many people and I made a lot of friends," she says. "Some of my classes only had six to 10 students. I liked the atmosphere and the small campus."



Top honours in the CIS

Third-year V-Reds forward Hunter Tremblay was named Canadian Interuniversity Sport (CIS) player of the year in men's hockey, while his coach, Gardiner MacDougall, was named CIS coach of the year.

Tremblay became the second V-Red in three years to claim the Senator Joseph A. Sullivan trophy. Former UNB great Rob Hennigar was honoured in 2007-08. Tremblay captured the CIS scoring crown with 57 points, tied for the nation's lead with 25 goals and ranked fourth in the CIS with 32 assists in 27 conference games.

MacDougall became the second UNB mentor to earn the Father George Kehoe Memorial Award for coach of the year. Mike Kelly was honoured in 1997-98.

In his 11th season behind the bench, MacDougall led the Varsity Reds (27-1-0) to a record campaign

during which they set a CIS mark with 27 conference wins and established a new Atlantic University Sport (AUS) standard with 54 points, tying the all-time CIS record.

However, the Reds dream season came crashing down in the AUS semi-finals when they were swept in three straight games by St. FX.

But the Reds will definitely be in the CIS finals for the next two years as UNB again hosts the nationals in 2010-11 and 2011-12.

The SIF students ended 2009 with their best investment performance to date, closing at \$2.4 million in funds under management. The 2009 absolute performance for the Canadian balanced fund portfolio was 17.8 per cent, 91 basis points over the benchmark performance. Since its inception more than 11 years ago, the SIF program has exceeded all expectations. The student-managed fund peaked during the summer of 2008 before the financial crisis. The students have recouped the underperformance of the last year strictly from investment returns.

Foundation for Innovation awards \$752,223 to UNB research projects

Four research projects at UNB Fredericton have been given a boost thanks to a funding announcement from the Canada Foundation for Innovation (CFI). UNB was awarded \$752,223 for projects led by John Hughes Clarke, Jason Addison, Michael Thomas and Stacey Reading.

Dr. Hughes Clarke, professor of geodesy and geomatics engineering, received \$396,415 toward his research in ocean mapping and Arctic operations. Dr. Addison, professor of biology, was given \$100,895 for his analysis of population genetic structure of marine invertebrates. \$234,588 will go towards a laboratory facility where Dr. Thomas, professor of civil engineering, will research sustainable concrete construction. Finally, Dr. Reading, professor of kinesiology, received \$20,325 for his research in the prevention, rehabilitation and treatment of vascular complications of diabetes mellitus.

"This contribution from CFI will help us continue to produce leading research for the province, country and beyond," said Greg Kealey, provost and vice-president research at UNB. "We look forward to continued collaboration with the federal and provincial governments to attract world-class researchers to our province."

"The investments at UNB will further enhance our country's reputation as a destination of choice for outstanding researchers," said Dr. Eliot Phillipson, president and CEO of the CFI. "They will make our universities even more competitive when it comes to attracting the best and brightest researchers from around the world."

The CFI continues to support cuttingedge research infrastructure that helps stimulate various sectors of the economy associated with such capital projects. It is estimated that every dollar invested directly in research yields more than \$7 in economic benefits, including spin-off jobs.

Complications slow construction schedule somewhat

COMPLETION BY YEAR'S END

While construction of the Richard J. CURRIE zations, NGOs and the private sector through innovative facilities such as: the Human Performance the past few months, the completion date has been moved to December 2010 to accommodate for unexpected rocky conditions on the site and a harsh winter in 2008-09.

Complete occupancy of the centre will be completed by May 2011, in time for the 2011 UNB Fredericton graduation ceremonies and the 80th Congress of the Humanities and Social Sciences, hosted by UNB and St. Thomas from May 28 to June 5, 2011. This annual congress is the largest academic gathering in Canada, attracting up to 9,000 scholars.

With the new completion date, UNB's basketball and volleyball teams will be housed in the CURRIE CENTER for the 2011-12 season. But if the building is ready for use early, the teams will certainly have the opportunity to finish their 2010-2011 season in the CURRIE CENTER.

The Richard J. CURRIE CENTER will be a 12,927-square-metre (139,145-square-foot), fivestorey building that will become a central part of Fredericton's skyline.

The CURRIE CENTER will enhance UNB's teaching, research and learning environment and serve as the anchor for the new Healthy Living Village, a wellness initiative that includes UNB, healthcare organi-

Laboratory, the Sun Life Financial Fitness and Lifestyle Assessment Centre, the Quartermain Sport Medicine Centre, the Nancy Webster McFadyen Track, the Hatheway Family Fitness Studio, and the Alberta Alumni Recreation Centre.

It will be a health and wellness focal point that addresses some of our nation's most pressing health concerns. A multidisciplinary team of researchers and partners will focus their efforts on fitness and lifestyle assessment and evaluation, pediatric weight management, cardiac rehabilitation, orthopaedic surgery rehabilitation, clinical gait analysis and enhancement, workplace wellness, healthy aging and more.

Strategic planning process

Alumni respond to survey

The UNB Strategic Planning steering committee extends I its thanks for the significant alumni response to its webbased survey last fall.

More than 54,000 people were invited to participate in the survey and in only a few weeks nearly 5,500 responses were received. Of those, alumni accounted for 2,634 responses, which is 48.5 per cent of all participants. The majority of the remaining responses were received from faculty (7.3 per cent), staff (10.2 per cent) and students (29.9 per cent).

After the survey, white papers on nine key topics (see winter edition of UNB Alumni News) were written over the winter, and posted on the strategic plan website (see URL below) for review and comment. The white papers are expected to be finalized this spring.

As well, the steering committee conducted an extensive round of external consultations over the winter with such groups as provincial NGO leaders; chambers of commerce and boards of trade; provincial MLAs, MPs and senators; educators; business and technology organizations across the province; CFB Gagetown; and Aboriginal community leaders.

The feedback from these sessions is being compiled into a "What We Heard" document that also will be posted on the website for review and comment.

University Commons soon to be under construction

\$25M fundraising drive underway

Construction of the new University Commons on the UNB Saint John campus is soon to be underway with significant infrastructure funding in place from three levels of government, as well as donations from the private sector and individuals.

The signature building will transform the entrance to Tucker Park.

"The Commons will be the first stand-alone building of its kind in the province," said Robert MacKinnon, vice-president UNB Saint John, during the project unveiling in February. "This has been a dream of ours for some time because we know it will be a place that will make our city and our region proud and one more reason for students and visitors to come to Saint John."

As UNB's first "green" building designed to conserve energy and resources such as grey water, it will be certified with a Leadership in Energy and Environment Design (LEED) targetting a rating of silver. A library of the future, it will contain a number of support services including the Student Technology Centre, the Writing Centre, the Math and Stats Tutoring Centre, and the Commons Café. Visitors will find treasures including the university's science fiction and fantasy collection, artworks from around the world and areas that can be transformed in minutes from seating spaces to guest lecture halls and back again.

Governments step up to the plate

The announcement coincided with the launch of a \$25-million fundraising campaign that will complete the project. As of the launch date, the campaign has already raised just over \$20 million, including pledges from all three levels of government: \$8 million under the Government of Canada's Knowledge Infrastructure Program, \$10 million from the Province of New Brunswick, as well as \$2 million from the City of Saint John. Additional funding has also been received from the towns of Quispamsis and Hampton, the Village of St. Martins, alumni, faculty, staff, corporations and friends.

The Knowledge Infrastructure Program is a two-year, \$2 billion economic investment to upgrade research and training facilities at Canada's colleges, universities and CEGEPs. It



is part of the \$12 billion in new infrastructure investments allocated under Canada's Economic Action Plan.

"A strong commitment to post-secondary education in our region has brought us to 80 per cent of our fundraising goal, in large part due to government support," said UNB President Eddy Campbell. "History has shown us that Saint Johners have always supported the development of their university and I am confident that this generosity and support will continue."

The University Commons campaign has raised \$20,400,000 to date, including generous gifts from two major donors, PotashCorp and Keith and Elizabeth Chapman.

"The people of New Brunswick have been very supportive of UNB's mandate and, most recently, of its growing health agenda that is welcoming partners like Dalhousie University Medicine New Brunswick and the New Brunswick Community College's health programs to campus,"said campaign co-chair Mary Ann Ketchum, who is leading the campaign with her husband and business partner, Don Ketchum. "This remarkable building will support all of the students and professionals who will be sharing our campus in the Eddy Campbell very near future and will be available to the broader community, ultimately contributing to Greater Saint John's aspirations for growth."

Medical school taking shape

Renovations to the Saint John College Building, the new home of Dalhousie Medicine New Brunswick (DMNB), which will see the establishment of a medical education program on the Saint John campus, will be finished in early May 2010.

This Phase I part of the project will house the classrooms, the state-of-the-art, high-definition video conferencing technology, and administrative offices for the medical program.

Phase II of the project (see artist's conception), the addition to the college building, involves the construction of the research labs for faculty and students. The medical school will include a comprehensive research program. The addition will be completed in 2011.

DMNB gives New Brunswick students the opportunity to attend medical school in their home province. It's a program of Dalhousie Medical School, offered in partnership with the Government of New Brunswick and UNB Saint John.

The program will admit 30 students from New Brunswick each year. Initially, in years one and two, all lectures will be delivered from Halifax by video conferencing to New Brunswick classrooms using full motion video conferencing.

In their final two years, DMNB students will complete their clerkships in Moncton, Fredericton, Miramichi, and Saint John.

To ensure that students located in New Brunswick have the opportunity to develop medical research experience, DMNB will hire four basic-science researchers over the next four years. Teaching labs for anatomy, histology, and microbiology will be located in the Saint John Regional Hospital, providing unique learning opportunities. Over the next two years, additional teaching facilities will be constructed in Moncton, Fredericton, Miramichi.

Patrick Beamish (BA'08-SJ)

Presidential politics

Patrick Beamish went from being a UNB Saint John student council president to being a part of a U.S. presidential election.

Beamish, a 2008 bachelor of arts (political science) graduate of UNB

Saint John, participated as an exit poller in Massachusetts during the historic November 2008 election of Barack Obama.

"I remember heading to Roxbury — one of the less influential areas of Boston — and seeing three to four thousand people lining up to vote at 6:15 in the morning," says Beamish.

"You could feel that something was going to dramatically change in America's history as most of the people leaving, even though they had waited hours to vote, were excited."

Beamish was in the U.S. pursuing his master's degree in political science at Suffolk University in Boston.

Putting the science in political science

While studying at Suffolk, Beamish started working for the university's Political Science Research Centre, an independent body that conducts political and corporate election polling.

Beamish now works as the managing director, North America, for DAPA Research, a political polling firm based in Boston.

Polling is typically conducted before an election and requires asking a specific group of people targeted questions and then using the information to forecast how a candidate ranks in the public eye.

This information can assist an election campaign by telling them what messages a candidate needs to get across in ads, speeches and commercials.

"The scientific aspect of polling is what interests me," says Beamish. "With the right questions cross tabulated with another set of questions you can learn a lot."

"It tells the campaign team what messages need to be part of every portion of the campaign."

Polls, he said, are an invaluable part of modern political campaigns. "It tells the campaign team what messages need to be part of every portion of the campaign. In the political world, politicians and advisers often assume that the campaign is going well and it is tough to take a step back and realize that the message or the strategy needs to change. A strong pollster can provide that objective view that sets a campaign on the right track."

Learning inside and outside the classroom

While at UNB Saint John, Beamish had the opportunity to work closely with his professors and participate in local politics by working part-time with the mayor's office.

Watching then-mayor of Saint John Norm McFarlane work was fascinating, says Beamish.

"He had such a passion for moving Saint John ahead that it gave me an appreciation of working hard in order to get things done."

While at UNB Saint John, Beamish also had the opportunity to work with experts in political science.

"The most impressive aspect of the political science department at UNBSJ is the fact that many professors do much more than teach theoretical principles. Many are involved in actual practical political endeavours and they encourage their students to do the same."



As of press time for this edition of *UNB Alumni News*, 4,200 survey responses had been received, a return rate of approximately 14 per cent of the number of alumni asked to participate. A great response for a project of this type considering that the average return rate for similar projects in Canada is 10 per cent.

The purpose of the survey is to establish the level of engagement UNB alumni have with their *alma mater* and the Associated Alumni. We will be using both individual and summary data to improve our programs to serve you better.

While this is the third major survey the association has conducted in the past six years, this one introduces an ongoing procedure in terms of assessing our effectiveness.

Survey will allow institutional comparisons

The association has partnered with a national firm specializing in alumni relations at institutions across the county. In addition to UNB-specific questions, our latest survey contained core questions that also are asked in surveys conducted at other Canadian universities.

This will enable us to conduct assessments of our effectiveness not only within UNB, but also in terms of how we stack up against other institutions of similar size and makeup.

Follow-up surveys now will be conducted regularly in approximately two-year time frames to provide comparisons with the benchmarks established by this year's survey.

Robb Parker, executive director of the Associated Alumni, said the information collected through the surveys will provide valuable guidance in terms of what we do and how we do it.

"The feedback generated and the level of participation in this project has been tremendous," Parker said. "Our main goal was to gain a benchmark of how engaged our alumni are with respect to certain key areas and in particular how we compare with other similar institutions. This will then allow us to enhance those areas where we are doing really well and add relevant programs where they are most wanted by our constituents."



Richard Winter (BSc'63)

Alumnus creates scholarship to honour wife, help students

At five years old, Dr. Richard Winter (BSc'53) sold *The Daily Gleaner* on a downtown Fredericton route.

"I was in charge of Queen Street back to Charlotte, from Regent to Westmorland."

At 12, he washed dishes at Tart's hot dog stand near the Armouries.

"I had to stand on a box to reach the sink."

At 26, he was picked up in a tractor by a man whose wife was about to give birth at home near Port Elgin, N.B.

"I was the only doctor in town. I even took out the odd tooth."

There's no question Dr. Winter has a strong work ethic and a wealth of good stories. During his medical career, he was chief of obstetrics and gynaecology at the Royal Alexandra Hospital in Edmonton and clinical professor at the University of Alberta for 30 years. He served as presi-

dent of the Alberta Medical Association, president of the Society of Obstetricians and Gynaecologists of Canada, and as a board member of the Canadian Medical Association.

But Dr. Winter wasn't alone in his hard work. In his third year of medical school, he married Lynne Lordly, an emergency room nurse at the Victoria General Hospital in Halifax. After their first child was born, Mrs. Winter worked 11 p.m. to 7 a.m., arriving home just in time for her

husband to go to the hospital to train.

"Nobody put their baby in day care in those days and there was no maternity leave," explained Dr. Winter. "She put me through medical school. She was a great wife and an excellent mother."

Lynne Winter passed away in 2007. To honour her, Dr. Winter has established the Dr. Richard and Lynne Winter Scholarship with a gift of \$100,000. The award will benefit UNB students intending to go to medical school on the UNB Saint John campus, the city where Dr. Winter interned at the start of his career.

Because he was only able to attend UNB thanks to a Beaverbrook Scholarship, Dr. Winter knows the difference donor support makes.



Steve Weagle (BSc'91) Broadcasting success

Steve Weagle wouldn't have guessed while he was at UNB that 15 years later he would be one of the most-watched weather broadcasters in Florida

The 1991 bachelor of science graduate first considered astronomy, but turned to meteorology after he finished his degree at UNB Fredericton. Once he finished his studies elsewhere, he began doing meteorological research.

He worked for public and private weather services before turning to Halifax-based ATV to try out as a weather broadcaster. Admittedly, says Weagle, he didn't think at first that he was the type of meteorologist to work on television.

"I wasn't really the TV type," he says. "I was a science nerd."

That didn't stop him — after weeks of practice and numerous auditions — Weagle became a weather broadcaster for ATV, a position he held for close to five years.

A forecast for sun

In 1998, Weagle wanted to escape the cold and try a new challenge, and soon found himself as the chief meteorologist at WPTV in West Palm Beach, Fla., the most-watched television station in the state.

The station is a meteorologist's dream — it boasts its own Doppler radar among its millions of dollars of weather equipment.

"It's a huge weather market, because you have so many hurricanes here." he says.

Weagle's reputation as a weather broadcaster grew immensely in 2004, when he was on the scene for a devastating hurricane season.

"When hurricanes hit down here, everyone watches. You have to watch, because it's really life and death."

He also credits his success to his passion for the weather.

"You have to have a passion for it that shows, so that the interest that you have in it comes across to the viewers and then they immediately have an interest in it," Weagle explains.

Engaging an audience

Weagle, whose parents live in Fredericton, still pays the UNB Fredericton campus a visit whenever he's in town. He fondly remembers his time at university, including his days as a resident of Mackenzie House — the first year it was a co-ed residence. He and his wife Karen were married in the Chapel of Sir Howard Douglas Hall (Old Arts Building) in 1992, and their son Jordan is a student at UNB Fredericton.

He studied physics and math at UNB, and says the characteristics of a good weather broadcaster were also espoused by his favourite professors.

"The two things that make you successful is a warm personality and an interest in the subject — I had a some really good professors at UNB who had that, and they got that passion across. Then you become interested in the subjects that you're taking."

VARSITY REDS MAKING AN IMPACT

s varsity athletes, the members of the UNB AVarsity Reds are most known for their actions on the field of play; the game winning shots, the highlight reel goals, and the spectacular saves. However, just as important as what happens on the 10th year, is designed for students in Grades 4 and field is the work the Reds do off of it in the community and in the classroom.

exploits of the Varsity Reds is well deserved, more important is what these student-athletes are accomplishing academically. Currently, 96 per cent of all Varsity Reds athletes graduate with a UNB degree.

Not only do they graduate, but in all of Atlantic University Sport (AUS), UNB has produced the most

Academic All-Canadians this decade, averaging 52 per year over the past four years. To be an Academic All-Canadian is no small feat; it is reserved for students who achieve a GPA of 3.5 (more than 80 per cent).

In addition to the work the Varsity Reds put in on the field and in their academic careers, they're active in the community as

"As a coach and now an athletic director I've always subscribed to the vision that there

is nothing special about winning in the sports arena if you're not winning outside of it," said Kevin Dickie, UNB Fredericton director of athletics. "We're extremely proud of what our student-athletes are accomplishing in the classroom and continue to be tremendously impressed with what they do in our community, for the youth in our community, and to enhance the esprit de corps of our community and alumni."

programs are the Heads Up with the Reds and the Read with the Reds programs that were created in conjunction with School District 18.

The Heads Up with the Reds program, now in its 5, and is based around the REDS acronym. Each letter represents a concept (Respect, Esteem, Although the recognition given to the athletic Dedication, Strategy) and athletes attend schools in teams of two explaining how the concepts fit into their lives and their importance.

> Jacob Kilpatrick, fifth-year volleyball player and President of the Athletes' Council, helps co-ordinate the program with District 18 and thinks it is an integral part of being a varsity athlete.

> "I think it's really important to let kids know, and be visible to kids in the community, that there's someone to look up to," said Kilpatrick. "I know a lot of kids look up to professional athletes and we can just kind of show them that we're kind of like local professional athletes."

> Read with the Reds is in its fifth year and is for students in kindergarten. It features a member of the Varsity Reds reading a story written specifically for the program, SU and RED Become Junior Reds, and each student takes home a copy of the book.

> Both programs are administered with the aid of the district's physical education mentors, particularly Garth Wade, who helped set up the programs and wrote the text for the children's book.

> Wade co-ordinates the programs along with the Athletes Council and thinks that both the Heads Up and Read programs have a "major impact" on the students in District 18.

> "From a role model perspective, having studentathletes from our local university interact with our young kids, it gives messages to our kids to aspire to go to university and be an athlete. It also promotes the messages of healthy eating and being physically

Think pink for cancer

n any other weekend of games hosted by the V-Reds, an abundance of Othe colour pink would have meant a problem with the washing machine. However, it was Think Pink Weekend at the LB Gym in February, and all of the pink apparel was in support of breast cancer research.

As part of the nation-wide Shoot for the Cure campaign, the Varsity Reds hosted a weekend of events designed to raise awareness and funding for the Canadian Breast Cancer Foundation.

Featuring three full days of volleyball and basketball games with the Cape Breton Capers, Dalhousie Tigers, and St. Mary's Huskies, UNB women's volleyball and basketball players raffled off a number of pink items and raised \$4,024.76, surpassing the goal of \$4,000 for the weekend.

"One of the main goals of these events is to raise money for the Canadian Breast Cancer Foundation and to raise awareness for the fight against breast cancer so I think we were very successful on both accounts," said women's basketball head coach Jeff Speedy.

Along with the money raised by the raffles, members of the Varsity Reds staff and fans pledged money for UNB service ace or 3-point basket made during the weekend, raising more than \$400.

"I thought it was special," said women's volleyball head coach John Richard. "I thought our student athletes were extremely excited to take part. They worked all weekend and we hit our fundraising goals."

Now in its third season the Shoot for the Cure campaign, chaired by coach Speedy and organized by the CIS Women's Basketball Coaches Association, aims to raise over \$100,000 this year after raising over \$142,000 during the first two seasons of the initiative.

Two more teams join Bombers in AFL

 $T^{\text{he UNB Red Bombers club football team will be}}_{\text{competing this fall in an expanded Atlantic}}$ Football League (AFL).

During the league's annual general meeting in March, it was announced teams based at Holland College in Charlottetown and Dalhousie University in Halifax would join the AFL for the 2010 season.



They will compete against the three original AFL teams from last fall the Red Bombers, the Seawolves based at UNB Saint John, and the Moncton Jr. Raiders.

Last year, the AFL had a regular season schedule of four games, followed by the championship game, which the Red Bombers won by a 3-1 score over the Seawolves.

With the addition of the two new teams this year, the regular season schedule may be expanded to six games, though that is still under discussion.

UNB wrestlers capture four medals at CIS

Tones House, home to thousands of students for nearly 50 years, now has a new role in serving the needs of all those attending UNB's Fredericton campus.

In February, UNB celebrated the rededication of Jones House and the official opening of the C.C. Jones Student Services Centre. After extensive renovations and upgrades, the building is now the central location for student services on campus.

"As a university, we are committed to providing a quality learning environment that will enable our students to achieve their academic and personal goals," said UNB President Eddy Campbell. "This new centre brings the majority of student services together under one roof and enhances our ability to meet students' needs."

The centre houses a modern Student Health Centre on the third floor; Counselling Services on the second; and the Office of Student Affairs and Services and Jones House itself in the lobby of the new centre. and Financial Aid on

the ground floor.

Relations Office is also located in the building. Moving

this office next to the International Student Advisor's office brings together all international services and programs for students.

One of the key features of the building is its accessibility. The very first phase of the renovation was the installation of an elevator.

"It's wonderful to see current students stop to view and read the panel and know that that part of UNB's history is being preserved," said Anne Forrestall, executive director of student affairs and services. "Their comments on the building have future." been so positive and appreciative. The new space really has made a difference."

Renovations to Jones House began two years ago and cost just under \$5 million. The majority of the funding came from the Province of New Brunswick. Thanks to the province's Alterations and Renovations Grant, University Deferred Maintenance Program and the University Infrastructure Improvement Program, the provincial government has contributed more than \$3 million to this project. The remainder of the funding was covered by UNB, \$1.2 million of which came from


