



## UNB libraries system steps up to plate for alumni

Recognizing that learning is a lifelong process, the UNB Libraries system has stepped in to make sure you have more resources to stay on that curve.

It's a commendable initiative, and we hope many of you will take advantage of what's being offered.

Effective Jan. 1, free library cards, renewable each year, were made available to alumni living in New Brunswick. The cards may be applied for and picked up at the circulation desks at the Harriet Irving Library (HIL) on the Fredericton campus, and the Ward Chipman Library on the Saint John campus.

As well, alumni living anywhere in the world now have access to two online library databases — Academic Search Alumni Edition and Business Source Alumni Edition, both offering full-text or abstracts from thousands of sources. The databases are secure sites, and will require alumni to claim a password, using their alumni ID number, if they haven't already done so to access the alumni Online

Directory or EFL sites. Visit either alumni.unb.ca/services or alumni.unb.ca/e-services for further information on the library cards or online databases.

The Associated Alumni extends its thanks and deep appreciate to UNB Libraries Director (Fredericton) John Teskey and the staff at both the HIL and Ward Chipman Library for putting in place this valuable alumni service.

## Samuel Cunard: Nova Scotia's Master of the North Atlantic

The name Cunard is synonymous worldwide with luxurious ocean travel. This book tells the story of Samuel Cunard, who established the world's first transatlantic steamship line. Born in Halifax in 1787, even as a boy Cunard showed an early bent for making money. He became a leading citizen in his homeport city and had his finger in many pies, including a seat on the unelected council that ran the colony, as well as vast timber holdings in New Brunswick's Miramichi region and extensive farmland on Prince Edward Island. Once realized the potential of steamships, he invested in a service between Halifax and Quebec, with stops on the Miramichi and at Pictou. He went on to establish the first regular and reliable service between Britain, Halifax and Boston in 1840. But his business ambitions had forced him to leave Nova Scotia and move to Britain to find the investors, shipbuilders, government support and customers he needed to launch his new line. After his death in 1865, Cunard's family continued their involvement in the business for several decades and the Cunard Line remained pre-eminent among the world's passenger lines. This book is a long-overdue account of a brilliant and determined man who single-handedly revolutionized world transportation and communication.

Treatments using applications of heat and cold have been around for millennia, but there are few introductory level text-

books that the manual therapist can trust to provide accurate, current information about their use. An Introduction to Heat & Cold as Therapy begins with an explanation of the physiological effects of hot, cold and contrast treatments and the rationales for their usage as therapeutic modalities. It then provides general treatment guidelines, as well as a discussion of contradictions and cautions related to temperature therapy treatment planning. The remainder of the book is dedicated to presenting detailed, fully illustrated descriptions of how to make available a large number of temperature treatments in clinical practice and as home care recommendations. An Introduction to Heat & Cold as Therapy is a long-awaited text that meets the needs of students and practitioners alike.

#### Roots, Wings and Other Things: A Mother's True Story On Transracial Adoptions

Roots, Wings and Other Things is a chronicle of Donna Gillis Spalding's "unplanned" transracial family, which started off in the usual way (with the birth of their first and only biological child), and grew, through numerous adoptions, to the unusually large number of eight children. Her and her husband's children are black, aboriginal, Chinese, French Acadian, white and mixed race. She and her husband were among the first people in Canada to raise an interracial family, because transracial adoption was not permitted in Canada until the 1970s. Even now, there is very little Canadian research on transracial adoptions and whether they've been successful, but this book begins to fill that gap by providing "anecdotal" evidence (literally) that transracial families "work." One of her reasons for writing this manuscript is to show readers just how interesting, funny, and loving such families can be. The book isn't intended to be didactic - it's simply the story of a nontraditional family and it endeavours to demonstrate that families don't have to be white, middle class, and consist of a couple with two kids to be normal, that adoption is good for children and parents alike, and that family is more important than race or

In his second collection of poetry, Steve McOrmond distills the fleeting beauties and lingering pains of daily life into darkly elegant, elegiac poems. Moving from rural to urban settings, considering the stars, music and the inanimate objects with which we share our lives, McOrmond subtly examines concepts of home, loneliness, belonging and worth. With graceful lines he creates startling images and metaphors, where crows are "tuneless/as 10,000 cigarettes" and a young deaf couple can "hardly pay attention to what their hands are saying." McOrmond's poems have been published internationally in literary magazines and online at Maisonneuve, nthposition (UK) and Jacket (Australia). His work also appears in the anthology Breathing Fire 2: Canada's New Poets (Nightwood 2004). His first book of poetry, Lean Days (Wolsak and Wynn 2004), was shortlisted for the Gerald Lampert Award.

These rings are then strategically scattered in high-profile areas. Then posters are placed near the drop site, and arrangements are made for an advertisement to be placed in the local newspaper. The work is based on happenstance - the off chance a person finds one of the placed rings. Individuals must find not only the ring, but also notice one of the posters/ads containing details of the lost ring. #### The Prize of Learning Love: The Life of Margaret Fawcett Norrie, Nova Scotia's First Woman Senator

Margaret Fawcett was a 27-year-old assistant instructor in biology and assistant dean of

women at Mount Allison University in Sackville, N.B., when one of the girls under her supervision invited her to go to the gold fields of Quebec in the summer of 1933. Little did Margaret know that she would meet the love of her life there, for the girl who invited her was Pauline Norrie, daughter of mining engineer J.P. Norrie. Theirs was a whirlwind courtship that ended in a marriage that lasted 12 years, until Norrie's death. Now Margaret had four children to raise on her own, and a new life to carve out for herself in Truro, N.S. This new life would see her take several roles: mother, dairy farmer and politician. It would see her reach the Canadian Senate as N.S.'s first female senator, and only the fifth female senator in Canada. The Prize of Learning Love is the story of this remarkable woman, whose roots were deep in the soil of N.B., who faced adversity with stoicism, and who understood the human heart.

#### A Deeper Sea

A Deeper Sea is a beautiful fable about a man who has opened locked gates without a key, but can't remember how he did it. Yvonne Wilson's 10th novel is another on her favourite theme: survival of the individual in isolation. remote communities, harsh climates, social solitude. Hano is the only child of the only policeman on Rangiora's Reef. He is also the only child whose first language is English and who is not one of Father Jean's flock. Hano needs another boy, and when he is five, the "Children of the Sea" — a deeper sea than ours - make tentative first contact. Hano tells his foster mother, "His name is Star, and he's my brother." Hano's story unfolds in four parts: childhood on Rangiora's Reef, setting based on Akaroa, an isolated town near Christchurch, New Zealand; success in maturity, setting based on an N.B. village the author knew well as a child; in love, with a girl half his age, in a hot desert setting; and old age, trapped in a jungle. Hano survives, rises to high honour, and remembers at last what freedom is and how to achieve it.

## Nursing professor named nation's top young researcher

Nicole Letourneau, a professor of nursing at UNB Fredericton and a UNB alumna, has been named Canada's Premier Young Researcher by the Canadian Institutes of Health Research (CIHR).

"This is a truly remarkable achievement," said Greg Kealey, UNB's vice-president (research). "Nicole's deserved recognition reflects well on UNB's health and wellness research agenda, on the faculty of nursing, the Muriel McQueen Fergusson Centre for Family

Fergusson Centre for Family Violence Research, and the Canadian Research Institute for Social Policy at UNB."

The Peter Lougheed/CIHR New Investigator Award, cofunded by the Peter Lougheed Medical Research Foundation, is CIHR's most important career development award. It is given only to Canada's brightest young researchers at the beginning of their careers.

"This five-year, \$500,000 award represents an important incentive for young researchers, such as Dr. Letourneau, to pursue their work in Canada," said CIHR President Alan Bernstein.

"It is a great honour to be able to bring this award to my home province of New Brunswick," said Dr. Letourneau. "This award allows me to utilize and build on the tremendous capacity and excellence of New Brunswickers. I will be able to attract and support talented students to do research in child development. It will also provide more resources to work with our community partners in promoting the best start for kids."

Dr. Letourneau's research focuses on the link between early care-giving experiences and children's development. She designs and tests interventions to promote the healthy development of vulnerable children, particularly those who are exposed to domestic violence or whose mothers suffer from depression. Her findings will help policy-makers and social-program-delivery organizations to implement effective interventions that will allow children to overcome a poor start in life and help to create healthy adults.

A 1991 UNB nursing graduate, Dr. Letourneau earned master's and doctoral degrees in nursing from the University of Alberta. In 2003, she received the Outstanding New Investigator in Research Award from the Canadian Association for Nursing Research and the Alumni Horizon Award for early achievement from the University of Alberta and was invited to be a New Investigator of the Canadian Institute for Advanced Research.

A member of the CIHR's Institute of Gender and Health Advisory Board, Dr. Letourneau has received a Harrison McCain Young Scholars Award for 2006-07. She will also take up the Canada Research Chair in Healthy Child Development at UNBF on June 1, 2007.

#### Two honoured for teaching

Two professors, one from the Saint John campus and the other from the Fredericton campus, were recognized at the fall Convocations for their teaching abilities.

Dr. Sandra Bell of the Saint John campus and Philip Sexsmith of the Fredericton campus were awarded the Allan P. Stuart Award for Excellence in Teaching during the fall graduation ceremonies on their campuses.

Dr. Bell, assistant professor in the faculty of arts, department of humanities and languages, has an honours BA and an MA from McMaster University, and a PhD from Queen's University. Her research focuses on the literature and court culture of James VI of Scotland (James I of England), and the connections of poetry, politics and power. She has published articles on various aspects of the Scottish renaissance, and her next project is a book-length study of the writings and cultural policies of James VI/I. Dr. Bell is the majors coordinator for the English program.

A faculty associate in UNBF's faculty of education, Prof. Sexsmith spent the early part of his teaching life in public school. He inspired middle-and high-school students to reach academic, musical and dramatic heights they didn't know were within their grasp. "His students mention how much attention Philip pays to his teaching," said Marian Small, former dean of education. "He is constantly trying new approaches, always telling them why he is trying those approaches, and consistently asking for feedback." Prof. Sexsmith was nominated for the award by one of his students.

The Allan P. Stuart Award for Excellence in Teaching recognizes outstanding teaching on the basis of nominations from students and faculty members at UNB. It is named in honour of Allan P. Stuart, a respected UNB professor of chemistry from 1946 to 1973 and one of the first recipients of an excellence in teaching award at the university.

#### New dean of nursing in Fredericton

**J**anice Thompson is the new dean of nursing on the Fredericton campus, succeeding Cheryl Gibson, who had served as dean since 1999.

Dr. Thompson came to UNB from the University of Southern Maine in Portland, where she was a professor of nursing and director of the University Honors Program.

Dr. Thompson received her bachelor of science degree in nursing from the University of Iowa. She obtained a doctoral degree in nursing from the University of Utah.

She has authored numerous articles, contributed chapters in several academic books, served as principal investigator or project director on several funded grants, supervised undergraduate, interdisciplinary thesis students, and mentored masters and doctoral students in nursing.

Dr. Thompson's teaching interests include interdisciplinary course development within the framework of community based action research. Her research has ranged from work in critical social theory to the examination of postcolonial commitments in transcultural nursing.

## Mi'kmaq, UNB partner up for archeological research

An historic agreement will advance knowledge of the oldest inhabited village in New Brunswick, Metepenagiag. This First Nation community is located at the confluence of the Northwest and the Little Southwest Miramichi rivers in northeastern New Brunswick.

Metepenagiag Mi'kmaq Nation and Metepenagiag Heritage Park Inc. signed a memorandum of understanding with UNB in November.

"This is the first time in Atlantic Canada, and possibly in the country, that a First Nation community has signed an agreement with an academic institution," said Madeline Augustine, presi-

dent of the Metepenagiag Heritage Park Inc. "What really excites me about the partnership is how traditional knowledge and the western science of archeology are coming together."

The preliminary goal of the partnership is to further research on some of the most significant archeological sites in Eastern Canada: the Augustine Mound and Oxbow National Historic Sites. These sites, which are the centrepieces of a proposed heritage park, are exceptional sources of information about ancient Mi'kmaq people and their customs.

"Over 30 years ago, my grandfather, the late Joseph Augustine, rediscovered these two very sacred and important heritage sites in our community," said Noah Augustine, chief

of the Metepenagiag Mi'kmaq Nation. "He knew of these sites from stories passed down to him from his grandfather. He recognized immediately the need to involve others, to find likeminded partners who shared an interest in the protection, preservation and presentation of Mi'kmaq cultural resources and heritage in New Brunswick."

Under the agreement, UNB anthropologist Susan Blair will work with the Metepenagiag community to continue their research on the archeological heritage of the Metepenagiag Mi'kmaq Nation.

"I know our Elders are proud to see the work that they have contributed to the project from the beginning take another step forward," said Ms. Augustine.

Community members and UNB graduate and undergraduate students will be involved in the research, and the university's archeology lab in Fredericton will be upgraded to support the project.

"I believe the roots of a strong institution lie in its community," said UNB President John McLaughlin. "Metepenagiag's willingness to allow us to share their principles of protection, preservation and presentation is a precious and important indication of their confidence in us. We look forward to a very productive partnership to which each of us can contribute and from which each of us can benefit."

## UNB expertise available to private sector

Private-sector companies can now receive technical assistance from experts at UNB, thanks to a recent agreement with the National Research Council Industrial Research Assistance Program (NRC-IRAP).

"This new service allows a small-to medium-sized Canadian firm to access the expertise available at UNB Fredericton and UNB Saint John," said Elliott Keizer, the university's director of industry-government services. "If a company needs technical help to solve an engineering problem, for example, they can contact us. We'll review the project in conjunction with NRC-IRAP advisers, then we'll find someone who can assist them."

Although the program is in its infancy at UNB, nine firms have been matched with UNB experts.

"In one case, a professor of electrical and computer engineering was called

in to find the source of electrical interference that was affecting a firm's computers and phone lines," said Mr. Keizer. "Another involved figuring out a way to clean a used fluid which had additives that were fouling equipment."

The service is intended for instances where the provision of a small amount of expertise in science, computer science or engineering — over a few days — will be sufficient to solve a problem or advance an opportunity. In addition to on-site trouble shooting, technical assistance could include activities such as selecting equipment, assessing a new product concept, conducting a technology search and review, providing technical training or giving ad-hoc advice.

## Student investors top \$2 million

NB Fredericton's Student Investment Fund (SIF) is continuing to set records. In October, the fund topped \$2 million, doubling what it started with eight years ago.

The SIF program was launched in 1998 with a \$1-million contribution from the N.B. Investment Management Corp. The money allows students in the program to experience real investing, in real-time, in the capital markets.

The fund's growth is due exclusively to investment performance. No new funding has been acquired.

"The student investment success showcases the high-quality students who are accepted into this rigorous experiential learning program," said Glenn Cleland, program founder and director of UNBF's Centre for Financial Studies. "The students are responsible for adding value to the portfolio."

This financial milestone is the most recent in a series of successes for the program. In 2003, UNB became the first Canadian university to win an investment category and placed second overall in the Redefining Investment Strategy Education (RISE) symposium, a global competition for student-managed funds. The following year, UNBF, with a new cohort of SIF students, continued to outperform larger schools with a first-place ranking in the hybrid investment category at RISE.

Prof. Cleland said another performance measure of the program's achievements is the pass rate on the industry standard Chartered Financial Analyst (CFA) Level One exam.

SIF students have consistently outperformed global average pass rates on the uniform exam. They excelled at the June 2006 Level One exam, recording a 78 per cent pass rate compared to a global success rate of 40 per cent.

Feiber Omana, a 2006 BBA graduate, is the first SIF alumnus to be accepted into Harvard Business School. His deferred admission to Harvard until 2008 will allow him to gain meaningful experience as an analyst with the investment firm Peters & Co. Ltd. in Calgary.

He credits the SIF program with getting him started.

The SIF program's financial learning lab, the TSX Group boardroom, is set up to replicate a small investment firm. Sophisticated, leading-edge, industry-standard equipment, such as the Bloomberg professional dual monitor terminal, allow students access to current information to make informed investment decisions. Students work individually and in groups, learning group dynamics and collaborative team-building.

## Canadian Rivers Institute moves into its new labs

The Canadian Rivers Institute (CRI) on the UNB Saint John campus has moved into new state-of-the-art quarters.

The CRI was formally established in 2000 as a collaboration of researchers at UNB's Saint John and Fredericton campuses. Once established, the provision of adequate facilities was one of its highest priorities. The new 2-storey, \$4.9-million facility, which is located as an addition to the existing K.C. Irving Hall, contains both wet and dry labs as well as office space for researchers, technicians and graduate students.

The project was financed by the Atlantic Canada Opportunities Agency, the Province of New Brunswick, and a Canadian Foundation for Innovation Award. Construction of the facility began in early September 2005.

"We are thrilled to be able to open this facility, to offer this unique opportunity to graduate students and researchers to field test tools and approaches to assess impacts on our river ecosystems," said CRI Director Dr. Allen Curry. "This facility will benefit all New Brunswickers by providing a regional centre of excellence for identifying the causes of environmental problems and developing solutions to improve the sustainability of New Brunswick's rivers."

The CRI offers tremendous potential for teaching graduate students and training future professionals in the pure and applied scientific disciplines associated with river ecosystems. In Atlantic Canada, there is a great opportunity to develop educational curricula and research protocols related to the study of Canadian river environments because of the proximity to natural and altered basins. It is a goal of the CRI to develop courses from a uniquely Canadian perspective. The new tools and innovative assessment techniques developed in the modernized CRI labs will also benefit Atlantic consulting companies in growing their business

and exporting their services throughout Canada and international markets.

The mandate of the CRI is to carry out multi-disciplinary basic and applied research focusing on river ecosystems, including their land-water linkages, for the purposes of conservation and habitat restoration. The CRI has grown to include 13 fellows, 31 associates, 15 staff, and 58 graduate students.

## Harrison McCain Awards presented to faculty members

NB has present a lamost \$200,000 to faculty members as part of the first-ever Harrison McCain Faculty Awards. The awards will invest in new faculty, attract visiting faculty to

short-term appointments at UNB, and send faculty on visiting assignments that will benefit the university.

The Harrison McCain Foundation supports three awards. The Young Scholars Awards, valued at up to \$25,000 per year, are designed to provide special support to new or recently hired faculty members. The Visiting Professorships Awards are intended to bring to UNB exceptional expertise and new perspectives gained through visiting faculty members. The Visitorship Awards support UNB faculty who take

short-term appointments at other institutions. The visiting professorships and visitorship awards are valued at up to \$50,000 a year.

The Harrison McCain Young Scholars Award recipients for 2006-07 are: Paul Howe, associate professor of political science (F), for research on the political disengagement of young Canadians; Karen Kidd, assistant professor of biology (SJ), for research on emerging chemicals in New Brunswick waterways; Van Lantz, assistant professor of forestry and environmental management (F), for research on the economic impact analysis of climate change; Nicole Letourneau, associate professor of nursing (F), for research on salivary cortisol levels in mothers with post-partum depression; Carissima Mathen, assistant professor of law (F), for research on the theory and practice of Supreme Court Justice Louise Arbor; and Benedict Newling, associate professor of physics (F), for research on magnetic resonance imaging of highly turbulent flows.

The Harrison McCain Visiting Professorship Award recipients for 2006-07 are: **B.R. Jagirdar** from the Indian Institute of Science, **Gaspar Gonzalez-Sanson** from the University of Havana, and **Debbie Kralik** from the Royal District Nursing Service in Australia.

The Harrison McCain Visitorship Award recipients for 2006-07 are: **Bruce Balcolm**, professor of physics (F), for an appointment at Cambridge University; **Peter Bischoff**, professor of civil engineering (F), for an appointment at the University of New South Wales; and **Sandra Byers**, professor of psychology (F), for an appointment at New York University.

"This professional recognition and support will help some of our very best and brightest faculty take their ideas and turn them into something special, as Harrison himself did so effectively throughout a long and brilliant business career," said UNB President John McLaughlin. "These awards are an appropriate tribute to a special friend."

#### **ALUMNI AWARD OF HONOUR**

The UNB Associated Alumni's most prestigious award recognizes truly outstanding service and commitment to UNB and the Associated Alumni. This year's recipients are:

Gary Lawson (BBA'76, LLB'79) of Saint John, N.B., is a partner in the Saint John law firm of Lawson & Creamer, where he has practised since graduating from UNB Law School in 1979. Prior to attending law school, Gary received his business degree at UNB Saint John, where he was immersed in student activities. Gary currently co-chairs the nationally unique Business Community Anti-Poverty Initiative (BCAPI) in Saint John. This organization is a large group of senior business and

professional leaders working to fight poverty in the Saint John area. Over the years, besides his involvement with UNB and alumni affairs, Gary has also been active with such organizations as Hospice of Saint John, and Rocmaura Nursing Home, has served as president of the Saint John Board of Trade, and has contributed to his profession by teaching courses and giving seminars. Gary's law practice focuses on business law, as well as in the area of labour and employment law.

Jim Morell (BPE'67) of Fredericton has a long history of involvement with UNB, the Associated Alumni and his community. After a year of teaching and coaching immediately following his graduation from UNB, Jim joined the New Brunswick public service in

Richard J. Scott (BBA'74, LLB'76) of Fredericton, following in the footsteps of his parents, the late R. Gordon Scott, P.Eng. (BScEE'49) and the late Roberta M. Scott (Ex), enrolled at UNB in the fall of 1970. Having completed the first three years of the BBA

This award recognizes the significant contributions made by UNB alumni in their local communities and beyond, for which they have been recognized regionally, nationally, or internationally. This year's recipients are:



His work with various news media, first at CHSR and then at The Brunswickan, led him to jobs at the Telegraph Journal, CBC, and CFNB. He eventually worked in radio and television in Winnipeg, print in Toronto, and radio and television in N.B. Mike is a leader in the field of media literacy. As a teacher of media studies and journalism courses at Fredericton High, he involves his students in the media, often providing opportunities to work on UNB broadcasts. In March 2005, Mike was awarded The Prime Minister's

Award for Teaching Excellence, the highest acknowledgement a Canadian teacher can receive. Mike says he can trace his successes back to UNB coaches who encouraged him, and especially to people such as Don Nelson, Joyce Slipp and John Meagher.

Anne Marie McGrath (BEd'69, MEd'87) of Saint John, N.B., also studied at Université de Montréal and the University of Alberta after graduating from UNB. She taught at St. Joseph's School and was subsequently supervisor of elementary and junior high school education, assistant superintendent and retired as superintendent of schools in District 8 (Saint John). A recipient of the F. K. Stewart Fellowship in Educational Administration, she was a member of the Conference Board of Canada Quality Education Network and, through the British Council, examined education and business relationships in England. Anne Marie was a founder of the South End Day Care Centre, was on the board of the Saint John Boys' and Girls' Club, served on the Boards of Bruncor and NBTel, was a member of UNB Alumni Council, the UNB Board of Governors and the Saint John Senate.

Sally Richards (BA'71, BEd'75, MEd'84) of Nackawic, N.B., has had a long and distinguished career in education. Recently retired as the principal of George Street Middle School in Fredericton, Sally began her teaching career in 1972 in Quebec City. She returned to New Brunswick in 1975 to take a teaching position at Nackawic Junior High School, where she remained until 1994. In the fall of that year, she became vice-principal of Hartland High School. She was named principal of Hartland High in 1995, serving in that capacity until her move to George Street Middle School in 2000. Throughout her career, she has served on various school district and Department of Education committees, and has maintained a solid record of ongoing professional development. In 2006, Sally was named one of Canada's Outstanding Principals by The Learning Partnership and the Canadian Association of Principals.

Joyce Slipp (BPE'72, BA'74) of Fredericton has been with the UNB athletics program in one capacity or another since she began her undergraduate degree in 1968. She is a former student athlete in field hockey and basketball. Joyce was awarded the Colin B. Mackay Shield in 1974 as UNB's Female Athlete of the Year. From 1969 to 1976 Joyce was a member of the Canadian National Women's Basketball Team, and was captain of the Canadian Olympic basketball team for the 1976 Montreal Olympics. From 1977 to 1990 (with a brief hiatus in 1980-81), she was a lecturer in the faculty of physical education and recreation and head coach of either field hockey or basketball, and for several years coached both sports. In 1990 she took a break from UNB to become a sport consultant with the Province of New Brunswick, but returned to her love of coaching in 1995 and once again took up the reins as head basketball coach. She retired in June 2006.

#### YOUNG ALUMNI ACHIEVEMENT AWARD

This award recognizes those who received a bachelor's degree within the last 10 years or a graduate degree within the last five years. This year's recipients are:

Wayne Chamberlain (BCS'98) of Saint John, N.B., worked in the telecommunications field for two years after leaving UNB before helping found AnyWare Group. Appointed vice-president of sales for AnyWare Group in January 2003, Wayne is responsible for establishing and growing AnyWare Group's foreign operations. The AnyWare Group team has been developing and delivering technology and telecommunications solutions to public and private sector companies throughout the world since its inception. Wayne is an active outdoorsman committed to the young people of New Brunswick, dedicating two weeks per year to outdoor leadership camps for New Brunswick's high school students. The camps provide students a chance to rappel, kayak, climb and hike while learning to discover and expand their own limits. Wayne's other two major pastimes include adventure racing and ultimate frisbee.

Adrian Chan (PhD'02) of Ottawa received his PhD in electrical engineering from UNB in 2002. He has been an assistant professor with the department of systems and computer engineering at Carleton University in Ottawa since 2003. Adrian has more than 40 publications and has been recognized with a number of honors, including the Governor General's Gold Academic Medal (2003), Maclean's 25 Best and Brightest (2004), Ottawa Life Sciences Council Dr. Michael Smith Promising Scientist Award (2004), Ottawa Life Magazine 50 Top People in the Capital (2005), and the Carleton University Spirit Recognition Award (2006). Adrian serves as the Carleton University Shad Valley program director, the faculty representative for the Carleton University Engineers Without Borders chapter and the IEEE EMBS student club, and as a board member for the Carleton University Virtual Ventures program and Co-operators Community Advisor Panel.

Steve Mason (BSc'96) currently works with the Aga Khan Foundation as its regional program manager for East Africa, based in Nairobi, Kenya. Steve previously worked for the Foundation in Afghanistan, from 2004 and 2006. Prior to this, he held the post of executive

director of the United Nations Association in Canada, based in Ottawa. He has previously worked as a field worker with the UN High Commissioner for Refugees (UNHCR) in West Africa, as a consultant with Foreign Affairs Canada and as a researcher with Human Rights Internet and the N.B. Human Rights Commission. Steve has sat on the boards of directors of a variety of Canadian

non-profit organizations, including the Group of 78, World Inter-Action Mondiale and the Canadian Centre for Quality Education and Opportunity. His long-standing commitment to Amnesty International includes serving as a caseworker and trainer for its Refugee Network over a five-year period.

Steve Toner (BScCE'97) of Grand Falls, N.B., worked with his father at Timber Top Trusses Ltd. for a year after graduating from UNB before purchasing the business. He drastically changed the way the 23-year-old company did business by giving it a customer-based orientation. He also introduced lean thinking techniques in manufacturing, which resulted in productivity increases of more than 200 per cent. This translated to a yearly 40-per-cent increase in sales. Steve is serving the truss industry as the current president of the Canadian Wood Truss Association, past-president of the Atlantic Wood Truss Fabricators Assoc., a board member of the Truss Plate Institute of Canada (TPIC), and a member of the Association of Professional Engineers and Geoscientists of N.B. For his innovative and growing success story, Steve, at the age of 30, was awarded the Business Development Bank of Canada's (BDC) Young Entrepreneur Award for N.B. for 2005.

#### OUTREACH GROUP OF THE YEAR

The recipient group will have made significant contributions to UNB alumni, students, the university or the Associated Alumni during the previous year by holding events, demonstrating growth, and/ or undertaking new initiatives in support of these groups.

The UNB Club of Ottawa is the oldest chapter of North America's oldest English university. The chapter was founded in 1947, and has had a record of consistent activity for the ensuing 59 years. The chapter's first president was Thomas Foulkes Sr., and in his memory the chapter has awarded a scholarship to deserving Ottawa-area students since 1982. The club holds a send-off reception every year for freshmen on their way to UNB. This event, along with the dinner-dance, golf tournament and PUB night, are held every year, and are the cornerstones of the chapter's activities. As well, the chapter from time-to-time organizes special attractions such as UNB Nights at football and hockey games. The Ottawa Chapter also holds the distinction of having the most Alumni Award of Honour recipients - a total of eight among the UNB chapters. The Ottawa Chapter has energized and involved literally thousands of Ottawa-area alumni on behalf of the association and university during its long history.

## OUTREACH VOLUNTEER OF THE YEAR

The recipient has made a significant contribution to advancing the objectives of the Outreach Program, either by being a member of an outreach group or individually.

Bob Slipp (BPE'72) of Ottawa has been a

mainstay of the UNB Ottawa Chapter for more than a decade. In particular, Bob was one of the lead organizers of the annual Ottawa Chapter golf tournament from 1996 to 2005. He also served as chapter secretary-treasurer from 1998 to 2006, and assisted with

other activities in one of the association's most active chapters. Bob also has found time to give back to his local community, having served on the board of Kiwanis Club of Rideau (Ottawa), and as a Level II CSIA ski instructor and Level I Coach. Professionally, Bob has more than two decades of experience in the financial services and insurance sectors. He is currently a senior compensation policy analyst with the RCMP National Compensation Policy Centre in Ottawa.

#### HONORARY MEMBERSHIP

This honour will be conferred on any person who has rendered outstanding service to the association and UNB.

John Meagher of Fredericton was born in Montreal. In July 1957, he accepted an invitation from UNB President Colin B. Mackay to establish the Maritimes' first physical education degree program at UNB in Fredericton. He is proud to say that there is a UNB physical education graduate in almost every English-speaking secondary school in N.B., as well as on the faculties of all four N.B. universities and several community colleges, and at every university in Atlantic Canada. He was the executive assistant to UNB President John Anderson from 1972-76, and was chair of the management committee of UNB's successful capital campaign, The Third Century Fund, on behalf of President James Downey from 1980-84. Dr. Meagher also co-chaired the committee charged with designing and funding the Aitken University Centre and the G. Forbes Elliot Field House. He was responsible for the institution of the N.B. Winter Games, the N.B. Federation of Sport, Recreation & Physical Education, and the N.B. Sports Hall of Fame.

Don Nelson of Fredericton came to UNB in 1956 as head football and basketball coach. He served 11 years as football coach, 32 years as basketball coach and 33 years teaching in the faculty of physical education and kinesiology. In 1971 Don established the first UNB summer sports camp program and directed basketball and volleyball programs for 17 years. Following his retirement in 1991, the UNB Varsity Reds Alumni named two scholarships in his honour -The Don Nelson Merit Award and The Don Nelson Leadership Award. Don was enrolled in the N.B. Sports Hall of Fame in 2001 and in the City of Fredericton Sports Wall of Fame in 2002. Don and his wife Margie (Lewis) have served the university community in a number of ways and now are enjoying retirement with their three daughters and grandchildren.

## First annual gala supports new bursary

or an inaugural event, the smiles and laughter, the patter of voices, the applause all signalled a resounding success.

She was cited for her work on two highly successful fund-raising campaigns and in creating relationships with alumni and friends, resulting in some \$135 million contributed to UNB in the past two decades.

The Celebration Dinner also featured a keynote address by UNB Chancellor Richard Currie, and the

## About the UNB Donor Wall

**S**ince its inception in 1785, when citizens of New Brunswick petitioned government to establish an educational institution, the University of New Brunswick has benefited from the support and generosity of its alumni and friends. The UNB Donor Wall honours those who have made a lasting investment in our institution and who help sustain a tradition of excellence.

The Benefactor Society recognizes the university's most generous donors - individuals, families and organizations - who desire to help UNB remain one of the nation's outstanding universities. Members of the Benefactor Society represent a long tradition of giving and a legacy that includes new buildings, endowed chairs and professorships, and many undergraduate and graduate scholarships. The Benefactor Society recognizes cumulative, lifetime contributions of \$25,000 and above. Once a donor's cumulative giving to UNB exceeds \$25,000, lifetime membership is assured in one of the following cumulative gift societies.

#### Beaverbrook Society

Recognizing cumulative gifts of \$5 million or more, the Beaverbrook Society is named for UNB's great benefactor, Lord Beaverbrook. It recognizes those individuals and organizations whose generosity and influence, like that of Lord



Beaverbrook, have had a transforming effect on the university. A "wonderful catalyst" for change and development, UNB Chancellor Lord Beaverbrook began his significant contributions in the early 1920s and continued to give until his passing in 1964.

#### Foster Society

Recognizing cumulative gifts of \$1 million or more, the Foster Society is named for Kings County, N.B., native Sir George Foster. An educator, distinguished statesman and former acting prime minister of Canada, Sir George



Foster (BA1868) was a founder and supporter of UNB's first endowment in 1923. Today, this endowment continues to provide funding for undergraduate scholarships.

#### **Smith Society**

Recognizing cumulative gifts of \$500,000 to \$1,000,000, the Smith Society is named for Fredericton native Dr. J. Herbert Smith. Dr. Smith graduated from UNB's faculty of engineering in 1932 and went on to become a



successful business leader and president of Canadian General Electric. He remained an active and loyal supporter of the university throughout his lifetime and upon his death

left a generous bequest, establishing the Dr. J. Herbert Smith Chair in Technology Management and Entrepreneurship.

#### **Singer Society**


Recognizing cumulative gifts of \$250,000 to \$500,000, the Singer Society is named for Miss Ethel Singer who graduated from UNB with a BA in 1935 and earned an MA in 1938. She went on to become a teacher in



Moncton, and maintained close ties with UNB throughout her career. Her generosity and that of her family aided in the construction of Singer Hall, home of the faculty of business administration on the Fredericton campus.

#### **Mackay Society**

Recognizing cumulative gifts of \$100,000 to \$250,000, the Mackay Society is named for Rothesay native Dr. Colin B. Mackay. Dr. Mackay (BA'42) assumed the leadership of UNB in 1953, becoming the youngest



university president in Canada. Serving as president until 1969, he oversaw unprecedented development of the university, including the establishment of the Saint John campus. His bequest, the largest in the university's history, established endowed funds in support of students on our Saint John campus and the library in the faculty of law.

#### **Snodgrass Society**

Recognizing cumulative gifts of \$50,000 to \$100,000, the Snodgrass Society is named for Youngs Cove native Dr. Florence T. Snodgrass (BA'24). As chair of the department of psychology from 1951 to 1967, Dr. Snodgrass influ-



enced the development of the department and gave graciously of her time and money in support of the university. Her gifts to UNB include endowed prizes and scholarships, as well as a student loans program.

#### **Magee Society**

Recognizing cumulative gifts of \$25,000 to \$50,000, the Magee Society is named for Dr. Frederick Magee. A native of Port Elgin, Dr. Magee attended UNB in the early 1890s and was later awarded an honorary degree in



recognition of his support to the causes of health and education in New Brunswick and his many achievements in business and public service. Dr. Magee was a generous supporter of the university and his largesse helped establish the BBA program, as well as a substantial endowment to support student loans.

## Library cards, online databases now available to alumni

The UNB Libraries system has gra-L ciously extended certain of its services, including access to two online databases, to all UNB alumni.

Alumni who live in New Brunswick. or who have a seasonal address in New Brunswick, are now eligible to receive a free library card, renewable each year, for the Harriet Irving Library (HIL), the Science and Forestry Library, and the Engineering Library on the Fredericton campus, and the Ward Chipman Library on the Saint John campus. The cards also allow Fredericton-area residents access to the some of the services of the Law Library on the Fredericton campus, though certain restrictions apply and users should contact the Law Library for further information.

The alumni library cards may be obtained from the circulation desks at the HIL and the Ward Chipman Library.

As well, the library has extended to all alumni access to two online databases — Academic Search Alumni Edition and Business Source Alumni Edition, both designed for the research needs of the post-college professional.

Academic Search Alumni Edition offers information in nearly every area of academic study including biology, chemistry, engineering, physics, psychology, religion and theology, and more.

Business Source Alumni Edition includes publications in nearly every area of business including marketing, management, MIS, POM, accounting, finance, econometrics, economics and more.

For more information on the alumni library cards and databases, visit alumni.unb.ca/services to review the library's policies.

Access to the online databases is a secure service, and may require the user to register and claim a password online if he or she hasn't already done so through access to the alumni Online Directory or EFL services.

## **UNB Alumni Survey**

## How we've acted on *your* input

It's been two years since thousands of you told us what you think of your UNB experience and the job the UNB Associated Alumni has been doing.

And now you should know that we've acted on most of what you told us.

The vehicle for that opinion-gathering process was the 2004-05 Alumni Survey, during which 25,138 of you were invited to participate via hard-copy and e-mail, and 6,075 of you replied, a response rate of a phenomenal 24.2 per cent.

The far-ranging survey asked your opinions on matters ranging from the quality of your UNB experience as a student to your impressions of UNB today to how you rate the association's services.

The results were then analyzed by an Alumni Council team and broken down into the Key Result Areas (KRAs) in the associations' strategic plan, *Energized and Involved*, and further defined in terms of three specific areas of operational importance — outreach, affinity, and communications.

In April 2005, the Alumni Council approved a total of 29 recommendations emerging from the report. Most have been acted upon.

"In the past 18 months, since council approved the survey report, 25 of the 29 recommendations have been acted upon through changes in the operation of the Alumni Office," said Mark Hazlett, association executive director.

"For example, in terms of our strategic plan, all individual staff workplans have been re-worked to reflect staff activities as they relate to our six KRAs — pride and loyalty, advice, students and young alumni, advocacy, student and faculty recruitment, and fundraising," Mr. Hazlett said.

"We've also implemented steps to utilize the right levers when dealing with our alumni. We're strengthening the common bonds — the links between our alumni and UNB — by reshaping our programs and services. For example, we've moved more toward programs and services based on faculties or athletics or by campus of graduation.

"We're also recognizing our alumni's roots. Because 46 per cent of our membership lives in New Brunswick, we're increased our outreach activities in Fredericton and Saint John, and mounted new activities in Moncton and Dalhousie."

The association also has looked for ways to create the right opportunities for engaging alumni, thus increasing their connection to the university, Mr. Hazlett said. Expanded programs, services and benefits have been introduced through changes to the outreach, events, merchandising and affinity partners programs. And volunteer opportunities have been increased.

The association also is trying to ensure its communications and messaging is much more strategic and targeted. For example, the Alumni Office sent more than 150,000 e-mail notices to smaller, select groups of alumni in 2006 informing them of events specific to their area.

As well, the results of the 2004-05 survey, which contained many open-ended or comment sections that focused on questions about the respondent's overall UNB experience, were distributed institution-wide through presentations to the Board of Governors, deans, and other university groups.

The survey has proven so valuable that the associations is planning to do it again.

"We've received so much information from the last survey that is helping us do our job so much better that we're planning to conduct another survey later this year," Mr. Hazlett said. "I encourage all alumni to watch for our 2007 questionnaire and participate."

# Meeting the challenge face-to-face

UNB Fredericton was ahead of its time six years ago when it created the Office of Student Recruitment and Integrated Marketing and hired Susan Mesheau as its director. This initiative established UNB as one of the first universities to recognize and respond to the need for strategic recruitment within a disciplined, integrated marketing process.

The approach worked; undergraduate enrolments at UNBF rose to ideal numbers to sustain a high level of service and world-class programs. It is a record other Maritime universities have envied.

Today, all universities in Atlantic Canada are facing major enrolment and retention issues. The number of university-aged students across the Maritimes is expected to decline over the next 10 years. The lure of better jobs, higher wages, and more opportunities is also attracting increasing numbers of young people to western Canada.

"At UNBF, we'll continue to be innovative and client focused," says Ms. Mesheau. "We've been successful with our strategic, disciplined approach to undergraduate recruitment. Now we've been asked to apply that methodology to graduate and international student recruitment and to customer service and retention at all levels on our campus."

Personalization, she says, will be a key component of this broader mandate. "We take a one-on-one approach, not only in regards to recruitment but also to ongoing service and education. We need to enhance that personal experience, and we'll be relying on alumni more and more to help us connect with prospective students."

One of the most innovative and personal ways of reaching out to prospective undergraduates is UNBF's successful Admission on the Spot. This

registered trademark program, the first in Canada, brings recruitment admisand sions offices to prospective students across the country. Students are invited bring their transcript, application,

and application fee to have their application assessed on the spot. Admissions personnel have access to UNBF records through an online networking system, enabling them to make an instant admissions decision.

The sessions are designed for parents as well as students. "Parents want to know what educational and financial options their children have," says Student Recruitment Manager Scott Duguay. "They really appreciate getting that information first-hand."

The format consists of a presentation that gives an overview of UNBF's programs, career opportunities, internship and co-op opportunities, financial information, and the application process. After the presentation, students meet one-on-one with UNBF representatives — including admissions staff and local alumni.

"Alumni are a great resource for high school students," says Duguay. "Many of the alumni who attend these events are recent graduates. The students relate to them easily, knowing the feedback they get will be based on the experience of someone who has been there and understands.

"Student consistently tell us they want personal contact," he says, "Based on our experience at Admission on the Spot events, this face-to-face approach reinforces their desire to come to UNBF and gives them confidence that they're making the right choice."

## Athletes on both campuses recognized for academics

# In Fredericton, 56 named CIS Academic All-Canadians

Every year, Canadian Interuniversity Sport (CIS) recognizes varsity athletes across the nation for both their athletic and academic accomplishments by naming them CIS Academic All-Canadians.

The 2005-06 academic year saw 56 of 194 student athletes at UNB Fredericton achieve a grade point average (GPA) of 3.5 or higher, qualifying them for Academic All-Canadian status. All the recipients receive an official certificate from the CIS and a scholar-ship for their academic achievements.

# William MacGillivary passes away at age 67

William (Bill) MacGillivary, a name synonymous with athletic excellence at UNB Fredericton as a student-athlete and later as a coach, teacher and administrator, passed away in Fredericton on Sept. 14, 2006. He was 67.

Dr. MacGillivary's name is linked with decades of athletic tradition at UNB. He was a key member of the Red Devils hockey team as team captain in the early 1960s, leading the club to the Maritime Intercollegiate Athletic Union championship in 1959-60 and 1961-62. He would

go on to coach the Red Devils for 10 years, retiring in 1977.

Dr. MacGillivary returned to the spotlight in 2003 and 2004 when he was the tournament chair of operations for the successful Canadian Interuniversity Sport men's hockey championships, hosted by the UNB Varsity Reds.

His influence in the game of hockey reached far past the grounds of UNB.

Dr. MacGillivary was a former New Brunswick Amateur Hockey Association (NBAHA) technical director and lifetime member of the provincial body, now known as Hockey New Brunswick. He was a member of the Canadian Amateur Hockey Association development council and was general manager of Atlantic Canadian age-class teams and a member of the selection committee for the 1987 and 1988 Canadian world junior hockey teams.

On the academic side at UNB, Dr. MacGillivary started in 1967 as an assistant professor in the department of physical education before becoming associate professor six years later. He became a professor in the faculty of physical education and recreation in 1978 before taking over as dean of the faculty from 1980 to 1991.

The native of Florence, N.S., earned his bachelor of physical education degree from UNB in 1962 before obtaining his master's degree at the University of Alberta in 1965 and his PhD at the University of Wisconsin in 1977.

He is survived by his wife Sandra (Boyd); sons James (Sandy) and Tim; and a sister, uncles, nieces, nephews and cousins.
