#### The Peaceful Revolution: 250 Years of Democracy in Nova Scotia

By John Boileau (BA'66) Nimbus Publishing Limited ISBN: 978-1-55109-3

On Oct. 2, 1758, 19 men met for the first time as the Nova Scotia House of Assembly, and in a small, wooden courthouse in Halifax, Canadian parliamentary democracy was born. From the signing of the Magna Carta to the early Mi'kmaq political systems, to the see-sawing battles between England and France for control of key North American footholds, The Peaceful Revolution chronicles the alliances, betrayals, petitions and protests on the long road to the democracy that Canadians enjoy today. After representative government began in 1758, N.S. led the way with other democratic advances. The Peaceful Revolution openly acknowledges that not everything in N.S.'s past is worthy of celebration, such as the decimation of the Mi'kmaq by European diseases and the expulsion of the Acadians. Despite the past injustices of colonial authorities, all Nova Scotians can take pride in many of their predecessors' achievements. With impeccable research and a strong sense of narrative, John Boileau brings the vital struggle that created the underpinnings of Canadian society to life.

#### Painted Poems: Inspired by the Natural Beauty and History of South-East New Brunswick

Painted Poems is the result of a collaborative effort between poet Margaret Eaton of Moncton and artist Angelica De Benedetti of Sackville, N.B. It contains 20 reproductions of Angelica's oil paintings, 20 of Margaret's poems and detailed research notes about the area, including Sackville, Dorchester, Baie Verte and the Tantramar Marsh, and was published with grants from Cultural Capitals '08 Project: Town of Sackville and The Westmorland Historical Society. This uplifting historical romance is Pamela Fulton's third book, first novel, a sequel to Thomas Hardy's Tess of the D'Urbervilles. It follows Eliza Durbeyfield on her quest for happiness from England's West Country to the Illawarra coast of far off New South Wales, where an urgent letter draws her home to unravel the mystery of Alexis, whose shadow haunts all she touches.

#### **Brown Trout and Rainbow Trout:** A Journey Into **Newfoundland Waters**

By Donald Hustins (BScF'70, MScF'72) Tight Line Publishers ISBN: 978-0-9782245-0-9

The book presents an historical overview of the introduction of brown trout and rainbow trout throughout the island of Newfoundland. It discusses how government encouraged a private fishing club to stock waters depleted of native brook trout; when and where these fish were introduced: the science and environmental considerations involved when introducing exotic species; the impact these introductions have had on native species; and how quickly these foreign species became part of Newfoundland's angling traditions. It is interspersed with humour from the times, old photographs, poetry, and stories and dialogue about the world record sea run brown trout that now inhabit the Avalon Peninsula. It also presents information on places to fish both species and techniques used by seasoned anglers.

#### **Kandahar Tour: The Turning Point** In Canada's Afghan Mission

Kandahar Tour takes the reader into Afghanistan, into the battle group responsible for driving the Taliban farther into outlying areas, to establish a broad security and development zone, allowing Task Force 1-07, the UN and NATO to increase their restoration initiatives. The book details the combined work of soldiers - Canadian and their dozen allies and their commanders, aid workers, the RCMP, and NGOs – all of the pieces that are a part of the Afghan mission, often overlooked by journalists and media. Task Force 1-07 deployed to Afghanistan from February to August 2007. Its core was the 2nd Battalion of the Royal Canadian Regiment from CFB Gagetown. UNB's Gregg Centre's close affiliation to this army of the Atlantic gives the authors excellent access to participants. Their connections and security clearance status provided the authors with access to official war diaries and after-action reports, enabling them to write a rich account of the fight against bomb-making cells and drug gangs that occurred simultaneously with the dramatic but unsung effort to establish a stable government.

#### Researchers awarded \$1 million to study space weather

esearchers at UNB Fredericton have received more than \$1 million from the Canadian Space Agency (CSA) for their research, which will provide information on space weather and improve the accuracy of navigation devices based on the global positioning system (GPS).

P.T. Jayachandran is the principal investigator and Richard Langley and A. M. Hamza are co-investigators on the Canadian High Arctic Ionospheric Network (CHAIN) project.

CHAIN is a network of continuously operating radars and GPS receivers, which will pick up radio signals from a constellation of navigation satellites. The data collected from this network will supplement the information now available from existing systems, used to study the upper atmosphere.

"We need additional receivers because the upper atmosphere, known as the ionosphere, is quite different above the Arctic, compared to lower latitudes," said Dr. Langley, an applied physicist and geodesy and geomatics professor at UNB engineering Fredericton.

"The signals from the GPS satellites travel through the atmosphere - the ionosphere and the lower atmosphere - on their way to receivers on the Earth's surface. By analyzing these signals we can figure out how the atmosphere has affected them, and actually deduce some of the atmosphere's properties."

The information gathered from these receivers may also be useful to Natural Resources Canada, Environment Canada and to the U.S. National Weather Service. It will help improve their conventional weather forecasts and it will also help with navigation and surveying around the world.

The funding for the CHAIN network was one of 10 research projects to receive a total of \$6.5 million in funding from the CSA. It was established in 1989 to co-ordinate all civil, space-related policies and programs on behalf of the Government of Canada.

The maze was also a learning experience. N.B., was awarded the first David M. Armstrong Doctoral Fellowship for graduate students of chemistry and physics at UNB. He is studying computational chemistry under the supervision of Ghislain Deslongchamps. Dr. Armstrong, along with his wife Diane, established the fellowship in honour of Richard's elder brother David, an air crewman who perished in the Second World War. Dr. Armstrong graduated from UNB with a BSc, an MSc, and a PhD. Dr. Armstrong's inheritance from his brother helped him to complete his education. The fellowship is open to PhD candidates and is valued at \$25,000 a year and may be held for up to three years. Following his studies, Dr. Armstrong received the prestigious Beaverbrook Overseas Scholarship for post-doctoral research at the University of London. He later joined CIL Inc., a major subsidiary of Imperial Chemical Industries, one of the largest chemical companies in the world.

#### A Message from the President

## Despite current climate, UNB 'on stable financial ground'

Because of the current economic climate, **UNB President John McLaughlin** has issued the following statement to keep alumni abreast of the university's financial situation.

#### Dear Alumni,

Every day we see more media coverage about the global economic climate and its impact on organizations across multiple sectors, including universities. Because you are part of the UNB family and have invested in our future, I would like to provide you with information about the impact this situation is having on UNB.

Like all universities across Canada, the economic downturn has affected the investment returns of UNB's endowment funds. This has reduced the level of funds available for spending from our endowment and trust accounts, which impacts our scholarship and bursary funds. Our endowment is a long-term fund made up of gifts to UNB generously donated over the decades by friends like you, corporations and foundations. The second-largest university endowment in Atlantic Canada, it was about \$170 million at the beginning of 2008. Endowment funds are invested, allowing the university to use the growth to fund important initiatives, such as the creation of scholarships and bursaries, research chairs and library acquisitions.

With all investments there is an element of risk, and we have always managed our endowment fund cautiously. Our long-term objective has been to earn a real rate of return, after inflation, of 4.5 per cent. Any returns in excess of our annual targets are placed in reserve for use in years when our investments might be adversely affected by market trends. Unfortunately, the scale of today's downward market trends has placed heavy pressure on our current reserves. Given the typical profile of Canadian university endowment investments, universities on average are likely experiencing market losses of between 15 per cent and 20 per cent as of Oct. 31, 2008. UNB expects to be about the same. We are currently exploring options to help make up for any shortfall, so that we can continue to sustain the level of scholarships and bursaries for our students, in particular, as we know many are depending on the support.

UNB has been through challenging financial times before and we have never wavered from our core mission of education and research. We remain on stable financial ground, but there is no question we will have to be both cautious and deliberate in our collective decision-making, to ensure we can continue to fulfill our mandate in teaching and research excellence, and also move forward with important new initiatives. Some of our priorities continue to be the total student experience on both main campuses, the Richard J. CURRIE CENTER in Fredericton, and the expansion of our health research agenda in Saint John, among others.

Because our University has been built on the shared vision and collaborative support of friends like you, we will continue to keep you posted on the overall state of UNB's finances. On behalf of all of us at UNB, allow me to express our continued appreciation for your loyal support.

## New-student enrolment up 6.5 per cent

## Overall enrolment shows slight decrease

More than 11,500 students are back to school at UNB campuses in Fredericton, Saint John and in programs offered elsewhere in Canada and around the world. There are 2,210 new full- and part-time students who are now part of the UNB family, a 6.5-per-cent increase over the same time last year.

"We are pleased to see an increase in new students to UNB," said UNB President John McLaughlin. "We are ahead of our target thanks to the dedication of our faculty and staff, and UNB's reputation for excellence in teaching and research. UNB is the university of choice for more than 50 per cent of students enrolled in New Brunswick's publicly-funded universities. We are proud of that.

"At the same time, there is more work to be done," added Dr. McLaughlin. "We will continue to enhance our efforts to recruit and retain students from within the province, the country and abroad, in support of growth in research and innovation, population growth and the economy in New Brunswick."

UNB's overall preliminary enrolment represents a 2.7-per-cent decrease compared to numbers reported at this time last year.

As reported to the Atlantic Association of Universities, there are 10,849 full- and part-time students (9,547 undergraduate and 1,302 graduate) researching and studying throughout the UNB network.

UNB Fredericton is reporting paid full- and part-time enrolment of 8,340 students, a decline of 2.4 per cent from 2007-08.

UNB Saint John is reporting paid full- and part-time enrolment of 2,509 students, a decline of 0.04 per cent from 2007-08.

UNB attributes this overall decrease to large graduating classes on both campuses last spring, declining demographics and a changing global market.

UNB expects the total number of students to increase slightly as registered students complete tuition payments. Final enrolment figures were to be reported to the Maritime Provinces Higher Education Commission in December.

Another 664 students outside of the Atlantic Association of Universities and Maritime Provinces Higher Education Commission reporting area are gaining a UNB experience through non-traditional programming and course delivery in Ontario and satellite campuses abroad.

## 516 graduate at Convocation

Five hundred and sixteen students received degrees at the UNB's 54th Convocation in Fredericton in October.

The fall graduation ceremony at the Aitken University Centre saw 347 students receive bachelor's degrees, 147 earn master's degrees and 22 achieve the highest level of academic achievement, the PhD.

During the ceremony, UNB honoured New Brunswick native **Basil** (**Buzz**) **Hargrove** with an honorary doctor of laws degree. Mr. Hargrove also delivered the Convocation Address.

Mr. Hargrove is the past national president of the Canadian Auto Workers Union (CAW). He grew up in Bath, N.B., and in 1992 was acclaimed national president of the CAW. Before retiring earlier in 2008, he had been reelected five consecutive times. He is currently the vice-president of the executive committee of the Canadian Labour Congress.

Two members of the university community also were recognized at Convocation. **Gwen Davies** received the honorary designation *professor emerita* in English and *dean emerita* of

graduate studies, and education professor **John Grant McLoughlin** received the Allan P. Stuart Memorial Award for Excellence in Teaching.

Dr. Lewis has continued to provide financial support over the years to the point where the musicians in residence fund can now provide permanent support for the program.

The funds will be used to help strengthen the program's already strong relationship with the New Brunswick Symphony.

In recognition of Dr. Lewis's support and patronage, the program has been re-named The Bill Lewis UNB Musicians in Residence Program.

#### Gregg Centre authors dedicate Afghanistan book at Gagetown

The Gregg Centre for the Study of War and Society at UNB hosted a book dedication at Base Gagetown in November. Kandahar Tour: The Turning Point in Canada's Afghan Mission is the story of a one six-month rotation of Canadian soldiers and civilian government officials, deployed to Afghanistan from February to August 2007. Most of the soldiers in Task Force 1-07 (TF 1-07) were members of the 2nd Battalion of the Royal Canadian Regiment (2RCR), based in CFB Gagetown, and backed by reservists from militia units from all regions of Atlantic Canada. The researchers were given access to official war diaries and after-action reports, which allowed them to write a rich and comprehensive account of the New Brunswick troops and their battle against bomb-making cells and drug gangs while they continued their dramatic efforts to establish a stable civil government. "And this new space will help us to even better prepare our students for careers in law by giving them access to the latest technology and to a simulated courtroom experience." The classroom accommodates more than 150 students, and will be used as a lecture theatre and as a courtroom for mock trials. A generous gift of \$250,000 from the New Brunswick Law Foundation helped to renovate the space, with additional funding from the faculty of law, UNB alumni and friends of Mary Louise Lynch. Dr. Lynch had a busy and successful law practice in Saint John, N.B., where she served as New Brunswick legal counsel for Lord Beaverbrook. She later served on the National Parole Board. She was also a member of UNB's Board of Governors and was named its first governor emeritus. #### New executive to examine role of women leaders

Nora Kelly has begun her new role as UNB executive-in-residence on the Fredericton campus.

UNB regularly hosts visitors-in-residence — from visiting scientists and scholars to visiting executives — who serve the community in a variety of ways and add value to the learning environment, said UNB President John McLaughlin.

In Ms. Kelly's case, she has come to UNB on a secondment from the provincial government, and will examine the role and impact of women in leadership positions in New Brunswick's public, private and non-profit sectors. This secondment is funded by the Province.

Ms. Kelly's primary objectives and activities as executive-in-residence are to:
• enrich the learning experience of students through the delivery of lectures, seminars, and/or advice to students, related to her area of focus:

- stimulate faculty discussion and research on issues related to women leaders in New Brunswick;
- provide advice to UNB with respect to its own approach to women in leadership;
- facilitate public discourse related to this subject.

Ms. Kelly will not work on files related to post-secondary education policy in New Brunswick.

## Carrying on the legacy of Leslie Bruce

Environmental scholarship honours memory of student

Leslie Bruce gifted student with boundless enthusiasm and energy and a passion to protect the local and world environment.

After her death just more than

two years ago, her family, friends, and classmates at UNB turned their grief into support for a scholarship in her memory.

More than 300 donors, in an incredible show of support, created the Leslie E. Bruce Environmental Scholarship.

Last fall, the first scholarship in Leslie's name was awarded to Andrea Norlund, a fourth-year student at Renaissance College in Fredericton.

Andrea volunteers at the Stan Cassidy Centre in Fredericton, and this past summer she worked on conservation projects in Ecuador, where she planted and maintained seedlings at a tree nursery, worked on an organic garden, and helped prepare organic coffee.

"It's very moving to see Leslie's scholarship benefit another young woman who works so hard and gives generously of her time to improve the environment and our community," said UNB President John McLaughlin. "I hope that it is some comfort to Leslie's family to know that this scholarship will continue to benefit many generations of students who demonstrate their interest and enthusiasm for protecting the world environment."

The scholarship is open to full-time graduate and undergraduate students in any discipline, from either UNB campus, and is valued at \$5,000 annually.

To be eligible, applicants must show leadership ability in the environmental field, and demonstrate acceptance into an accredited post-secondary institution or course of study.

"No grass ever grew under Leslie's feet — she had to be busy," said her father, Michael, citing a lengthy list of her work as a volunteer in various communities throughout New Brunswick. "When it comes to Leslie's approach to life, I like the quotation, 'In the end, it's not the number of years you live in your life that count, it's the life you live in those years.' It's so appropriate to Leslie because she accomplished a lot in her life, for someone who was so young."

In 2002, Leslie organized a coast-tocoast cycling trip to raise awareness of the dangers of greenhouse gases, joined World Trade Organization protesters in Seattle, took part in an exchange program in Britain where she learned to build straw bale homes, and travelled to Australia to see how people lived off the land.

"I am entering my early twenties into a world whose oceans are rising because of the effects of global warming, whose rain forests are being stripped by the minute for the sake of a quick buck, whose radioactive waste is being stored until we can figure out what to do with it, and where the worth of everything is measured in dollars,"

Leslie wrote in a letter to her local newspaper in 1999.

"I am very concerned for the kids of tomorrow because they are my children and your grandchildren," she added. "It is time to stop worrying about ourselves and the children of today, and time to take the larger picture into consideration."

Leslie also was devoted to her work with the counsellor-in-training (CIT) program at the YMCA's Camp Glenburn, on Belleisle Bay on the Saint John River. The CIT program fosters the development of leadership skills to help youth engage with other youth and outdoor education.

Leslie began her relationship as a camper and quickly became a junior, then a senior counsellor. In 2000, she became the environmental director for the camp, a perfect match for an inspiring and enthusiastic environmentalist. In 2003, eight years after attending as a camper, she became the CIT director at Glenburn.

At the time of her death, Leslie was one of eight co-owners of a 150-acre sustainable organic farm and green school at Tabusintac, N.B. She had returned to school in the fall of 2005 as a student in the faculty of education at UNB Fredericton. On graduation, she was planning to teach children the importance of sustaining the environment.

## UNB wins yet another bid to host national athletics championship

Tosting national athletics tournaments is getting to be almost routine for UNB Fredericton.

The latest coup came with the recent announcement the Fredericton campus will host the Canadian Interuniversity (CIS) Men's Hockey Championships in 2011 and 2012.

UNB's bid committee made its presentation to the selection committee in Ottawa on Dec. 2, and was awarded the championship two days later. Also bidding for championships was Dalhouse University. The bid presenters for UNB were Athletics Director Kevin Dickie, and Lloyd Henderson, co-chair of the bid committee and director of business development at the College of Extended Learning. The presentation included a video highlighting UNB's hosting success, the quality of the Varsity Reds' hockey program, and the support of Aitken Centre fans. "We are absolutely thrilled to have the opportunity to host such a tremendous event," said Mr. Dickie. "It is outstanding for our men's hockey team, our university, the City of Fredericton and the Province of New Brunswick. I sincerely want to thank our bid committee for their passion and tireless efforts over the past couple of months."

Other members of the bid committee in attendance at the presentation were: Roger Shannon, bid committee co-chair; Brian Johnson, community partner; and UNB's Gardiner MacDougall, Dave Morell, Maureen Sparks and Sandra Howland. Fredericton Mayor Brad Woodside accompanied the committee to lend support on behalf of the city.

UNB hosted a sold-out event for the 2003 and 2004 men's hockey championships, held a successful 2006 women's basketball championship and is currently in the second year of hosting the women's volleyball championships. The successful staging of each of these events has placed UNB in the position to continue to bid for other national championships. UNB's mandate to maintain its status as a national university is also a driving force for the Varsity Reds.

At the end of the fall term, the V-Reds hockey team was ranked No. 4 in the CIS Top Ten, and is the defending Atlantic University Sport champion. As a perennial national contender, UNB has reached the CIS University Cup tournament in seven of the past 12 seasons, including University Cup titles in

1997-98 and 2006-07.

"This is excellent," said an ecstatic MacDougall, UNB men's hockey coach. "A number of our veteran players have had the good fortune to be exposed to the CIS championships, but in other venues. Our younger players will now have the unbelievable opportunity to play for a national title in the Aitken Centre. The attention this brings to UNB, Fredericton and the Province of New Brunswick is just outstanding. I am extremely happy for our loyal fans."

## UNB in top five of Macleans comprehensive rankings

Macleans has ranked UNB as one of the top five comprehensive universities in Canada for the second consecutive year.

"We are proud that UNB continues to rank amongst much larger institutions," said UNB President John McLaughlin. "We are pleased with the ranking, but cannot lose sight of the work ahead to find better ways in which to serve our students and community."

Macleans rankings are based on recent publicly available data, and comprehensive universities described as those having a "significant amount of research activity and a wide range of programs at the undergraduate and graduate levels, including professional degrees."

The rankings for comprehensive universities are: Simon Fraser (1), Victoria Waterloo (3), Guelph (4), Memorial (5), New Brunswick (5), Carleton (7), Windsor (8), Regina (9), York (9) and Concordia (11).

The university was ranked number one in the categories of faculty/staff ratio and in library holdings per student. Student Union presidents Bethany Vail (Fredericton) and Nigel Wyles (Saint John) note there is a lot of strength on UNB's campuses as evidenced in this year's ranking.

Students throughout UNB want to continue to collaborate with UNB administration and faculty to further develop and promote a balanced student experience at the university. UNB also participates in several other surveys to measure its progress and evolution. In addition to the annual Macleans survey, UNB is also ranked in the Globe and Mail Report Card, the National Survey of Student Engagement, Canadian Undergraduate Survey Consortium and the College Sustainability Report Card.

## Public input sought on inter-campus report findings

Public consultation is under way after the recent release of UNB's report of the Commission on Inter-Campus Relations, Funding and Governance.

Commissioners Thomas Condon and James O'Sullivan, both *vice-presidents emeriti* of UNB, have concluded intercampus initiatives and funding have generally worked to the benefit of both the Fredericton and Saint John campuses and have been reasonable and fair.

At the same time, the commissioners made eight recommendations to further strengthen inter-campus relationships, and finance and governance systems.

UNB has been a two-campus institution for nearly 45 years, and it is vitally important that the relationship between the campuses be strengthened and supported, the commissioners said.

The report is available at **www.unb.ca/president**. A consultation process will solicit feedback from the community before UNB identifies an action plan based on the recommendations this coming spring.

Among the key recommendations: separate operating grants for campuses in Fredericton and Saint John; the adoption of new mechanisms to monitor and improve inter-campus functions and relations; improved program mandates for each campus; and greater community involvement for the Saint

John campus.

"The relationship between our two campuses is what makes us a national university," said UNB President John McLaughlin. "The work of this commission will help us to make that relationship even stronger as we continue to build on our reputation as one of the best public schools in the country."

From humble beginnings in 1964 as a feeder campus, UNB's Saint John campus has grown from 97 students to a full degree-granting institution with almost 2,500 students, part of a network of nearly 12,000 who now receive a UNB education in locations around the world.

"I came to Saint John because of the solid reputation of the University of New Brunswick," said Robert MacKinnon, vice-president of the Saint John campus. "UNB Saint John has become a key pillar within the UNB system, the community and the province. We will continue to build on our capacity in the Port City and, with our colleagues in Fredericton and throughout New Brunswick."

The commission is the first such look at inter-campus affairs since 1984. In preparing its report, the commissioners met with nearly 100 individuals from both inside and outside the university, and received 35 written submissions.

#### UNB welcomes capital investment plan

The provincial government's recent announcement of a \$1.2-billion capital investment plan for New Brunswick's universities has been welcomed by UNB.

The plan will see \$160 million earmarked for new facility construction and in renovations to existing buildings at New Brunswick's public universities and community colleges.

"Universities can launch a range of maintenance and renewal projects quickly and provide immediate stimulus in our local communities, while also furthering the province's long-term goals," said Dan Murray, UNB's vice-president, finance and corporate services.

"This is an example of the provincial government's recognition of the importance of post-secondary education and research in New Brunswick's drive towards self-sufficiency," said Greg Kealey, UNB provost and vice-president (research).

#### Retired MP Andy Scott named to lead new social policy network

Andy Scott, who recently retired as the member of Parliament for Fredericton, will lead the Social Policy Research Network at UNB Fredericton.

The network will combine the most current information and expertise available on social policy issues in New Brunswick.

Appointed to a two-year term as the Andrews Senior Fellow in Social Policy in the department of sociology, Scott began his new role in October.

"Andy Scott's outstanding abilities as a communicator, a negotiator and a team leader will be a great asset in getting this ambitious project off the ground," said James Murray, the dean of arts at UNB's Fredericton campus.

The goals of the network include cataloguing current social policy research and creating an easily accessible New Brunswick database of information for use by the public, researchers and other interested parties. Scott will seek new ways to bridge social policy research at institutions across the province and promote awareness of important social policy issues in New Brunswick.

"It's a great feeling to come to the University of New Brunswick, the research engine of the province," said Scott. "I'm looking forward to finding new ways to encourage more collaboration opportunities for researchers all across our province."

A generous bequest from the estate of J. William Andrews, a graduate of the arts faculty at UNB, made this position possible. Mr. Andrews, originally from Milltown, N.B., was a lifelong employee with CIL Canada, a producer of specialty products and paints in Montreal.

# UNB vaulting to the forefront of Atlantic athletic facilities

giant, 73-by-45-metre dome on Chapman Field and a towering 42-metre high crane are visible signs of the progress UNB is making in its effort to vault to the forefront of athletic facilities in Atlantic Canada.

"Considering the size of our institution, when the Richard J. CURRIE CENTER is finished our athletic facilities will be among the best in Canada," said Kevin Dickie, athletics director at UNB Fredericton.

In November, UNB erected a dome over one end of Chapman Field, providing year-round access for soccer players. Meanwhile, construction of the \$50-million CURRIE CENTER cleared its first major milestone this fall after crews completed site preparation work on the south side of Buchanan Field next to the Lady Beaverbrook Gym. Over the coming months workers will pour the building's foundation, then build its steel frame this spring.

The CURRIE CENTER is scheduled to be complete in May 2010.

"The Varsity Reds program is extremely excited about the opportunities ahead with the construction of the CURRIE CENTER," said Mr. Dickie. "There's no question it will take us to a different level in terms of national recognition and the recruitment of student-athletes."

Melanie Doucette, women's volleyball team captain and three-time winner of the Colin B. Mackay Female Athlete of the Year, said the addition of the CURRIE CENTER will help the next generation of UNB athletes compete at even higher levels.

"The development of the CURRIE CENTER will provide a more competitive atmosphere for both UNB volleyball and basketball student-athletes," Ms. Doucette said. "New training equipment will help student-athletes better train off the court and more gym space will provide these teams longer practice slots to further develop their oncourt skills and abilities."

The CURRIE CENTER will provide a sporting experience that is second to none for UNB's volley-ball and basketball teams and their fans. Spectators will enjoy V-Reds games from a 1,500-seat stadium and a café to purchase snacks and drinks. UNB athletes will have access to a performance court specifically for basketball and volleyball competition in addition to other practice courts. Each team will

have a personalized locker room and access to the CURRIE CENTER's cardio and weight training room, the Athletic Therapy Room, the Fitness and Lifestyle Assessment Centre and the Human Performance Laboratory.

The Athletic Therapy Room will provide the UNB community with short-term and long-term rehabilitation services. The Fitness and Lifestyle Assessment Centre is designed to provide physical fitness assessments, counselling to meet fitness goals and customized personal training to the university community and the general public. The assessment centre will have professionals trained to provide a whole range of services, from fitness tests on high-performance athletes to workplace wellness assessments.

The Human Performance Laboratory will be one of the most advanced movement analysis labs in the

country. Building on UNB's long history of research in human movement analysis, the creation of the Human Performance Laboratory in the CURRIE CENTER will further build on UNB's international reputation as a provider of research, education and chronic disease management services in human movement.

The only one of its kind in Canada, the Human Performance Laboratory will also provide the varsity athletes with fatigue and performance analysis.

The CURRIE CENTER will support the excellence for which the Varsity Reds program has become so well known. Its mandate recognizes that athletics is an important part of student and community life, and its breadth of health and wellness activities will touch thousands beyond the athletics program, through its activities as a public activity centre and through its important research.

The CURRIE CENTER is named after Richard J. Currie, UNB chancellor, who, along with hundreds of donors, has made the vision of the CURRIE CENTER a reality. The chancellor is challenging other UNB alumni and friends to provide their support to this very important project.

## Alumni Bldg. hosts national WWI memorial

The Alumni Memorial Building on the Fredericton campus was chosen as one of only a handful of Canadian host sites in November for *Vigile 1914-1918 Vigil: A Project of Remembrance*.

The project was a tribute to the 68,000 Canadians who died in the First World War. From sunset to sunrise Nov. 4 to Nov. 11 their names were projected, one at a time, on the Memorial Wall in the Alumni Memorial Building, on the National War Memorial in Ottawa, at sites in Halifax, Toronto, Regina and Edmonton, and at Canada House in London, England.

Throughout the week, scores of people came to the Alumni Building each night, some of them to see a specific name among the war dead. The date and time each of the names was to be projected were posted on the *Vigile 1914-1918 Vigil website*.

The project, which marked the 90th anniversary of the end of the war, was an initiative of noted actor/director R.H. Thomson, Martin Conboy, and Canada's National History Society. The N.B. Provincial Capital Commission facilitated New Brunswick's showing of *Vigile 1914-1918 Vigil* in partnership with the Province of New Brunswick, UNB, Canadian Forces Base Gagetown, and its national partners, Veterans Affairs Canada, and Canada's National History Society.

The Alumni Memorial Building, originally named the Memorial Student Centre, was built as a tribute to UNB alumni killed in both world wars.

During the First World War, about 300 UNB alumni enlisted for service overseas, a remarkable figure considering the university's enrolment in 1913, totalled just 165 students.

In conjunction with *Vigile 1914-1918 Vigil*, the UNB Associated Alumni has established a website featuring the 32 UNB alumni who gave their lives during the First World War. Visit **alumni.unb.ca/UNBvets**.

## Lest we forget: 32 UNB alumni made ultimate sacrifice in WWI

The following biography and photo of **Lieut. John Gibson**, one of the 32 UNB alumni who died in the First World War, was taken verbatim from the *Memorial Magazine 1914-1919*, *University of New Brunswick*, published by the university in 1919.

**LIEUTENANT JOHN T. GIBSON** was the son of Alexander and Charlotte Gibson, and was born at Marysville, York County, N.B., February 28, 1890.

He was educated in the Marysville school and the Fredericton High School, and was matriculated into the University, where he entered the department of Civil Engineering. In 1910 he was graduated, and accepted a position in the Dominion Public Works Department, St. John.

As early as 1906 he became a member of the 71st Regiment and drilled more or less regularly for some years, winning a lieutenancy in 1916, when he enlisted. In September he was appointed recruiting officer for the counties of Kings and Sunbury, which position he filled until January, 1917, and in June of that year he was granted a cadetship in the Royal Flying Corps, and soon after obtained a lieutenancy.


He sailed for England September 1, 1917, with a detachment of the Canadian Air Force, passed all the tests successfully, and was assigned to duty at Gatesbury, Wiltshire. While making a "solo" flight, his plane in some way got out of control and crashed to the ground, fatally injuring the young aviator, who never recovered consciousness, dying February 10, shortly after the accident. He was buried with military honors in a little churchyard at that place.

He was fond of military life. Those, who knew him best, admired his sturdy, heroic spirit, and were looking for a record of iron courage and brave deeds, had the young soldier been destined to reach the line where men do and die; but it was otherwise ordained.

#### **ALUMNI AWARD OF HONOUR**

The UNB Associated Alumni's most prestigious award recognizes truly outstanding service and commitment to UNB and the Associated Alumni. This year's recipients are:

John Bliss (BScCE'55) and Dorothy McDade (BSc'57) of Fredericton: John Bliss was born Feb. 13, 1933, in Montreal. His family moved to Fredericton, the original home of both his parents, in late 1933. While

attending UNB, he held a Beaverbrook Scholarship. After graduation, he was employed briefly with the provincial government, then joined the Canada Cement Co. in Moncton and then in Toronto. He moved to Woodstock, Ont., as a consulting engineer for about two years and then to nearby Stratford for two years with a contractor. Returning to Fredericton in 1965, John spent 14 years with ADI Ltd. and in 1979 took the job as city engineer with the City of Fredericton, retiring in February 1998. Recently the City of Fredericton named their new \$8.1-million water treatment plant in his honour. He served as a member of Fredericton City Council for two years, from 1971-1973, and served for several years on the executive of the Fredericton branch of the Association of Professional Engineers of New Brunswick. His community work has included several years on the board and executive of the Fredericton Area United Way, serving as

campaign chairman in 1977 and as president in 1979. John has participated in YMCA capital campaigns and the Chalmers Hospital Foundation cat-scanner campaign. He has been a long-time strong supporter of UNB and currently serves as chair of the Beaverbrook Scholars award committee. As life president of the UNB Class of 1955, John has helped organize and participated in a number of reunions. John married Dr. Dorothy McDade in 1971.

Dr. Dorothy McDade was born Oct. 7, 1935, in New Market, N.B., the youngest of 11 children. She moved to Fredericton in 1944 and attended St. Dunstan's School, Fredericton High School and UNB, graduating in 1957 with a bachelor of science, honours. She graduated from Wayne State University in 1959 with a master of science in medical technology, then from the University of Western Ontario in 1964 with a doctor of medicine. Dr. McDade then interned in Montreal, and did a residency in

internal medicine from 1964 to 1969. She then returned to Fredericton and practised internal medicine from 1969 to 2004 as a member of the Fredericton Medical Clinic, the Victoria Public Hospital and the Dr. Everett Chalmers Hospital (DECH). In 1992, Dr. McDade was awarded the Dr. Garfield Moffatt Medal for exceptional standards as a practising physician in New Brunswick. She was four-time chair of the department of medicine at the DECH. In 1993, Dr. McDade was appointed to the Board of Governors of UNB, serving until 1999.

John and Dorothy have been constant philanthropists for local causes and organizations, supporting recreational works such as the YM-YWCA and Fredericton Indoor Pool, the United Way, cultural activities through support to The Playhouse, and education in the form of major donations to UNB.

David Ganong (BBA'65) of St. Stephen, N.B., is chairman of the world-renowned candymaker Ganong Bros., Limited. Born in St. Stephen on Sept. 14, 1943, he is married and has three children. While attending UNB, he was a resident of Neil House, serving as house president. He received the Outstanding Business Student Award upon graduation, and was business manager of the Red 'n' Black Revue. He then earned his MBA from the University of Western Ontario in 1970 before joining the family business. David has a long record of engagement in corporate and community organizations. He currently is a director of Ganong Bros.; director, Canadian Council of Chief Executive Officers; director, Sun Life Financial; member, North American Competitiveness Council; member, Governor General's Canadian Leadership Conference; and member, Board of Governors, UNB. He also is the past chair of the UNB board, and was a member of the UNB's Forging Our Futures campaign cabinet. He received the BBA Achievement Award from UNB Fredericton's faculty of business administration in 1989 and was the recipient of the 2002 Gulf of Maine Visionary Award, which recognizes commitment to marine protection of the Gulf of Maine. In 2003 and in 2008, he was named one of Atlantic Canada's Top 50 CEOs by Atlantic Business Magazine. He was named to the Order of Canada in 2005. David and his wife Diane, along with Ganong Bros., Limited, have been generous supporters of UNB over the years.

David Le Blanc (BBA'82) of Ottawa has a continuing record of involvement with UNB as both a student and an alumnus since the day he started university in 1977. He began his volunteer activities as a member of the Neill House committee,

later serving as Neill's social chairman. His other student activities included the intramural sports program, the orientation committee and the winter carnival committee. In 1982, he was elected secretary\treasurer for the Life Executive of the Class of 1982, and was awarded the Gold Activity Ring. After leaving UNB, David moved

back to Ottawa, where he still lives. He was been working for Statistics Canada since 1985, and currently serves as a network administrator. He started volunteering with the UNB Club of Ottawa in 1986. He has served as the club treasurer, and as president for five years. During his third year as president, he was elected to the Associated Alumni Council, eventually serving for more than 10 years. David has been active for years with a number of soccer clubs as a head coach for his two sons Christopher, born in 1985, and Jonathon, born in 1990. David says receiving recognition through the Proudly UNB Awards "is truly an honour."

#### AWARD OF DISTINCTION

This award recognizes the significant contributions made by UNB alumni in their local communities and beyond, for which they have been recognized regionally, nationally, or internationally. This year's recipients are:

Peter Bessey (BBA'86) of Halifax is senior vice-president, Scotiabank, retail and small business banking, Atlantic Region. While attending UNB, Peter played an active role in the Business Society and the Student Representative Council. He joined Scotiabank in 1986, where he has held a series of progressively more senior management positions, including two branch manager's postings and two senior commercial banking appointments. In July 2008, Peter and his wife Mary Jane moved to Halifax, where he accepted his current assignment. Peter is a past director of the Saint John and Fredericton Chambers of Commerce, past president of the Kiwanis Club of Fredericton, past president of the Bridgewater Chamber of Commerce, past president of the N.B. Chamber of Commerce, past director of the Atlantic Provinces Chamber of Commerce, and has served on the boards of a number of economic development agencies. In 2003 he was awarded the Queen's Jubilee Medal in recognition of his contributions to the growth and development of business through his involvement in the Chamber of Commerce movement. In May of 2005, Peter was selected as one of the Top 50 CEOs in Atlantic Canada, by Atlantic Business Magazine. Peter and Mary Jane have two children, Christopher, who is a recent pharmacy graduate from Dalhousie University, and Alex, who is a fourth-year business administration student at UNB Fredericton.

Jennifer Flanagan (BSc'96) of Ottawa has devoted her career to making science and technology come to life for young people. As president and CEO of Actua, a national charitable organization based in Ottawa, Jennifer co-ordinates a network of 29 member organizations that annually engage more than 250,000 youth across Canada. Together, these groups deliver science and technology education programs via camps, classroom workshops, clubs, and community outreach. Under Jennifer's leadership over the past 10 years, Actua has established a niche in engaging youth who are typically underrepresented and underserved in science and technology. Prior to co-founding Actua in 1997, Jennifer was the New Brunswick provincial

director of the Innovators in the Schools program, where she created a province-wide science club for girls. Jennifer's interest in developing youth science and technology programs was sparked in 1993 while attending

UNB, when she became involved in their summer science and engineering program for children (Worlds UNBound). She and her husband, Michael Plamondon, welcomed their first child in September 2008.

Denise LaForge (BScME'88) of Calgary is a prominent bilingual Alberta business executive with 20 years of management experience in the oil and gas industry. She has cofounded and actively participated in the start up of several companies in Calgary. Originally from Edmundston, N.B., Denise also holds a masters in business administration from the University of Calgary. Most recently, she co-founded and was the first board chairperson of Tarpon Energy Services Ltd., an Alberta-based company that provides a broad range of integrated products and services to energy producers. Today, Denise actively supports charitable organizations that are close to her heart. Over the last four years, Denise has been engaged on the advisory board of Impact Society, a charitable organization specializing in strengthbased character development programs in youths. Denise has helped raised in excess of a million dollars and has personally donated in excess of \$100,000 to help the program expand to rural Alberta. In addition, she has recently donated \$100,000 to UNB's Richard J. CURRIE CENTER. Her unwavering personal commitment to "making a difference" will enable the Alberta Alumni Recreation Center to have advanced facilities for exercise and fitness. Recently, Denise accomplished her personal goal of completing Ironman Canada 2008. And her simple message to all is "If I can do it, so can you!"

Dr. Gordon Porter (BA'70, BEd'72, LLD'89) of Woodstock, N.B., is a consultant, trainer, researcher and teacher. He was instrumental in developing an inclusive approach to education in schools in New Brunswick, a program recognized as an example of good practice by UNESCO and the OECD. He retired in 2006 as a professor of education at the University of Maine at Presque Isle. Dr. Porter is director of inclusive education initiatives with the Canadian Association for Community Living and is active in supporting inclusive education in Canada. He is also serving a five-year term as chair of the N.B. Human Rights Commission and has initiated strategies to address human rights and achieving inclusive education in New Brunswick and Canada. In 2005, Dr. Porter completed seven years as the president of Inclusion InterAmericana, a regional federation of national associations advocating for individuals with intellectual disabili-

ties. In 2007 the Canadian Education Association named Dr. Porter the recipient of The Whitworth Award for Education Research, which honours an individual who has made a noteworthy contribution to educational research in Canada. The award recognizes Dr. Porter's substantial contribution nationally and internationally at both a conceptual level (by broadening and redefining our understanding of disability and inclusive education) and a practical level.

#### YOUNG ALUMNI ACHIEVEMENT AWARD

This award recognizes those who received a bachelor's degree within the last 10 years or a graduate degree within the last five years. This year's recipients are:

Sean Dowling (BScME'02) of North York, Ont., after graduating from UNB, entered the University of Toronto in aerospace engineering at the Institute of Aerospace Studies, earning a master's degree. Since then he has worked with MacDonald Dettweiller Associates (MDA), and, as a result of his work there, he recently was awarded the NASA Space Flight Awareness Award. Sean has had a distinguished career as an engineer at MDA. He has worked since 2004 in the space missions division, working on Canada's contribution to the International Space Station (ISS), the mobile servicing system, which comprises the mobile base station, space station remote manipulator system (or "CanadArm 2") and, most recently, the special purpose dextrous manipulator (SPDM or Dextre). Dextre's primary role is to carry out delicate maintenance and servicing tasks on the ISS, including installing and removing on-orbit replaceable units; operating robotic tools; and providing power and data connectivity to payloads. Dextre is controlled by the ISS crew and performs a great many tasks that otherwise would require an astronaut to perform spacewalks. Sean was award the NASA honour as a result of his work with Dextre. Sean credits his success to "very supportive parents, a lot of motorcycles that did not work, and a father with a life-long interest in all things air and space related.

Dr. Kate Rogers (BA'99) of Grand Bay-Westfield, N.B., has spent her adult life working for the betterment of humankind, specifically in Kenya and Sierra Leone. Since November 2007, Kate has worked with the World Bank

as program co-ordinator of Justice for the Poor in Sierra Leone. Before taking that position, Dr. Rogers worked in New York for 23 months to prepare and launch State of the World's Children, UNICEF's flagship publication. After completing her graduate degree work at the University of Oxford, she worked as an independent consultant in

Kenya on projects related to municipal sanitation and institutional strengthening. She also worked as a volunteer program associate, monitoring and analysing political violence as part of the elections monitoring unit during the 2002 national elections in Kenya. While at UNB, Kate reported for *The Brunswickan*, served as social issues commissioner, and worked as a peer mentor and on the orientation committee. Kate assumed the role of Student Union vice-president (student services) in third year and served as Student Union president in her fourth year.

#### OUTREACH GROUP OF THE YEAR



## Johnson named assistant VP at SJ campus

John Johnson, the former registrar at UNB Saint John, has accepted the temporary position of assistant vice-president (acting) for the period November 2008 to December 2009.

Dr. Johnson will help support some of UNB Saint John's major initiatives, both planned and underway, including the

emerging research agenda surrounding the new Dalhousie medical education program, the development of a renewed relationship with NBCC Saint John and NBCC St. Andrews, the establishment of an Urban Institute, ongoing academic planning, and enhancing the learning environment of the campus, said UNBSJ Vice-President Robert MacKinnon.

"Dr. Johnson's past involvement, particularly on the medical education and co-location files, along with his past experience as registrar for the Saint John campus, will allow him to have an immediate impact on the office of the vice-president and UNB Saint John," Dr. MacKinnon said.

Last spring, UNB reached an agreement with its partners in the provincial government and Dalhousie University to bring an English-language medical education program to New Brunswick.

Based on the Saint John campus, the program will see the first medical students in New Brunswick in September 2010. A partnership between anglophone hospitals in Saint John, Moncton, Fredericton and Miramichi will see medical students spend their first two years studying at UNBSJ and the Saint John Regional Hospital. Their third and fourth years will involve clinical rotations at hospitals in Saint John, Moncton, Fredericton and Miramichi.

Dr. MacKinnon said Dr. Johnson's role as the chief negotiator for the UNBSJ portion of the medical school made him the perfect choice for the new assistant VP position, which will be re-assessed at the conclusion of Dr. Johnson's term.

Meanwhile, the re-location of portions of Saint John College, UNB Saint John's academic preparatory college, from Tucker Park to new locations to make way for the medical program is continuing. Several college staff positions were moved to Beaverbrook House in uptown Saint John last fall. Further renovations are being done to Beaverbrook House, as well as the Grand Hall, in preparation for further moves from the current Saint John College space.

## New Innovatia Research Chair to build enterprise web solutions

Respected researcher Dr. Christopher J. O. Baker is the first Innovatia Research Chair at UNB Saint John. Dr. Baker brings to the province the vision and know-how to build new web solutions for enterprise using Semantic Web, Web 2.0, and Web 3.0 technologies.

Dr. Baker will establish a new team to build cutting-edge information integration systems that will aid scientists, knowledge workers and non-technical experts in the testing of new hypotheses and in data integration.

The appointment of the chair is the result of a partnership between the Atlantic Canada Opportunities Agency (ACOA), UNB and Innovatia.

ACOA's support of the Innovatia Research Chair came through an Atlantic Innovation Fund investment to Innovatia in January 2008.

"The partnership between Innovatia, ACOA and UNB to bring Dr. Baker to New Brunswick is a perfect example of what deep partnerships can accomplish for our province," said Robert MacKinnon, vice-president of UNB Saint John. "Dr. Baker's expertise has applications across a wide spectrum of interests, from health care to information technology, and we are thrilled to have him join our community."

As chair, Dr. Baker will lead research on a number of related projects while holding an official position as principal scientific researcher with Innovatia, and also teaching at UNB Saint John.

"Innovatia is pleased to be forging new ground with this collaboration between UNB Saint John and ACOA," said Roxanne Fairweather, COO, Innovatia. "We have been working for over a year to bring someone with Dr. Baker's international expertise to this region. Innovatia shares Dr. Baker's desire to create better and more efficient information management systems and we have no doubt it can be accomplished right here in New Brunswick."


The potential of bio-informatics and semantics as a new growth area affects many sectors in New Brunswick, including health research, education and industrial applications. Prior to his appointment as Innovatia Research Chair, Dr. Baker was head of the semantic technology group in the data mining department, Institute for Infocomm Research (Singapore), where his team developed knowledge navigation infrastructure based on semantic technologies.






## Leaving a Legacy

Tom to build the raft, right down to the pins, oars and oar locks. The result was a raft built from 28 white pine trees. It weighed 30 tons and was 25 feet wide by 34 feet long. After the trip was completed by a crew that included Tom, the raft was moored and displayed at the Canadian Museum of Civilization. The first square-timber crib to sail down the Ottawa River made the trip in 1806, and formed the basis for the Ottawa Valley lumber industry for the next century. The 2008 expedition has been turned into a book, One Last River Run, written by Ton Corbett and published by General Store Publishing House of Renfrew, Ont. Tom spent most of his working life in lumber camps in the Ottawa Valley, although he also taught for more than a decade at Algonquin College while his children were young.

# Founder of phys/ed program passes away at 81

he man who established and then fostered the physical education program at UNB has passed away.

Dr. John Meagher died in Fredericton Sept. 12, 2008, at the age of 81.

A native of Montreal, Dr. Meagher was a graduate of Loyola College (BA) and McGill University (BScPE) in Montreal as well as Pennsylvania State University (MS and DEd). From 1950 to 1952, he served as director of athletics at Macdonald College, Quebec. From 1952 to 1957, he was on the faculty at McGill.

In 1957, he was hired by the then president of UNB, Dr. Colin B. Mackay, as head of what was to be the first degree program in physical education in the Atlantic provinces.

From 1972 to 1976, he was executive assistant to UNB President John M. Anderson, and from 1980 to 1984. he served as chair of the management committee of UNB's Third Century Fund capital campaign. He took early retirement from UNB in 1988 to devote himself full-time to sport and recreation consulting in Atlantic Canada, Quebec and New England.

He was involved as a consultant on more than 80 major projects, including civic centres in Campbellton and Woodstock, N.B.; field houses at University College of Cape Breton, UNBSJ. UPEI and Memorial University; as well as dozens of arenas, including the Aitken University Centre.

During the UNB alumni reunion of 2007, Dr. Meagher was a central attraction during celebrations of the 50th anniversary of the physical education program at UNB.

He is survived by Kathy, his wife of 32 years; son Michael and wife Jackie and twin children Stephanie and Bobby of London, Ont., son David of Fredericton; daughter, Kathryn, of Fredericton; and other family members.

For the second straight year — and with the same hurler on the mound — the UNB Cougars baseball team captured a national championship with a 5-3 win over McGill in October.


Pitcher Peter Shaw, a third-year recreation student, tossed a no-hitter against Concordia in the 2007 Canadian Intercollegiate Baseball Association
