

## Ergonomics Minor: Policy and Procedure

The Minor in Ergonomics is designed for UNBF (full-time) students from inside or outside the Faculty of Kinesiology, who are interested in a coherent package of Ergonomics related courses.

### Policy:

- 1) Students outside the Faculty of Kinesiology must apply to and receive acceptance in the Ergonomics Minor **before** registering for any KIN courses in the Minor.
- 2) Students inside the Faculty of Kinesiology may apply for the Minor after completing 27ch in their degree program and must receive acceptance **before** registering for courses outside the Faculty and prior to taking KIN 4903, Directed Study in Ergonomics.
- 3) The Minor will consist of 24ch of approved KIN/RSS/ADM/ME courses.
- 4) Students enrolled in the Minor will be required to take 18ch of required courses and 6ch of elective courses chosen in consultation, and in advance, with the Faculty of Kinesiology.
- 5) A grade of "C" or better is required in each course used towards the Minor.
- 6) Enrolment is limited. Normally, a CGPA of 3.0 is required for acceptance.

### Procedure:

Complete the application form and return it to the Kinesiology Office, C201, Lady Beaverbrook Gymnasium or submit via email to [kin@unb.ca](mailto:kin@unb.ca).

For students outside the Faculty of Kinesiology, do NOT enroll in any KIN courses for the Minor until you have received acceptance from the Faculty.

For students inside the Faculty of Kinesiology, you must receive approval for the Minor, before taking required or elective courses outside the Faculty.
