#### **Fall 2022**

In the event the Faculty of Law is closed due to poor weather or building/campus closure between December 12, 2022 and December 16, 2022, the examinations scheduled for that day will be rescheduled for Saturday December 17, 2022.

In the event the Faculty of Law is closed due to poor weather or building/campus closure between December 19, 2022 and December 21, 2022, the examinations scheduled for that day will be rescheduled for Saturday January 14, 2023.

#### **Winter 2023**
