Report-Back on a Successful 2019 National Conference!

Ending Gender Based Violence: Harnessing Research and Action for Social Change was a successful conference by several measures. The organizing committee was delighted that researchers from a range of academic disciplinary perspectives as well as family violence service providers and government workers responded to our call for papers/presentations. The line-up of presentations reflected the kind of multidisciplinary collaboration and action-oriented research that the MMFC has fostered over the years. 63 people, including 2 postdoctoral fellows and 8 graduate students, took part in presentations of their work from across Canada as well as Washington, DC and London, England. Approximately 135 people attended the conference – many from the Maritime provinces but others from Saskatchewan, Manitoba and Ontario. Participants had the opportunity to learn about contemporary research, innovative service delivery and responses to recent policy and legislative changes in response to

gender based violence. International scholars conducting research on the use of parental alienation in the courts showed a shift in focus from the children's best interests to repairing parental relationships with children. Mothers' attempts to protect children from the harms of family violence are labeled as "implacably hostile" and fathers' "rights" are defended. Despite the persistence of high rates of domestic violence and domestic homicide, Myrna Dawson suggested that the general public does

not grasp that everyday terrorism against women is taking place in Canada because we are socialized to believe that gender based violence is normal. She urged us to focus our energies on systemic change. Paul Mazerolle's research on the police response to gender based violence in Australia showed that training on intimate partner violence alone does not lead to change. Training makes no difference in the practices of police without confidence. The question of how to enhance police confidence in responding to IPV remains to be answered. Feedback from participants included:

CASW Webinar: Assessing Danger in Abusive Relationships
An Overview of Intimate Partner Violence and Risk Factors for Lethality
November 14 at 2 pm AST, MMFC (678 Windsor Street, Fredericton)

This webinar is being offered by the MMFC to members of the <u>Canadian Association of Social Workers</u>. November is Family Violence Prevention Month in Canada. In that vein, this webinar will give an overview of domestic or intimate partner violence and the different forms in which it is manifested, particularly among male-female relationships. It will highlight the pervasiveness of a specific kind of domestic violence, namely the pattern of control and power over another person, and its impacts on its victims. Finally, it will examine risk factors that can be used to identify potentially lethal situations, in an effort to prevent domestic homicides, the ultimate impact of an abusive relationship. Safety planning will be emphasized as a method of working with clients in abusive relationships.

Dans cet esprit, ce webinaire donnera un aperçu de la violence familiale ou conjugale et des diverses formes sous lesquelles elle se manifeste, en particulier dans les relations hommes-femmes. Il mettra en lumière l'omniprésence d'un type spécifique de violence familiale, à savoir le modèle de contrôle et de pouvoir, de même que ses impacts sur ses victimes. Enfin, nous examinerons les facteurs de risque qui peuvent être utilisés pour identifier les situations potentiellement mortelles, dans le but de prévenir l'impact

ultime d'une relation violente, à savoir l'homicide. L'accent sera mis sur la planification de la sécurité avec les clients dans les relations de violence.

It's Your Business to Care: The Impact of Intimate Partner Violence on the Workplace December 2 & December 3, 2019

Presented by members of the MMFC's Domestic & Intimate Partner Violence (DIPV) in the Workplace Committee, this workshop helps employers become aware of risk factors, signs and appropriate responses when taking action to address DIPV and its impacts on the workplace.
