Overview

The Canadian Chronic Disease Surveillance System (CCDSS) was developed by the Public Health Agency of Canada (PHAC) in partnership with provincial health ministries – including the New Brunswick Department of Health – as well as non-government organizations, clinicians, and researchers. The CCDSS uses administrative databases to provide a passive surveillance of chronic diseases. The data is processed at the provincial level and submitted to PHAC as aggregate data for national comparisons and further study. The CCDSS Dementia DH01c13 database contains individual-level surveillance data for dementia in New Brunswick.
