Q2_Concern_growth_development	Does the parent/guardian have concerns about the child's growth or development
Q5_Child_seen_dentist	Has this child already seen a dentist?
Q6_0_Risk_dental_carries	Child has risk of dental caries?
Q6_1_Risk_parent_has_untreated_cavities	Parent currently has untreated cavities, broken teeth or toothaches.
Q6_2_Risk_Child_has_special_health_needs	Child has special development or health needs.
Q6_3_Risk_Child_has_spots_on_teeth	Child has chalky white or brown spots on their teeth?
Q6_4_Risk_Between_meals_childs_drinks_juice	Between meals child drinks juice or milk from a bottle or sippy cup.

Q6_5_Risk_Child_sleeps_with_a_bottle	Child sleeps with a bottle or sippy cup containing milk or juice.
Q6_6_Risk_Child_snacks_often	Child snacks often between meals on sweet or sticky foods.
Q6_7_Risk_Parent_brushes_child_teeth	Parent brushes child's teeth less than a twice a day.
Q6_8_Risk_Family_does_not_have_fluoridated_water	Family lives in an area that does not have fluoridated water.
Q9_Accident_incident	Has this child already been to a health care provider or Emergency Room because of an accident/incident?
Q10_0_Risk_injury_incident	Child has risk of injury/incident?
Q10_1_Risk_no_smoke_alarm	Family does not have a working smoke alarm on every level of their home.
Q_10_2_Risk_car_seat_not_appropriate_for_child	Child uses a car safety seat that does not suit his/her age or size.
Q_10_3_Risk_medication_not_locked_in_cupboard	Family does not keep medication, cleaning products, and alcohol out of reach, or in a locked cupboard.
Q_10_4_Risk_windows_can_not_be_locked	Family can not lock their windows.
Q_10_5_Risk_no_gate_on_stairs	Family does not a gate for the top and bottom of the stairs
Q_10_6_Risk_swimming_pool	Family has a swimming pool that is not fenced on all four (4) sides and not locked.
Q_10_7_Risk_child_does_not_wear_helmet	Child does not wear a helmet when riding on toys (e.g. bicycle)
Q_13_Vision	Is the child already seeing a health care provider because of his/her vision?
Q14_0_Risk_vision_problem	Child has risk of vision problems?
Q14_1_Risk_child_was_born_before_37_weeks	Child was born earlier than 37 weeks gestation.
Q14_2_Risk_development_delay	A doctor said that the child has a development delay.
Q14_3_Risk_child_has_a_medical_syndrome	Child has a medical syndrome (e.g Down Syndrome) or a chronic condition (e.g. arthritis, diabetes).

Q14_4_Risk_family_history_of_strabismus	Family member or child has Strabismus or Amblyopia.
Q14_5_Risk_family_wore_glasses	Family member wore glasses from the age of ten (10), or younger.
Q14_6_Risk_poor_eyesight	Family member has poor eyesight even when wearing glasses, at any age.
Q14_7_Hearing	Is the child already seeing a health care provider because of his/her hearing?
Q_18_0_Risk_hearing_problems	Child has risk of hearing problems?
Q_18_1_Risk_child_has_speech_problem	Parent thinks the child has a speech problem.
Q_18_2_Risk_family_member_had_a_hearing_loss	A family member had permanent hearing loss before fifteen (15) years of age.
