Proposed course number, title and credit hours: POLS 2311 The History and Politics of Latin America, (cross-listed: HIST 2511), 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes):

Provides an overview of Latin American history and politics from colonization to the 20th century.

Prerequisite: POLS 1301

Rationale and other information to support this submission: To add a lower-level Politics option for students. History course cross listed with Politics because the academic content supports and complements courses in Latin American Political

Science. Cross listing also supports the growing number of double majors who declare for both History and Politics. Taught on Registrar's Warrant Fall 2015 and Fall 2016.

Proposed course number, title and credit hours: POLS 4214 Prime Ministers and Cabinets, 3 CH [W]

Course description (proposed Calendar copy, including calendar codes): An examination of Canadian prime ministers and federal cabinets with a focus on the centralization of power in the prime minister's office and historical developments in these Canadian political institutions.

Prerequisites: POLS 1201 and at least one of POLS 3101, POLS 3205, POLS 3231, POLS 3241, POLS 3252, POLS 3261 or POLS 3278

Rationale and other information to support this submission: To add an upper-level Politics option. To be taught on Registrar's Warrant Winter 2017.

Proposed course number, title and credit hours: HIST 1101, European Experience, 3 CH.

Course description (proposed Calendar copy, including calendar codes): This course will introduce students to the history of continental Europe and the goals and methods of historical studies. A flexible set of lectures, discussion periods and assignments will explore social, cultural, economic and political issues illustrative of a

wide range of European experiences, as well as the central role of this continent in the shaping of our contemporary world.

Rationale and other information to support this submission: To add an option for students at the 1000 level. Taught on Registrar's Warrant Fall 2016.

Proposed course number, title and credit hours: HIST 2511 The History and Politics of Latin America, (cross-listed: POLS 2311), 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes):

Provides an overview of Latin American history and politics from colonization to the 20th century.

Rationale and other information to support this submission: To add a lower-level History option for students. History course cross listed with Politics because the academic content supports and complements courses in Latin American Political Science. Cross listing also supports the growing number of double majors who declare for both History and Politics. Taught on Registrar's Warrant Fall 2015 and Fall 2016.

Proposed course number, title and credit hours: HIST 2514, First Nations in North America to the War of 1812, 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): This course will focus on the history of Indigenous Peoples in the context of early European exploration, the fur trade, missionization, and colonial policies.

Rationale and other information to support this submission: UNB has expressed support for what Canadian university administrators are calling the indigenization of the academy. This course will offer all students, not just history majors, the opportunity to learn about the history of First Nations.

Proposed course number, title and credit hours: HIST 2515, First Nations in North America since 1800, 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): A history of First Nations focusing on economic, political, social, and cultural developments in the post-colonial context.

Rationale and other information to support this submission: UNB has expressed support for what Canadian university administrators are calling the indigenization of the academy. This course will offer all students, not just history majors, the opportunity to learn about the history of indigenous people.

Proposed course number, title and credit hours: HIST 3151 Britain in the Age of the World Wars, 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): Examines the impact of the First and Second World wars on British history, both on the battlefield and on the home front, with an emphasis on how total war transformed the economy, politics, religion and society.

Rationale and other information to support this submission: To add an upper-level History option. Taught on Registrar's Warrant Fall 2015.

Proposed course number, title and credit hours: HIST 3591 Latin American Revolutions, (cross-listed: POLS 3344), 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): Examines the origins and course of Latin American revolutions, especially the Mexican and Cuban revolutions.

Rationale and other information to support this submission: To add an upper-level History option for students. History course cross listed with Politics because the academic content supports and complements courses in Latin American Political Science. Cross listing also supports the growing number of double majors who declare for both History and Politics. Taught on Registrar's Warrant Winter 2016 and to be taught Winter 2017.

Proposed course number, title and credit hours: HIST 4221 Elizabeth I, 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): This course focuses on the major themes in the life of Queen Elizabeth I, one of the most famous and mythologized women in history. We will attempt to sort through the legacy of her father, Henry VIII, and ascertain the reasons for the fall of her mother, Anne Boleyn. We explore her turbulent relationship with her sister, Mary, which resulted in Elizabeth's stay in the Tower of London as a suspected traitor. From there we will examine some of the predominant themes in her reign: finding and preserving a religious settlement for the Church of England, her gender as both a "plus and a minus", the Elizabethan court, her relationship with Mary, Queen of Scots, her fashioning of her image and how her reputation has been perceived subsequently.

Rationale and other information to support this submission: To add an upper-level History option. To be taught on Registrar's Warrant Winter 2017.

Proposed course number, title and credit hours: HIST 4371 Murder in Canada: A Social and Legal History, 3 CH. [W]

Course description (proposed Calendar copy, including calendar codes): Examines the legal and expert response to homicide, patterns of homicide and the issue of capital punishment, from the colonial to the modern era.

Rationale and other information to support this submission: To add an upper-level History option. To be taught on Registrar's Warrant Winter 2017.
